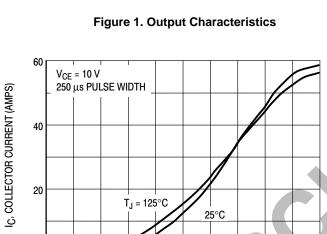


Figure 3. Transfer Characteristics

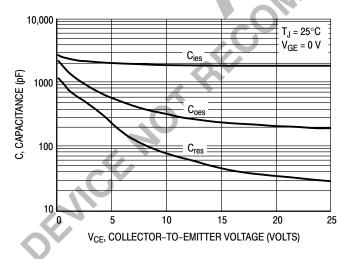


Figure 5. Capacitance Variation

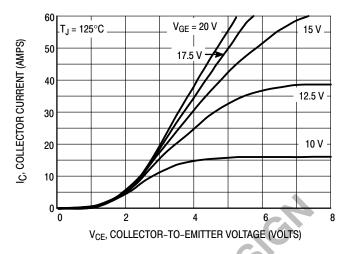


Figure 2. Output Characteristics

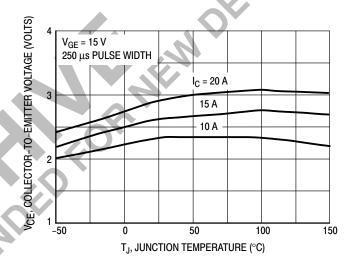


Figure 4. Collector-to-Emitter Saturation Voltage versus Junction Temperature

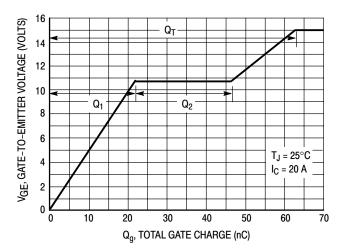


Figure 6. Gate-to-Emitter Voltage versus
Total Charge

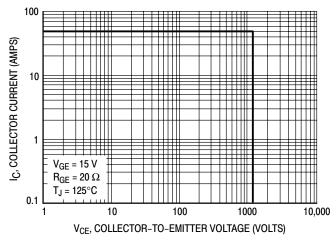


Figure 7. Reverse Biased Safe Operating Area

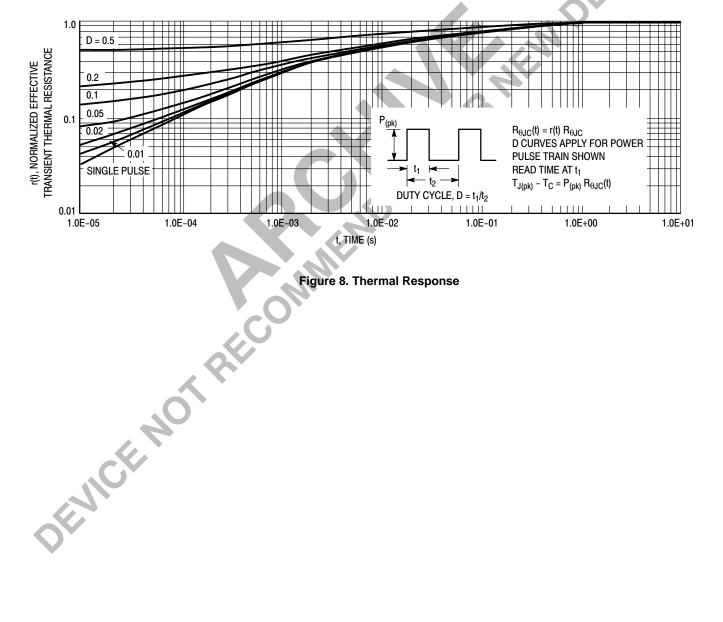
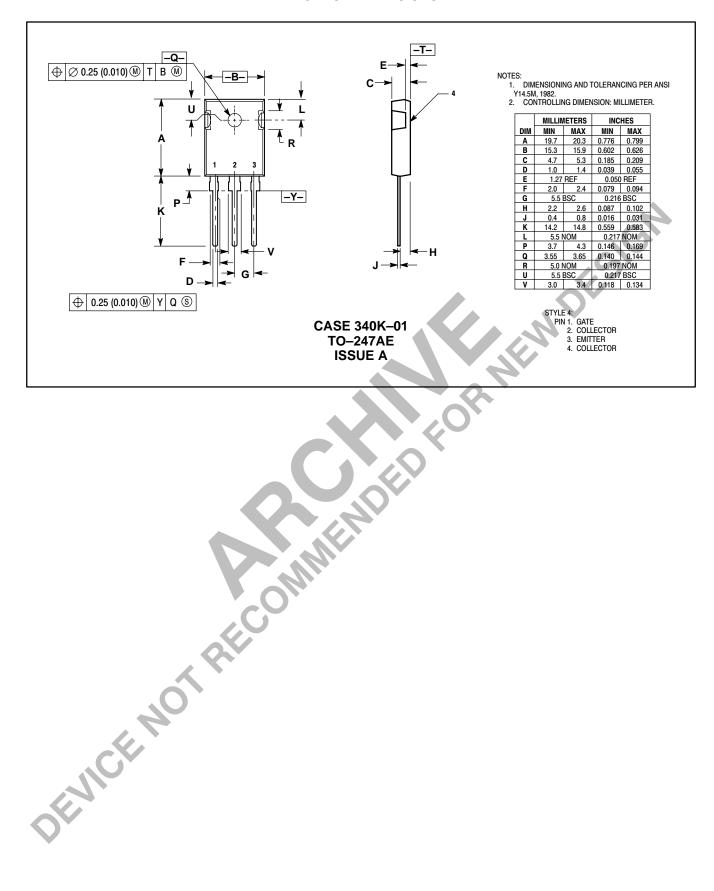


Figure 8. Thermal Response
