







Fig 5. Typical Capacitance vs. Drain-to-Source Voltage

Fig 6. Typical Gate Charge vs. Gate-to-Source Voltage




Fig 7. Typical Source-Drain Diode Forward Voltage




Fig 8. Maximum Safe Operating Area




Fig 9. Maximum Drain Current vs. Case Temperature




Fig 10. Drain-to-Source Breakdown Voltage




Fig 11. Typical C_{OSS} Stored Energy




Fig 12. Maximum Avalanche Energy vs. Drain Current




Fig 13. Maximum Effective Transient Thermal Impedance, Junction-to-Case





Fig 14. Typical Avalanche Current vs. Pulsewidth



Notes on Repetitive Avalanche Curves , Figures 14, 15:

1. Avalanche failures assumption:

Fig 15. Maximum Avalanche Energy vs. Temperature




Fig 16. Threshold Voltage vs. Temperature




Fig. 17 - Typical Recovery Current vs. di_F/dt




Fig. 18 - Typical Recovery Current vs. di_F/dt




Fig. 19 - Typical Stored Charge vs. di_F/dt






Fig. 20 - Typical Stored Charge vs. di_F/dt

Fig 20. Peak Diode Recovery dv/dt Test Circuit for N-Channel HEXFET® Power MOSFETs




Fig 21a. Unclamped Inductive Test Circuit




Fig 21b. Unclamped Inductive Waveforms




Fig 22a. Switching Time Test Circuit




Fig 22b. Switching Time Waveforms




Fig 23a. Gate Charge Test Circuit





Fig 23b. Gate Charge Waveform
