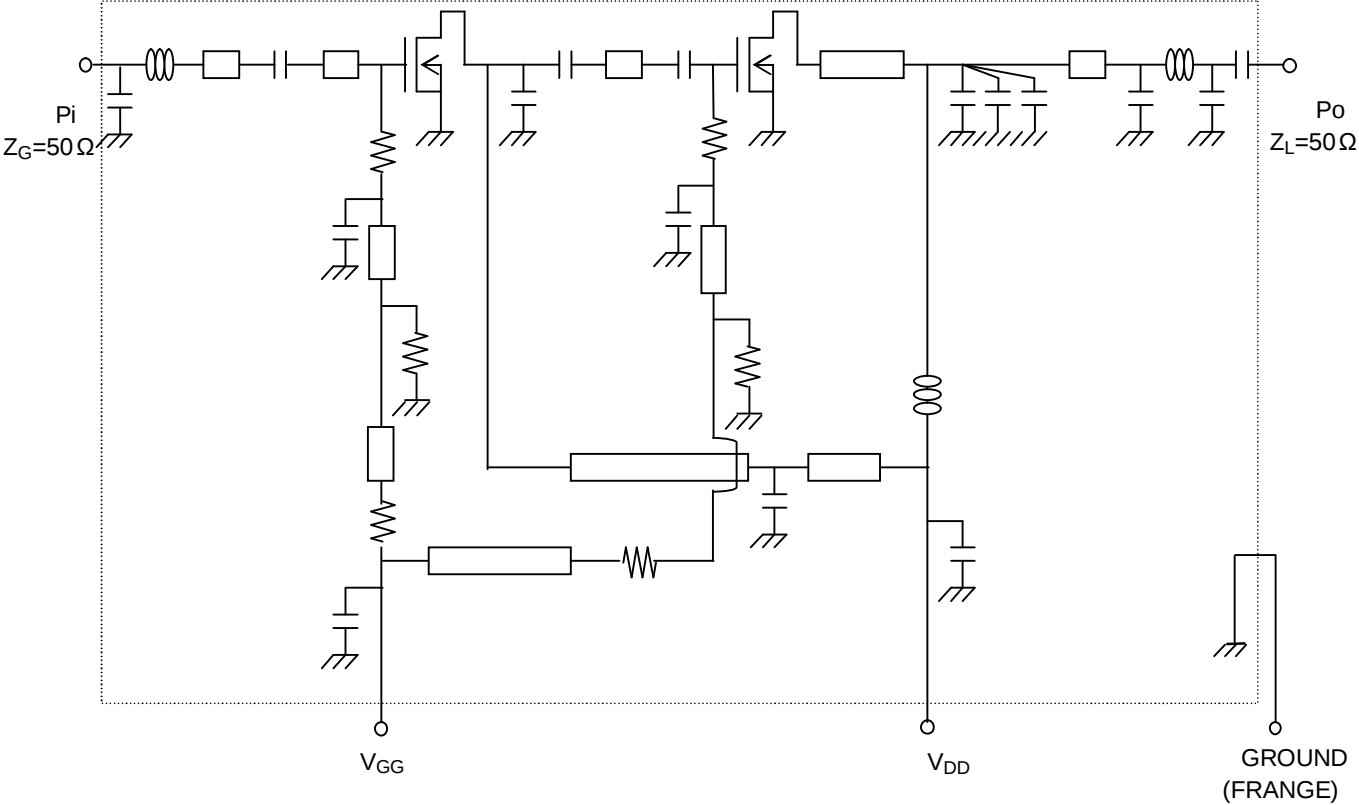

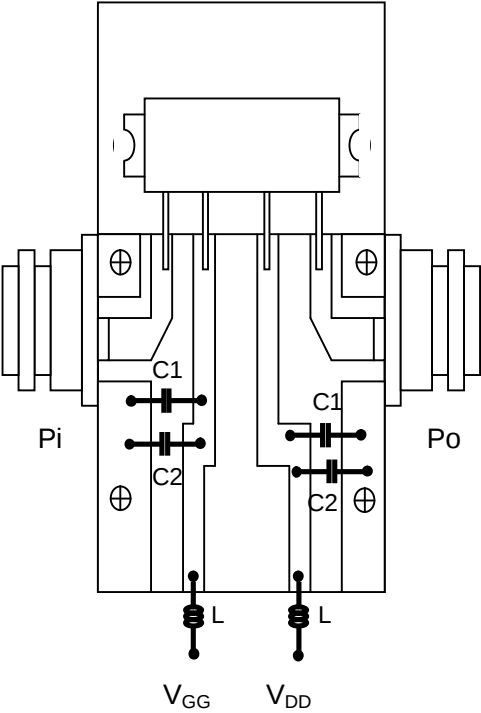

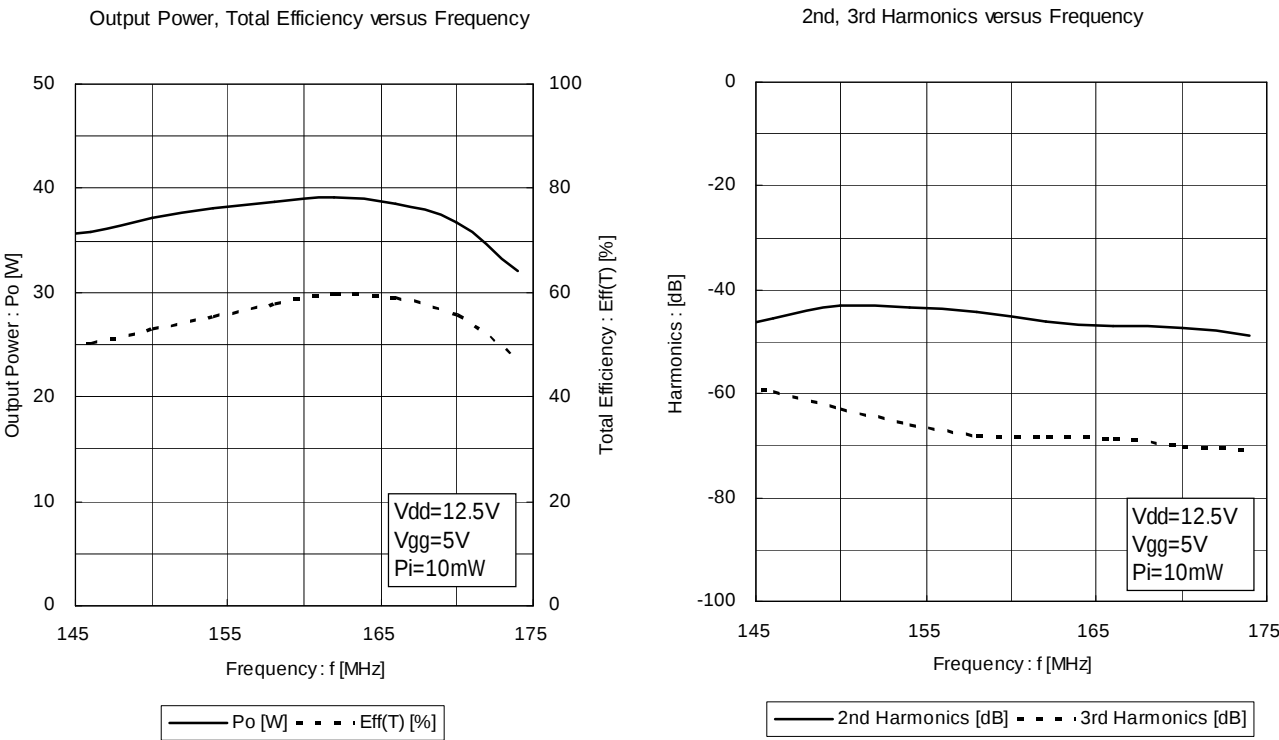

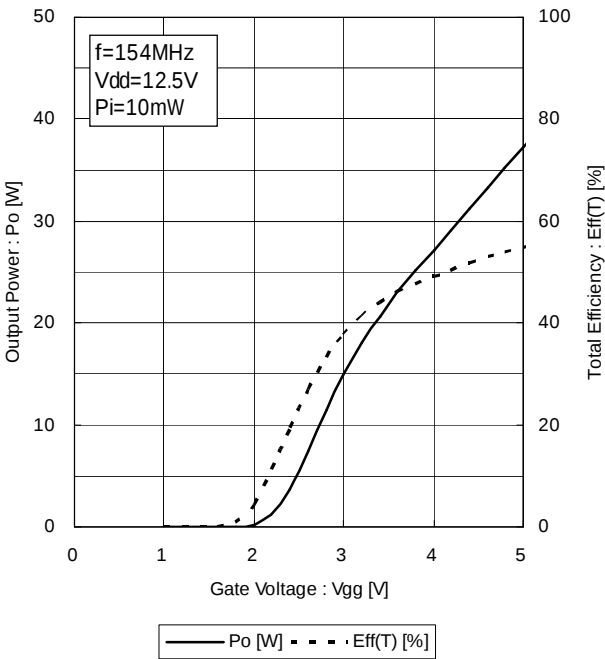


TYPICAL PERFORMANCE CURVE

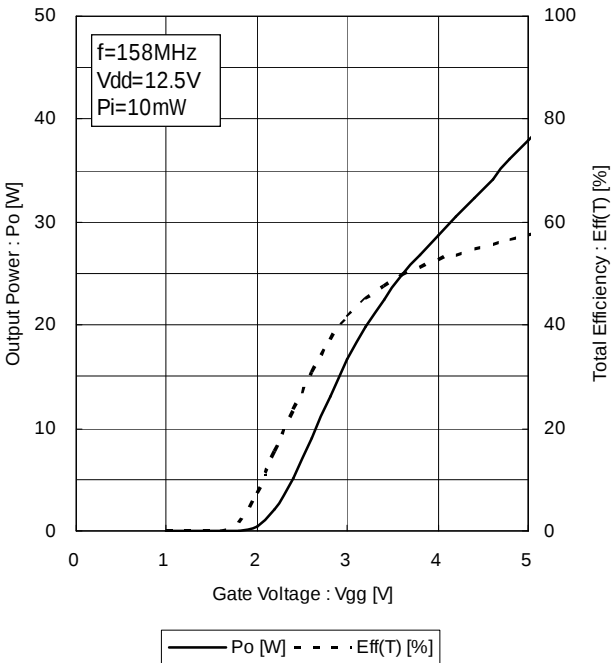

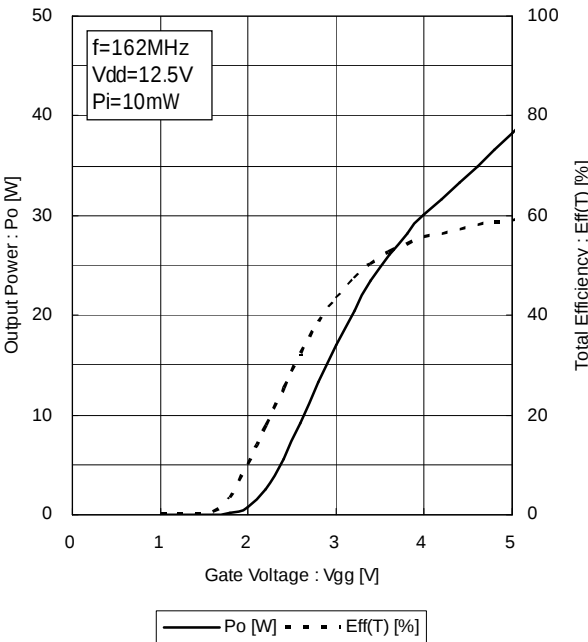
Output Power, Total Efficiency versus Gate Voltage
