





(a) Test circuit







## Equivalent Circuit (top view)









## Notice on Usage






$V_{th}$  can be expressed as the voltage between gate and source when the low operating current value is  $I_D = -1 \text{ mA}$  for this product. For normal switching operation,  $V_{GS}(\text{on})$  requires a higher voltage than  $V_{th}$  and  $V_{GS}(\text{off})$  requires a lower voltage than  $V_{th}$ .

(The relationship can be established as follows:  $V_{GS}(\text{off}) < V_{th} < V_{GS}(\text{on})$ .)  
 Take this into consideration when using the device.
