


### **RELATIVE INTENSITY vs. WAVELENGTH**





### **SPATIAL DISTRIBUTION**












### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**




  2. The maximum number of reflow soldering passes is 2 times.

## TAPE SPECIFICATIONS (units: mm)




## **REEL DIMENSION** (units: mm)
