

Description

The ZXTR2008K monolithically integrates a transistor, Zener diode and resistor to function as a high voltage linear regulator. The device regulates with an 8.2V nominal output at 15mA. It is designed for use in high voltage applications where standard linear regulators cannot be used. This function is fully integrated into a TO252 package, minimizing PCB area and reducing number of components when compared with a multi-chip discrete solution.

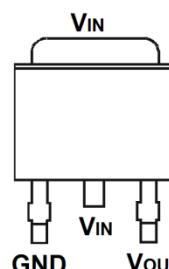

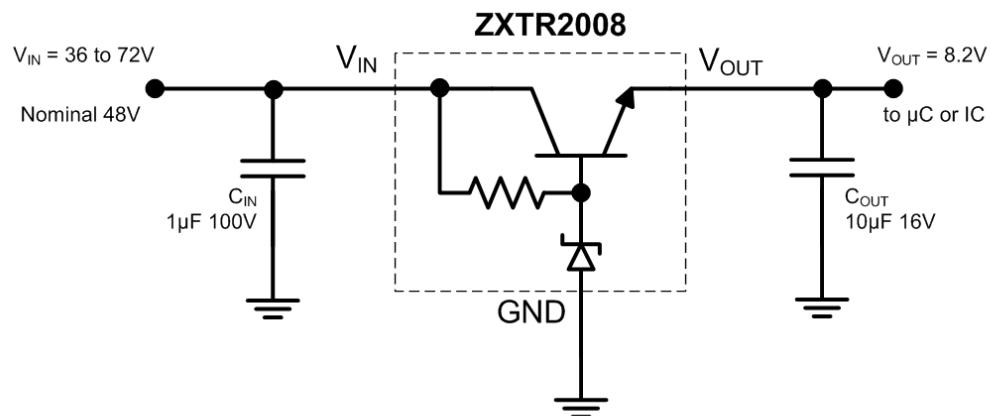

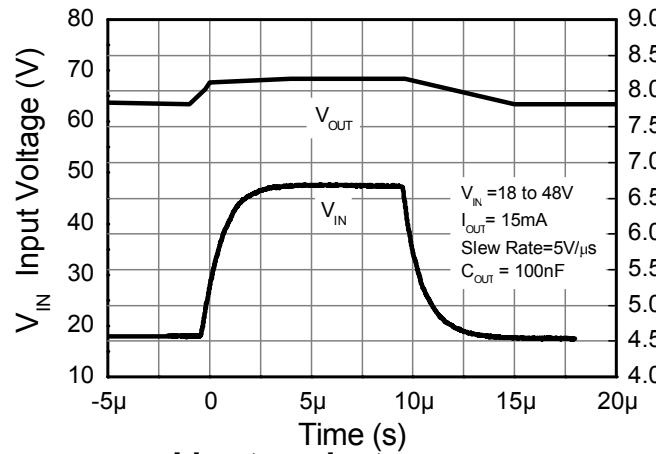
Typical Application Circuit


Example of an 8.2V regulated supply from a nominal 48V for powering a Controller IC.

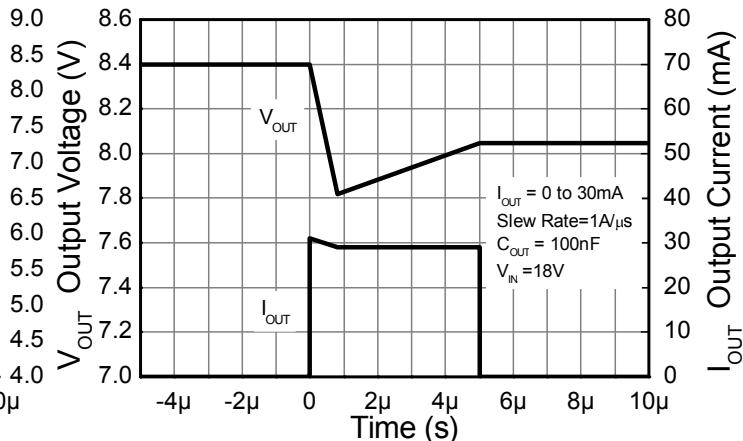
Pin Functions

Pin Name	Pin Function	Notes
V_{IN}	Input Supply	To maintain output regulation the input voltage can vary from 12V to 100V with respect to the GND pin. It is recommended to connect a 1 μF capacitor to GND.
GND	Power Ground	This pin should be tied to the system ground.
V_{OUT}	Voltage Output	Outputs a regulated 8.2V. It is recommended to connect a 10 μF capacitor to GND. Minimum of 10 μA must be drawn from V_{OUT} to maintain regulation. The pin can be pulled high to a maximum of 14.5V with respect to ground.

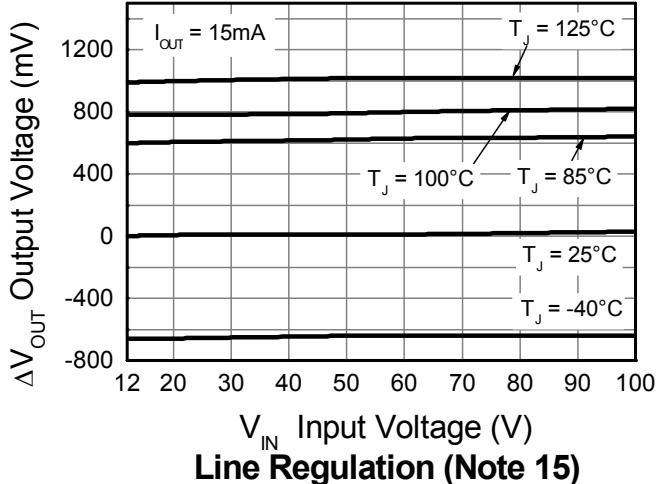

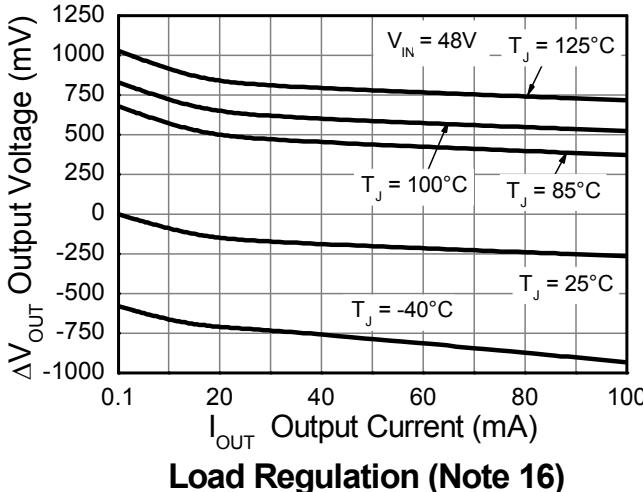
Line transient response



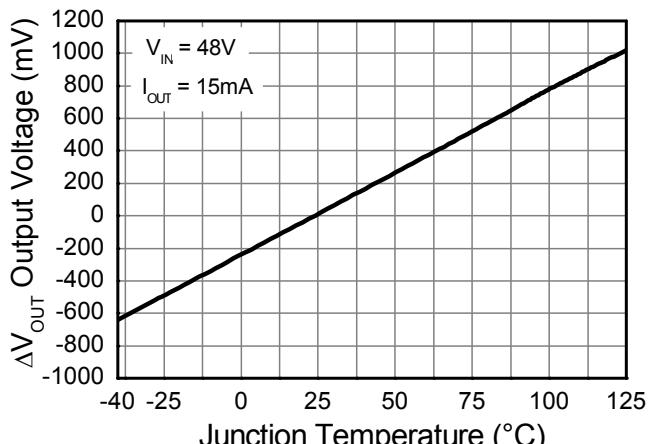
Load transient response



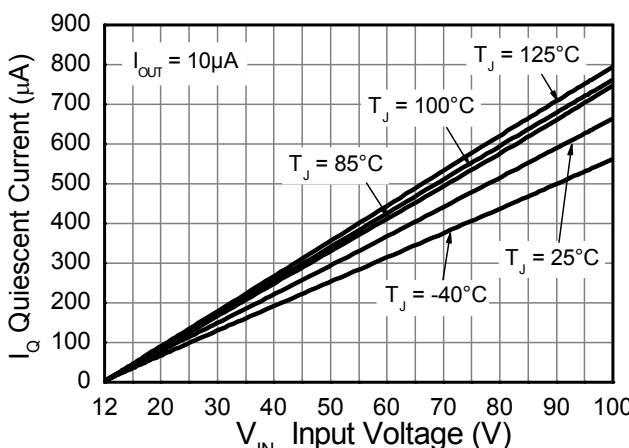
Line Regulation (Note 15)

Temperature Coefficient (Note 17)



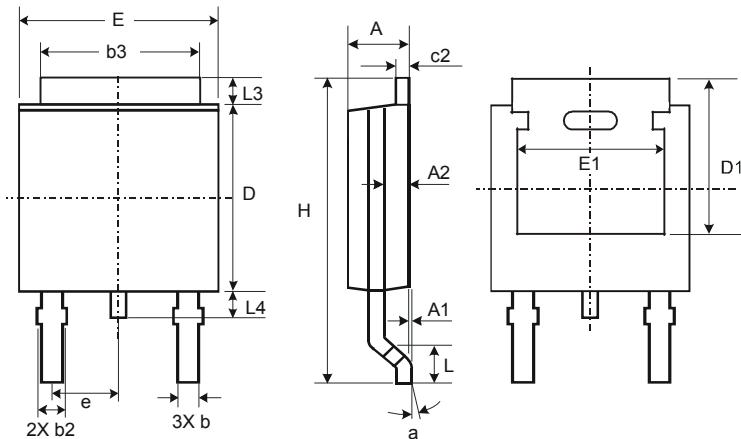

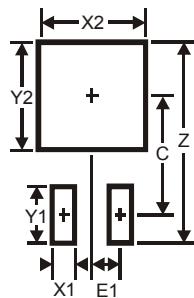
