4 FIRST-AID MEASURES

GENERAL INFORMATION

Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

INHALATION

6 ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS

Use protective gloves, goggles and suitable protective clothing. Do not smoke, use naked flames or other sources of ignition. Provide adequate ventilation.

SPILL CLEAN UP METHODS

Wear necessary protective equipment. If leakage cannot be stopped, evacuate area. Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate. Dam and absorb spillages with sand, earth or other non-combustible material. Collect in containers and seal securely.

ENGINEERING MEASURES
