

TLV117125EVM-097 Evaluation Module

This User's Guide describes the operational use of the TLV117125EVM-097 Evaluation Module (EVM) as a reference design for engineering demonstration and evaluation of the TLV117125, low dropout linear regulator (LDO). Included in this user's guide are setup instructions, a schematic diagram, layout and thermal guidelines, a bill of materials, and test results.

1 Introduction

The Texas Instruments TLV117125EVM-097 EVM (referred to as the EVM for the remainder of this document) helps design engineers evaluate the operation and performance of the TLV117125 family of linear regulators for possible use in their own circuit application. This EVM configuration contains a single linear regulator with internal thermal- and current-limit shutdown circuitry in a small SOT-223 package. The regulator is capable of delivering up to 1 A to the load depending on the input-output power dissipation across the part which can be minimized because of the very low dropout voltage. The input and output capacitors for the TLV117125 need to be at least 1 μ F (effective) for stability. An additional output-capacitor pad is added to the EVM if a larger capacitance is desired.

2 Setup

This section describes the connectors on the EVM and how to properly connect, setup, and use the EVM.

2.1 Input/Output Connectors

2.1.1 J1 – V_{IN}

Input power-supply voltage connector. The positive-input lead and ground-return lead from the input power supply should be twisted and kept as short as possible to minimize EMI transmission. Additional bulk capacitance should be added between J1 and J2 if the supply leads are greater than six inches. For example, an additional 47- μ F electrolytic capacitor connected from J1 to GND can eliminate unwanted ringing on the input, due to long wires.

2.1.2 J2 – GND

Return connector for the input power supply.

2.1.3 J3 – V_{OUT}

Regulated output voltage connector.

2.1.4 J4 – GND

Return connector for the output.

2.2 Soldering Guidelines

Solder rework modifying the EVM for the purpose of repair or any other application reasons must be performed using a hot-air system to avoid damaging the integrated circuit (IC).

2.3 Equipment Setup

- Set the power-supply voltage between 3.5 V and 5.5 V. Turn the power supply off. Connect the positive voltage lead from the power supply to J1 (V_{IN}). Connect the ground lead from the power supply to J2 (GND).
- Connect a 0- to 1-A load between J3 (V_{OUT}) and J4 (GND).

3 Operation

- Turn on the power supply.
- Vary the respective loads and V_{IN} voltages as necessary for test purposes.

4 Test Results

This section provides typical-performance waveforms for the EVM printed-circuit board. Actual performance data can be affected by measurement techniques and environmental variables; therefore, these curves are presented for reference and may differ from actual results.

4.1 Turn-on Waveform

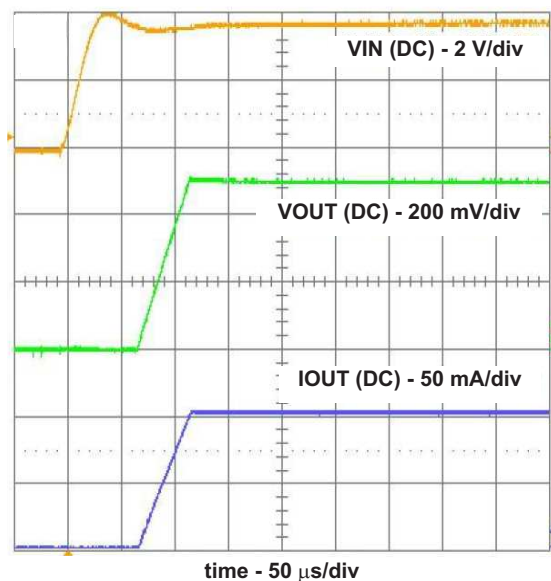


Figure 1. Turn-on Waveforms of the TLV117125EVM-097

Figure 1 shows the turn-on characteristic where 4 V is applied to V_{IN} . The output drives a full load to 2.5 Ω .

4.2 Load Transient

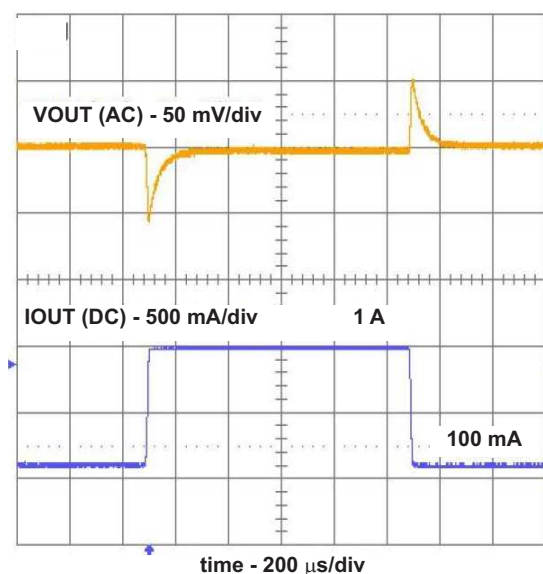


Figure 2. Load Step and Transient Response of the TLV117125EVM-097

Figure 2 shows the load transient response (V_{OUT}) for a load step transient from 100 mA to 1 A (Output current) where 4 V is applied to V_{IN} .

4.3 PSRR

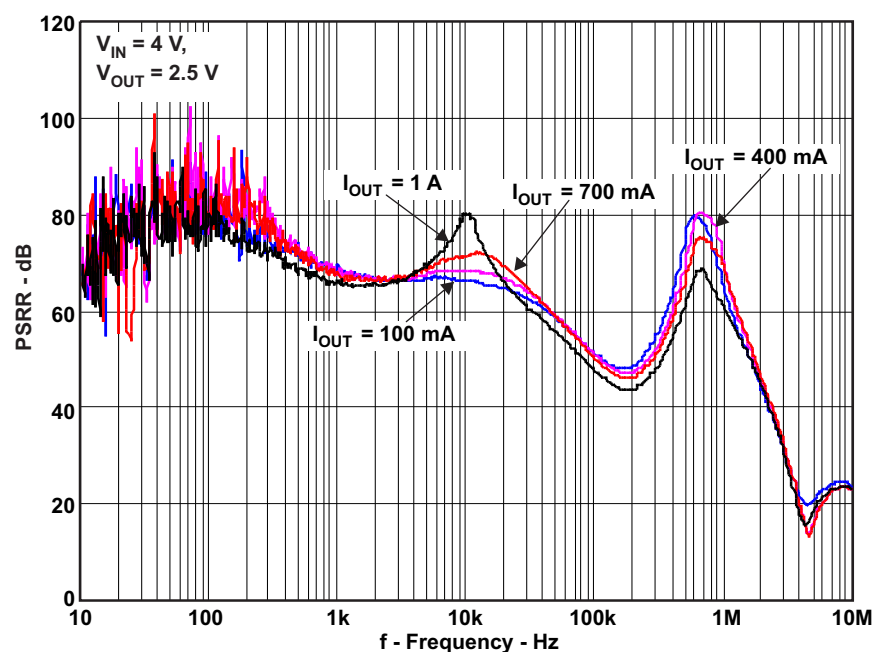


Figure 3. PSRR of the TLV117125EVM-097

Figure 3 shows the PSRR performance for various loading conditions of the TLV117125EVM-097.

5 Thermal Guidelines and Layout Recommendations

Thermal management is a key component in the design of any power converter and is especially important when the power dissipation in the LDO is high. Use the following formula to approximate the maximum power dissipation for the particular ambient temperature:

$$T_J = T_A + P_D \times \theta_{JA}$$

where T_J is the junction temperature, T_A is the ambient temperature, P_D is the power dissipation in the device (Watts), and θ_{JA} is the thermal resistance from junction to ambient. All temperatures are in degrees Celsius. The maximum silicon junction temperature, T_J , must not be allowed to exceed 150°C. The layout design must be copper trace and plane areas smartly, as thermal sinks, preventing T_J from exceeding the absolute maximum rating under all temperature conditions and voltage conditions across the part.

The layout should carefully consider the thermal design of the PCB for optimal performance over temperature. [Figure 5](#) shows the PCB top GND plane has twenty-two 6-mil thermal via connections to the bottom side copper GND plane to dissipate heat, for this EVM. The PCB is a two-layer board with 2 oz. copper on the top and bottom layers. The DCY package drawing can be found at the Texas Instruments website in the product folder for the TLV117125 LDO.

[Table 1](#) repeats information from the Dissipation Ratings Table of the TLV117125-series datasheet. The High-K value is determined using a standard JEDEC High-K (2s2p) board having dimensions of 3-inch x 3-inch with 1-oz internal power and ground planes and 2-oz copper traces on the top and bottom of the board.

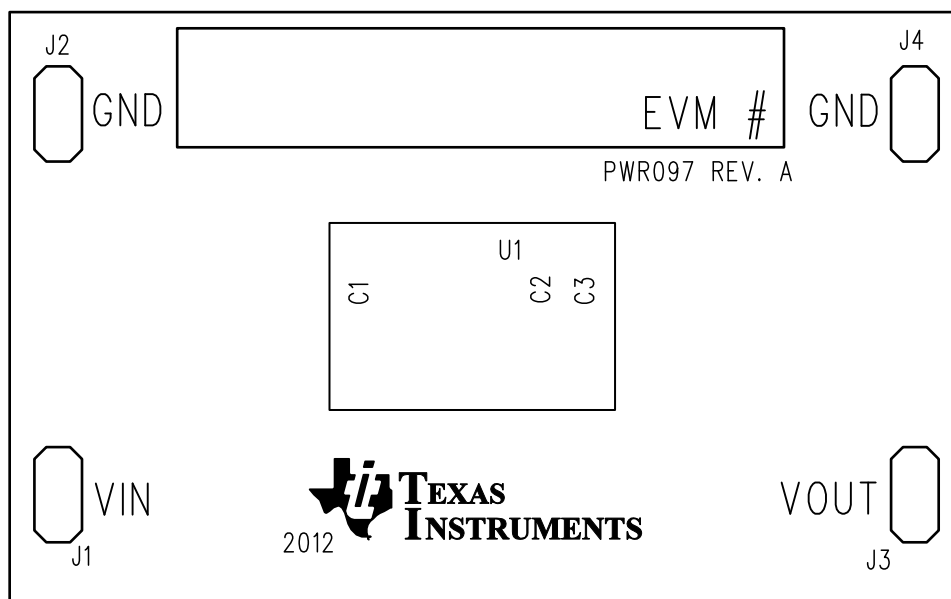


Figure 4. Assembly Layer

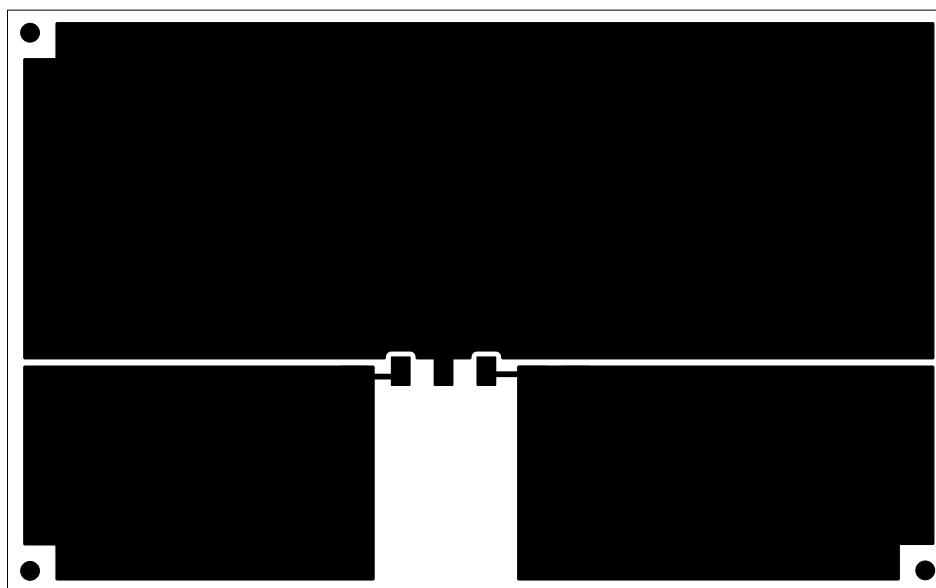


Figure 5. Top Layer Routing

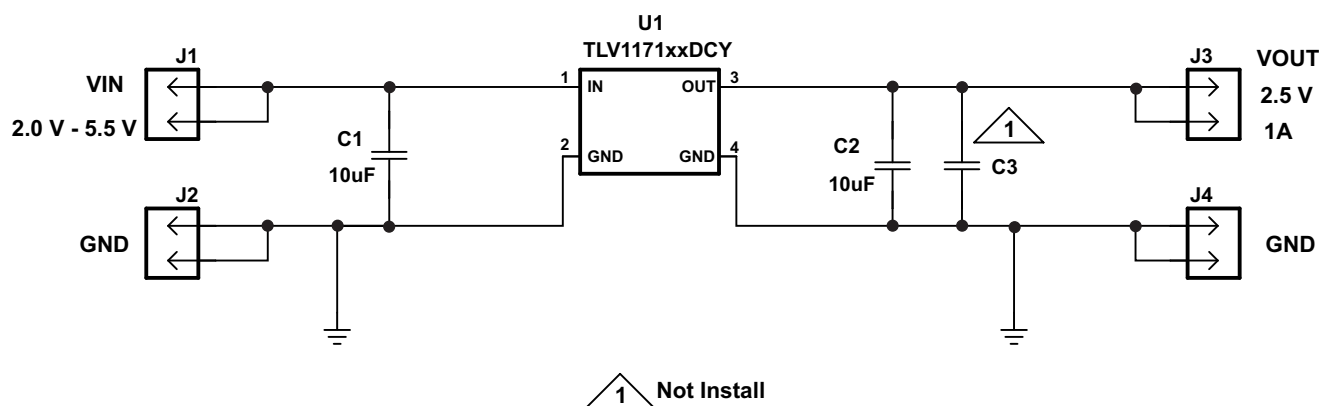


Figure 7. TLV117125EVM-097 Schematic
