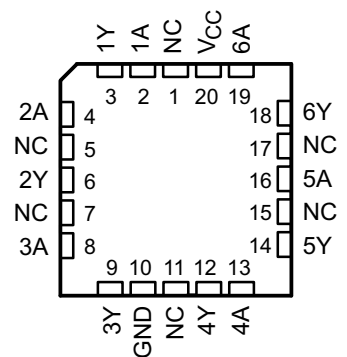

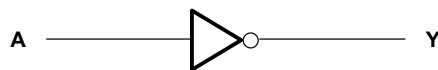
DESCRIPTION

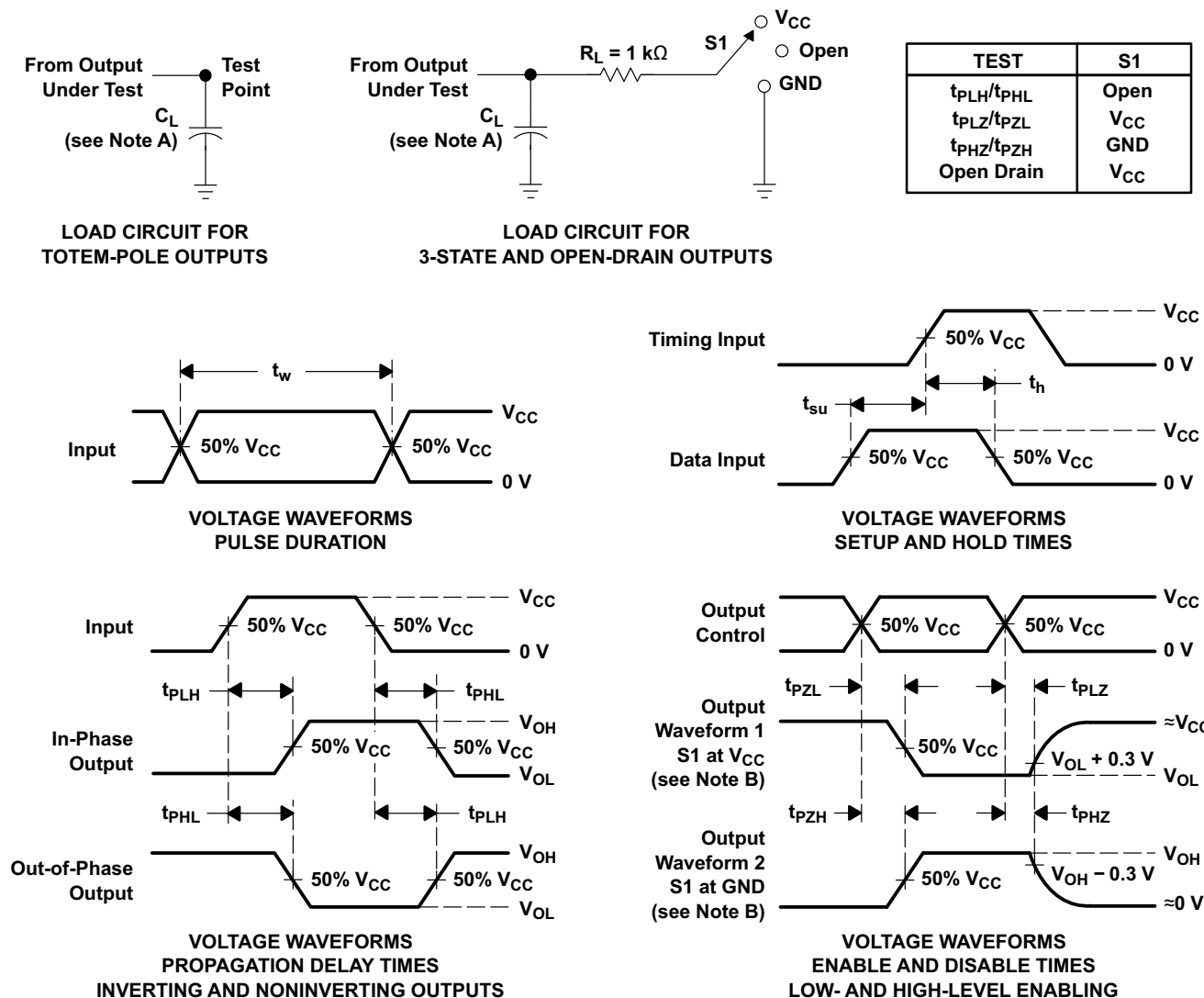

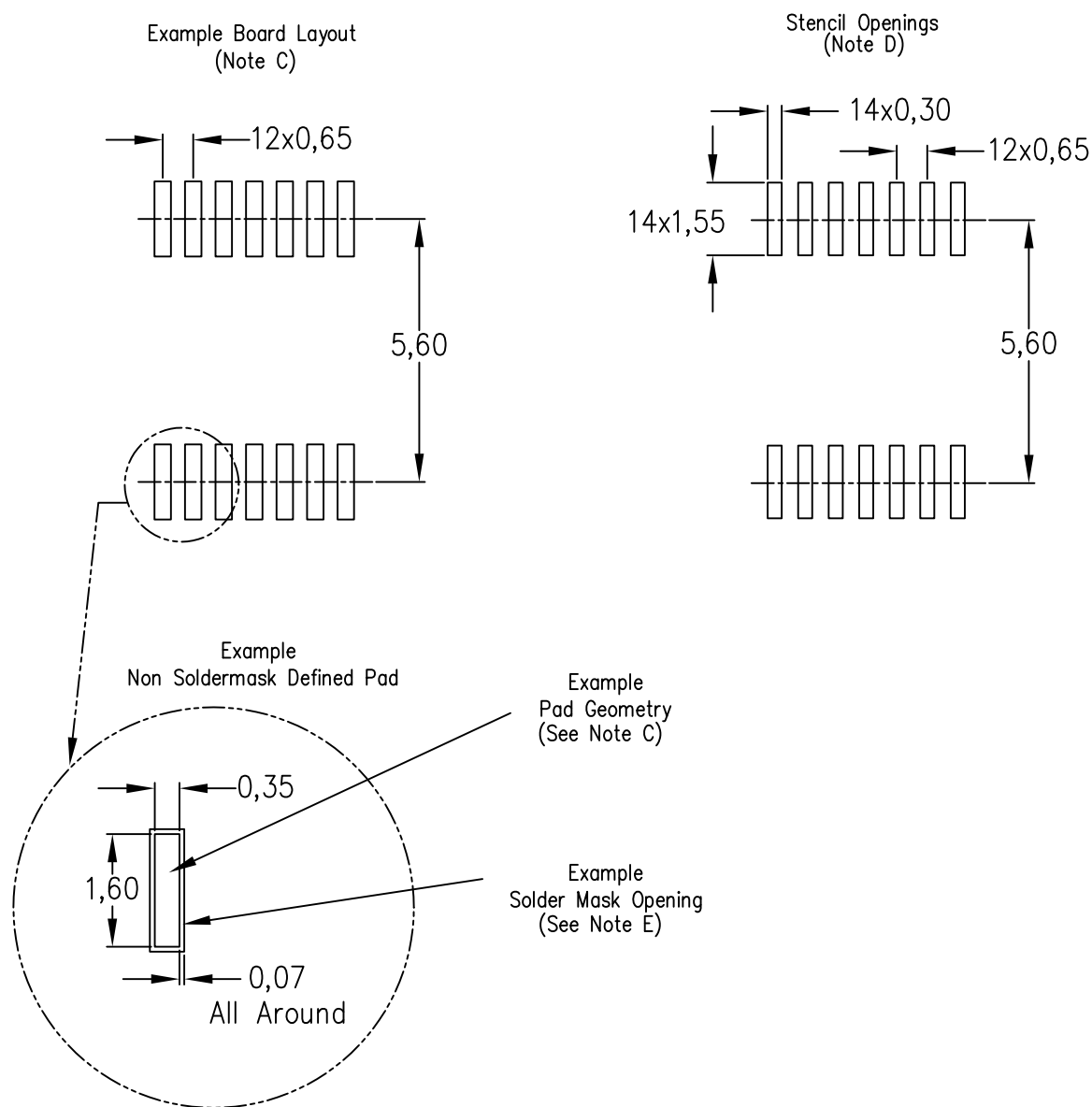

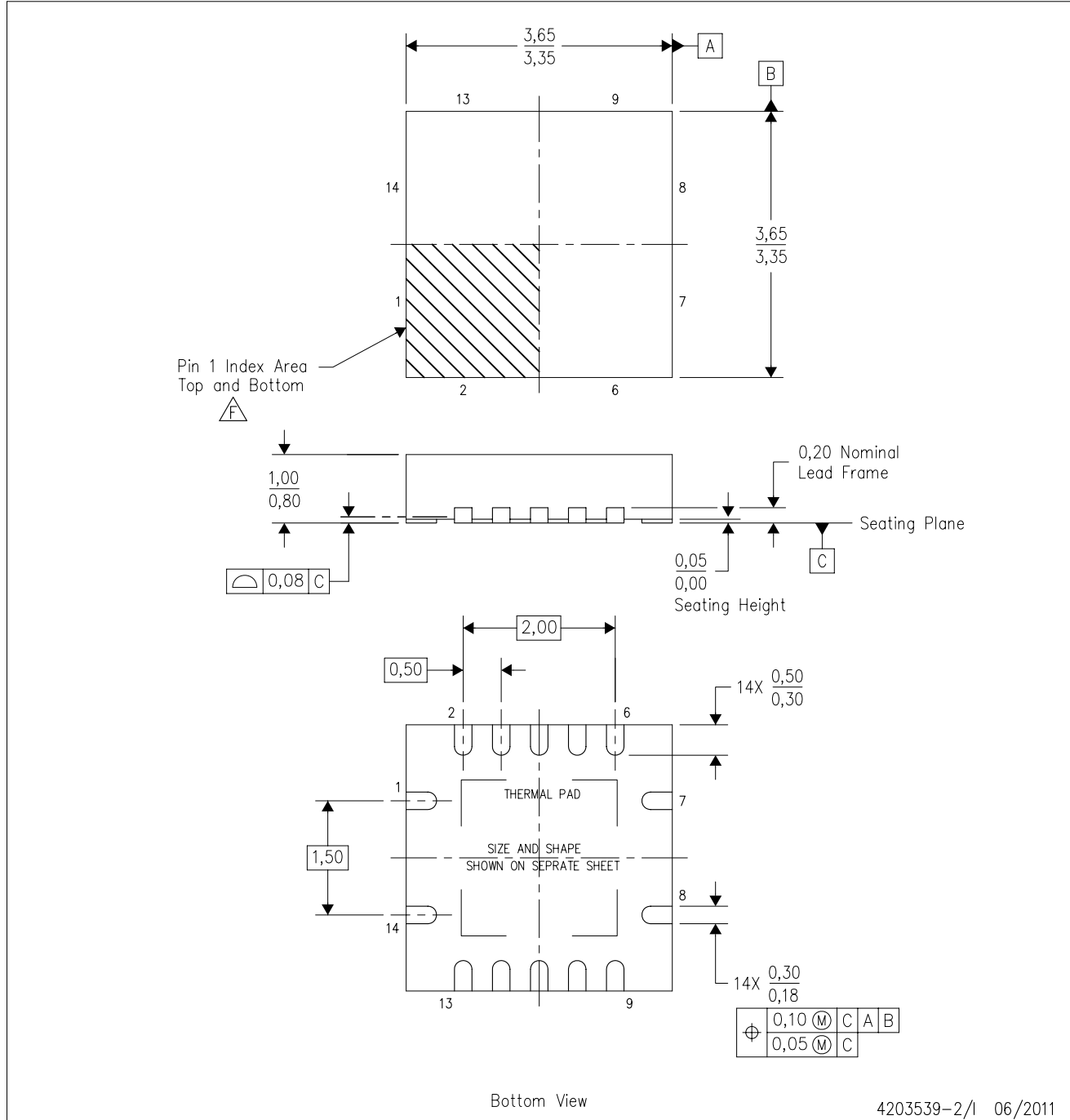
