


$I_C$  - Collector Current (Amps)

**$V_{CE(sat)}$  v  $I_C$**




$I_C$  - Collector Current (Amps)

**$V_{BE(sat)}$  v  $I_C$**




$I_C$  - Collector Current (Amps)


