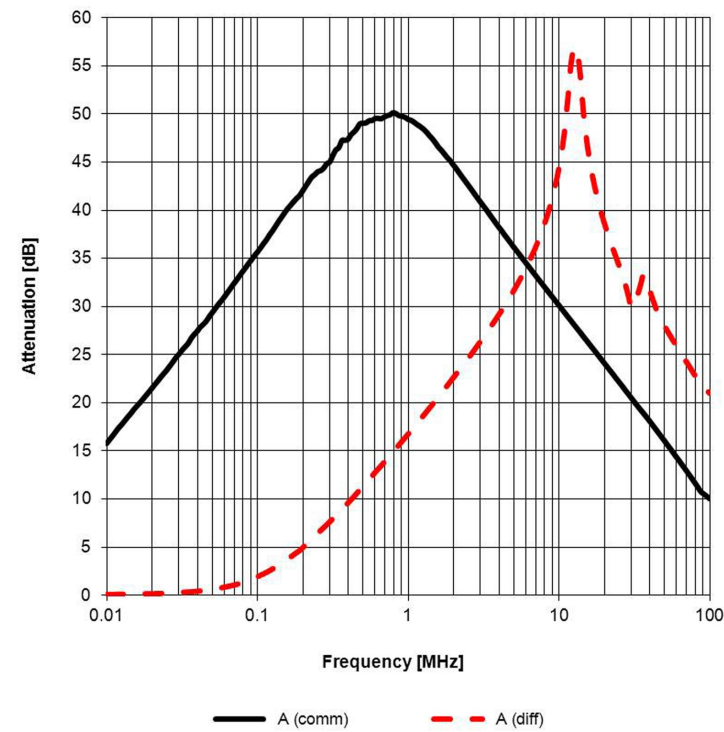

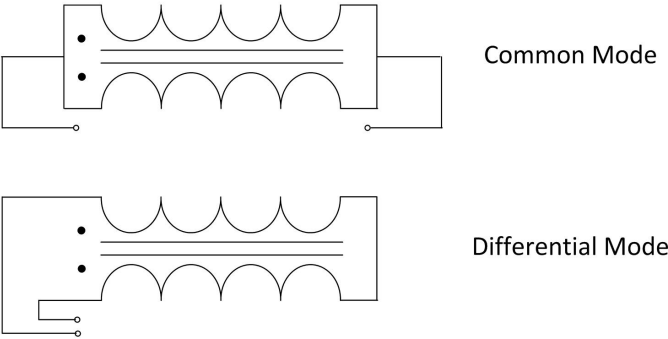

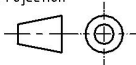
Product specific:

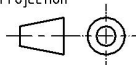
