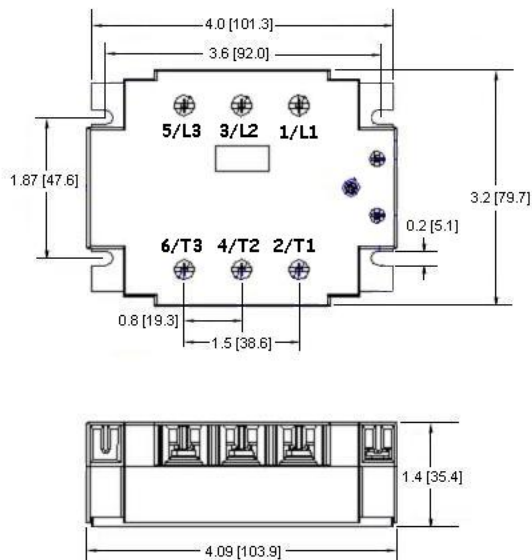

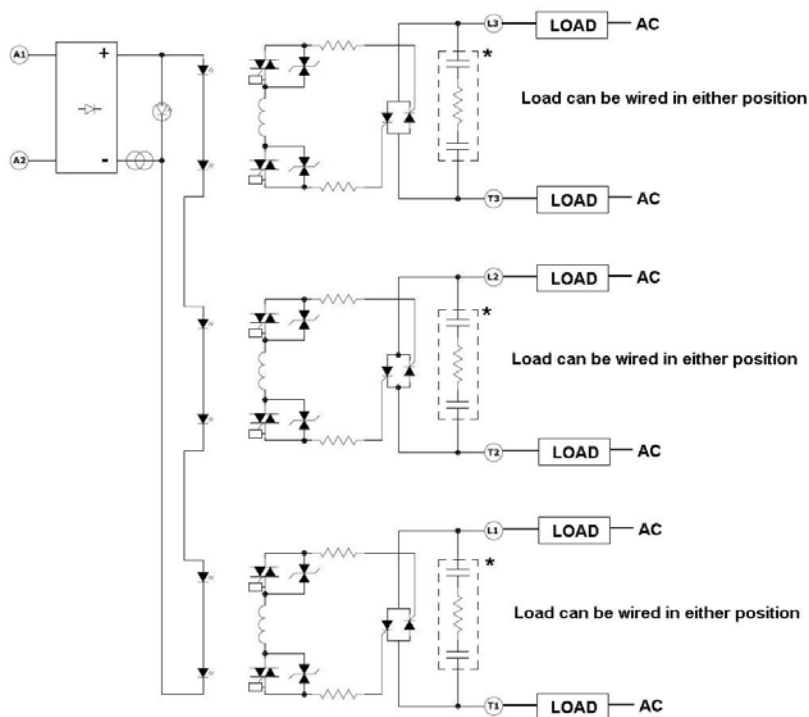

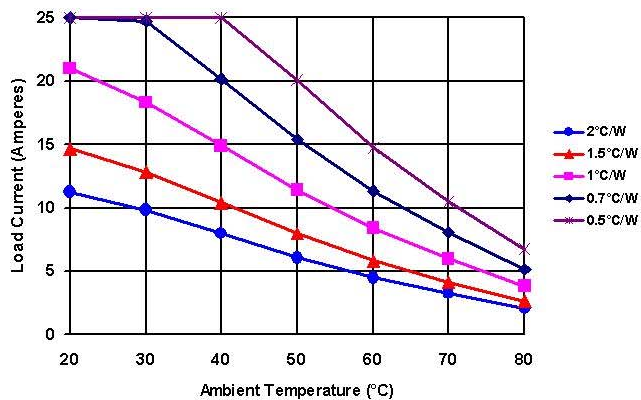
WIRING DIAGRAM



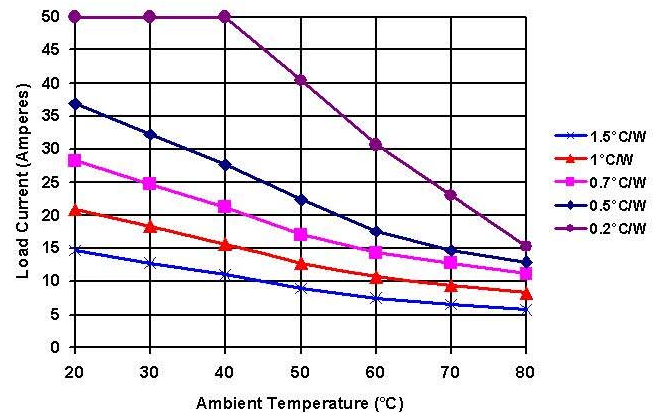
