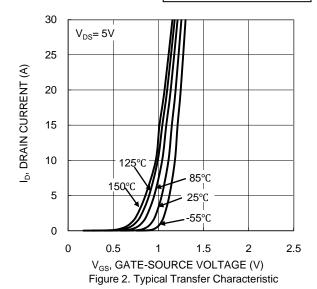
I<sub>D</sub>, DRAIN CURRENT(A) Figure 5. Typical On-Resistance vs. Drain Current and Junction Temperature

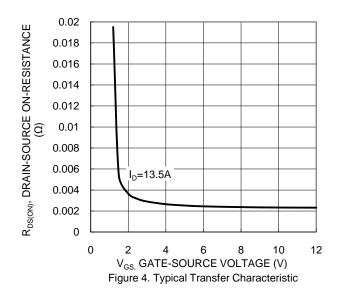

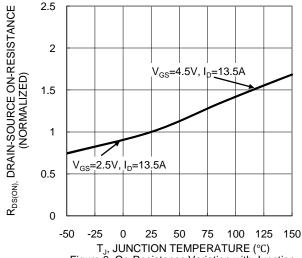


Figure 6. On-Resistance Variation with Junction Temperature

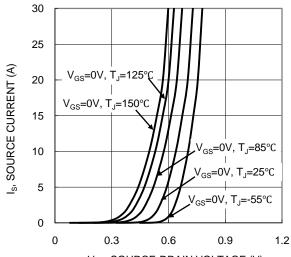

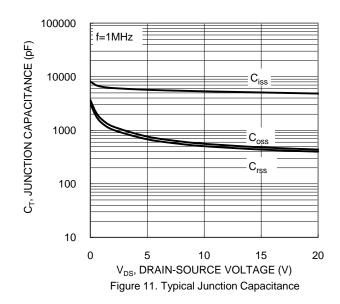

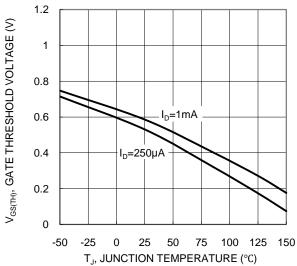
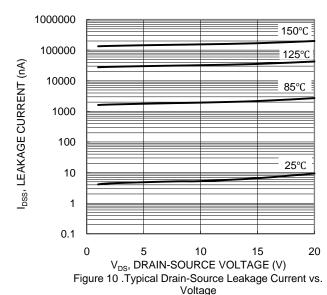
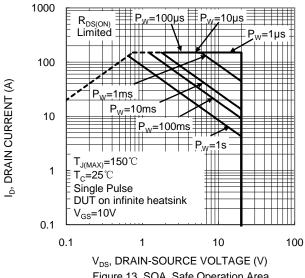


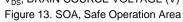
Figure 8. Gate Threshold Variation vs. Junction Temperature

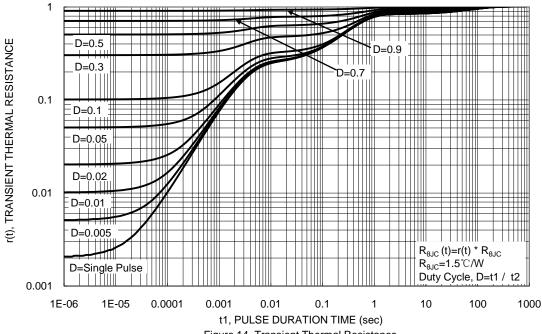
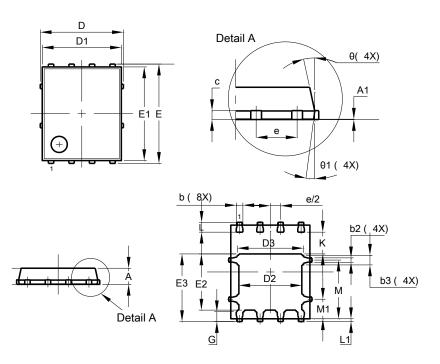


Figure 14. Transient Thermal Resistance

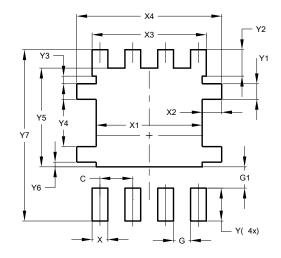
