




Figure 1. Collector Dark Current vs. Ambient Temperature




Figure 3. Collector Emitter Capacitance vs. Collector Emitter Voltage




Figure 2. Photo Current vs. Illuminance




Figure 4. Relative Spectral Sensitivity vs. Wavelength




Figure 5. Relative Radiant Sensitivity vs. Angular Displacement

Reflow Solder Profiles




Figure 6. Lead (Pb)-free (Sn) Reflow Solder Profile

Drypack

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

Floor Life

Time between soldering and removing from MBB must not exceed the time indicated in J-STD-020, Moisture Sensitivity Level 4:

Floor Life: 72 h

Conditions: $T_{amb} < 30^{\circ}\text{C}$, $RH < 60\%$

Drying

In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-020 or Label. Devices taped on reel dry using recommended conditions 192 h at 40°C ($+ 5^{\circ}\text{C}$), $RH < 5\%$.







Figure 7. Lead Tin (SnPb) Reflow Solder Profile


