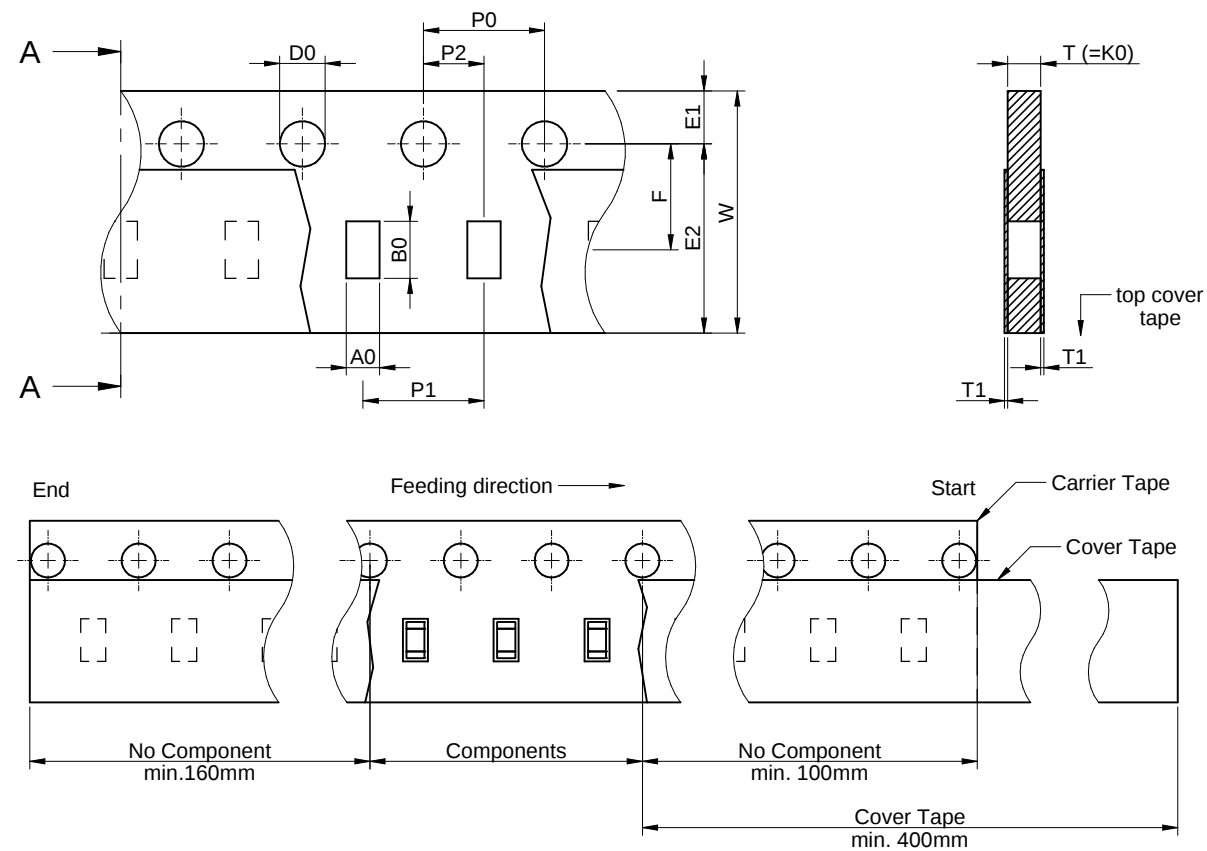
Derating Curve:

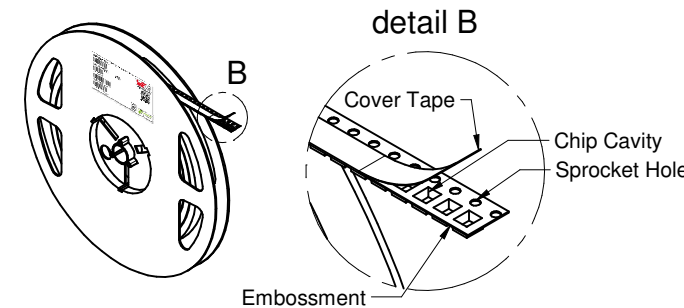
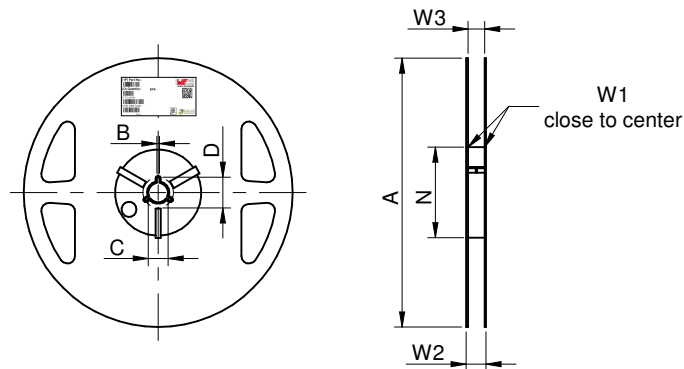

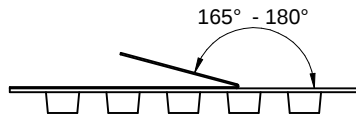
