### 1. General description

The HEF4520B is a dual 4-bit internally synchronous binary counter with two clock inputs (nCP0 and n $\overline{CP1}$ ), buffered outputs from all four bit positions (nQ0 to nQ3) and an asynchronous master reset input (nMR). The counter advances on either the LOW-to-HIGH transition of nCP0 if n $\overline{CP1}$  is HIGH or the HIGH-to-LOW transition of n $\overline{CP1}$  if nCP0 is LOW. Either nCP0 or n $\overline{CP1}$  may be used as the clock input to the counter and the other clock input may be used as a clock enable input. A HIGH on nMR resets the counter (nQ0 to nQ3 = LOW) independent of nCP0 and nCP1. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{DD}$ .









a. nCP0 and nCP1 set-up times, propagation delays and output transition times




b. nMR recovery time, minimum nCP0, nCP1, and nMR pulse widths and maximum frequency Measurement points are given in Table 9.


The logic levels  $V_{OH}$  and  $V_{OL}$  are typical output voltage levels that occur with the output load.




Fig. 6. Package outline SOT109-1 (SO16)
