


Fig. 7 Gate Threshold Variation vs. Ambient Temperature




Fig. 9 Typical Capacitance




Fig. 8 Diode Forward Voltage vs. Current




Fig. 10 Typical Drain-Source Leakage Current vs. Drain-Source Voltage




Fig. 11 Typical Output Characteristics




Fig. 12 Typical Transfer Characteristics




Fig. 13 Typical On-Resistance
vs. Drain Current and Gate Voltage




Fig. 14 Typical Drain-Source On-Resistance
vs. Drain Current and Temperature




Fig. 15 On-Resistance Variation with Temperature




Fig. 16 On-Resistance Variation with Temperature




Fig. 17 Gate Threshold Variation vs. Ambient Temperature







Fig. 18 Diode Forward Voltage vs. Current


