C Schematic:

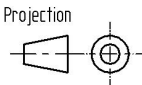

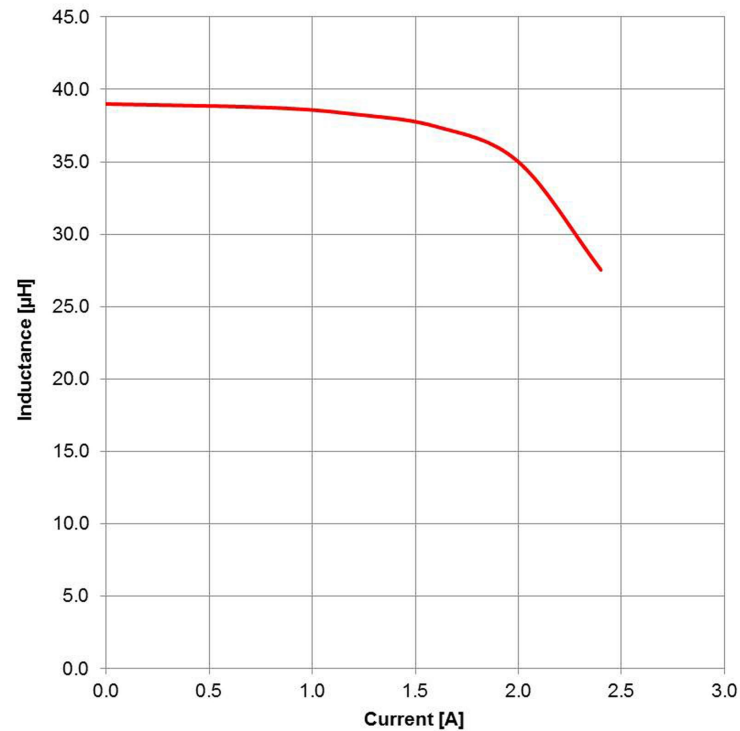

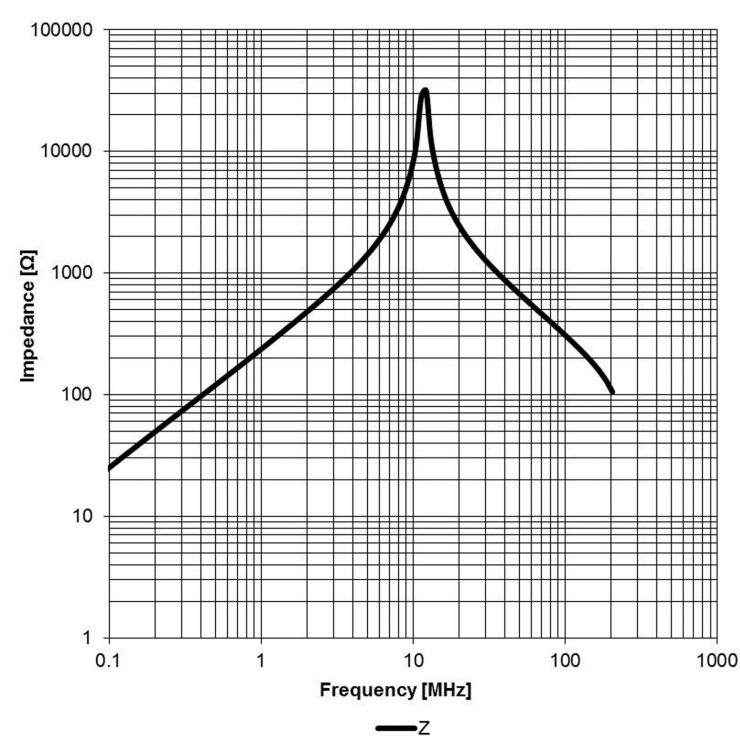

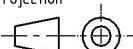


F1 Typical Inductance vs. Current Characteristics:

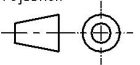

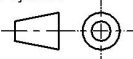
