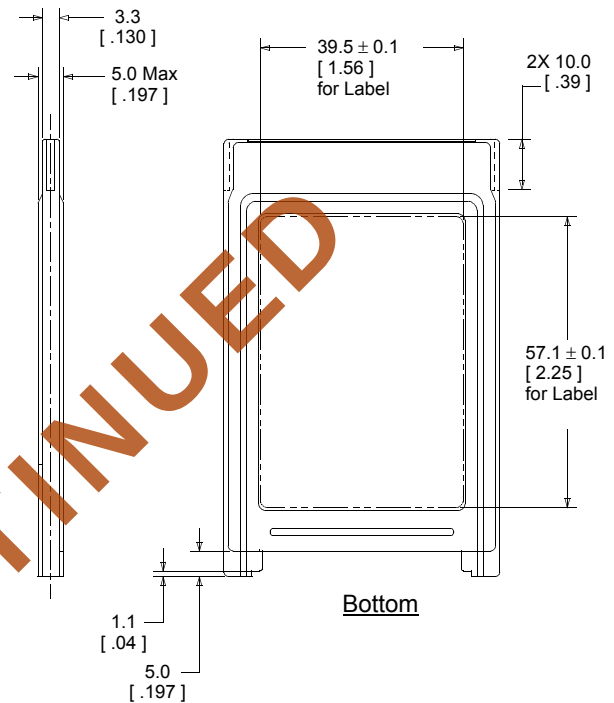


PC Card Socket Interface View 2:1

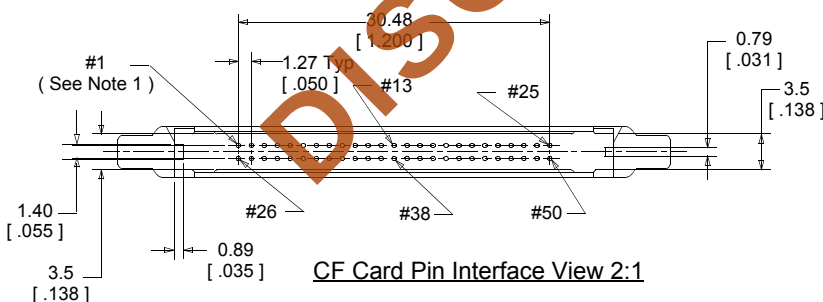
