1. General description

The 74HC1G02-Q100; 74HCT1G02-Q100 is a single 2-input NOR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

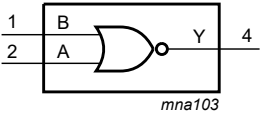


Fig. 1. Logic symbol

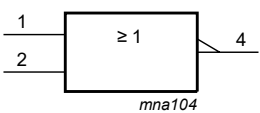


Fig. 2. IEC logic symbol

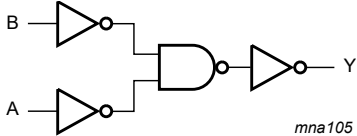
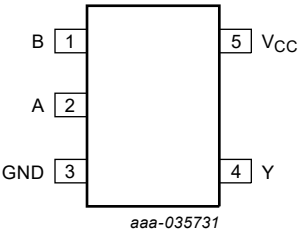


Fig. 3. Logic diagram

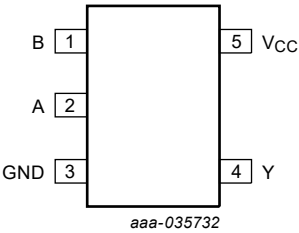

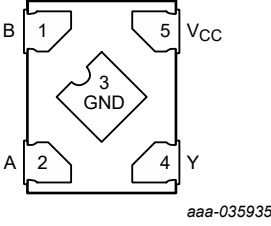

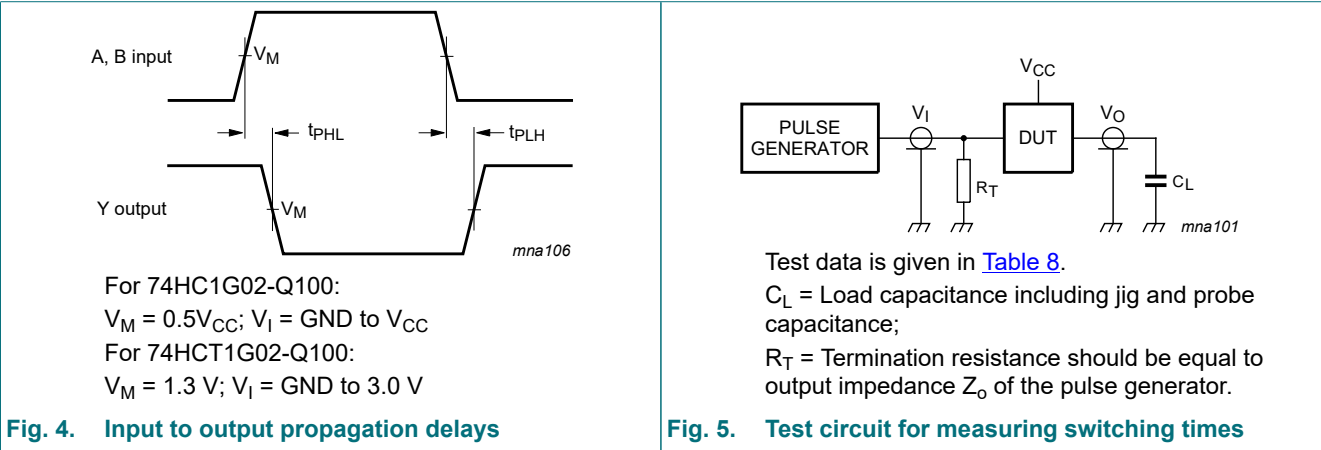

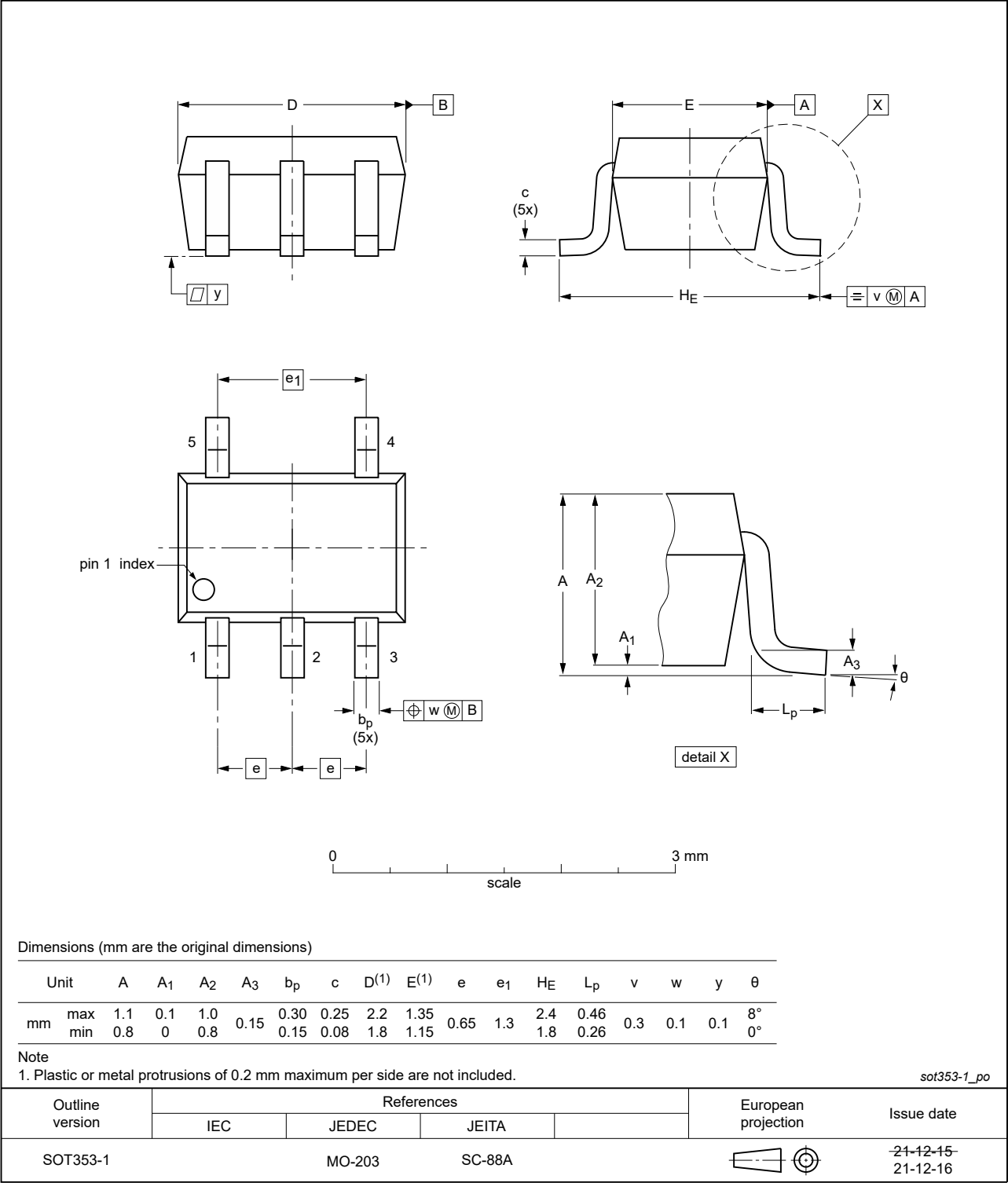


Fig. 6. Package outline SOT353-1 (TSSOP5)

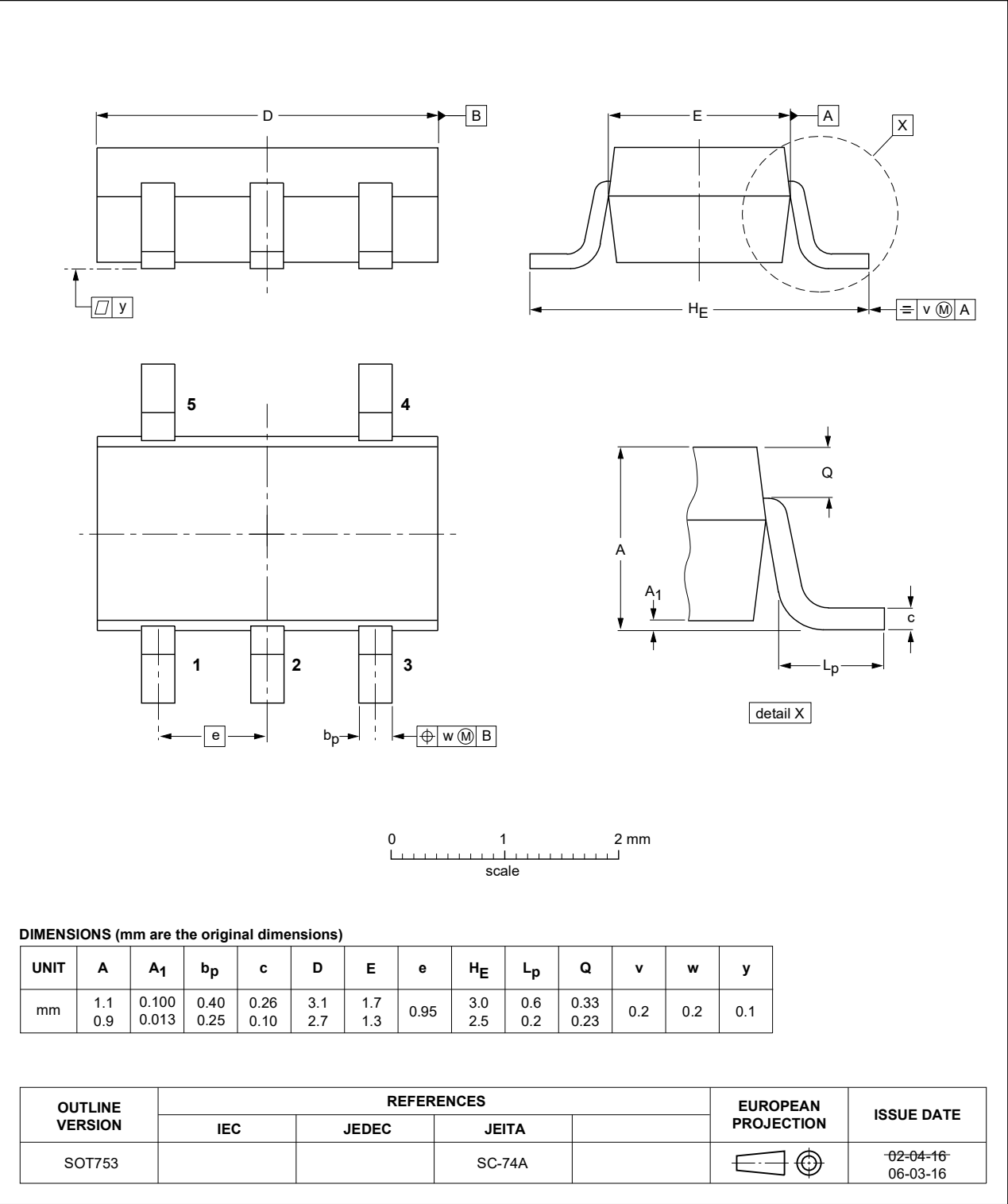


Fig. 7. Package outline SOT753 (SC-74A)

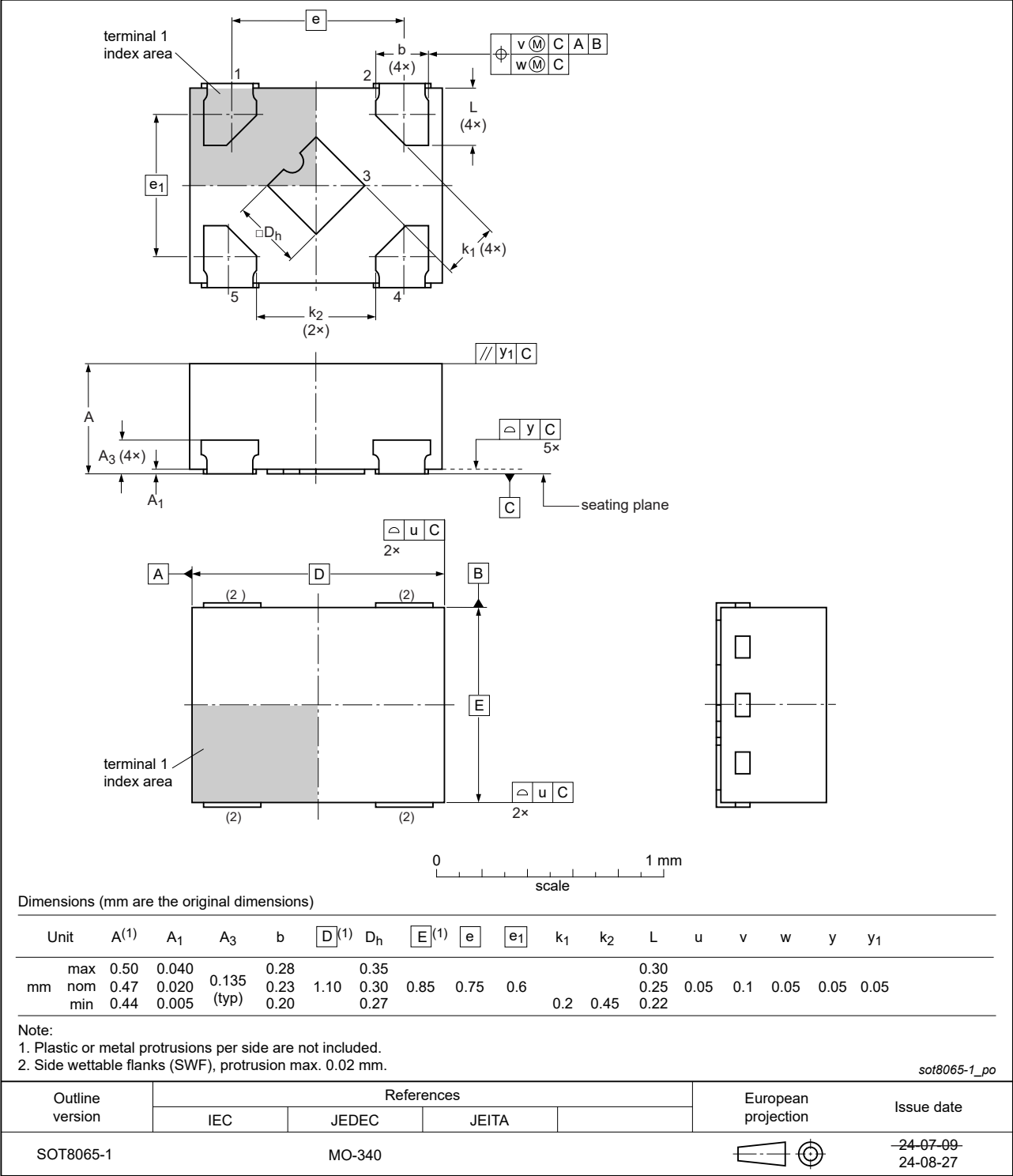


Fig. 8. Package outline SOT8065-1 (XSON5)
