




■ Recommemded Pad Layout







■ Electrical Characteristic Curves

Forward Current - Forward Voltage







Relative Luminous Intensity - Case Temperature







Relative Luminous Intensity - Forward Current







Ratio of Maximum Tolerable Peak Current - Pulse Duration
