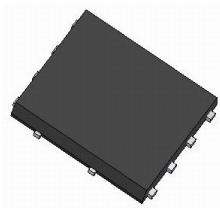

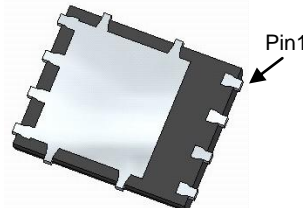

Top View



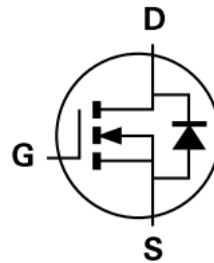

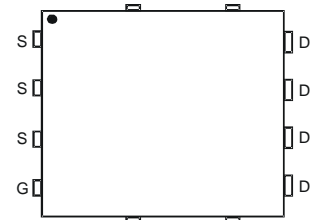

Internal Schematic



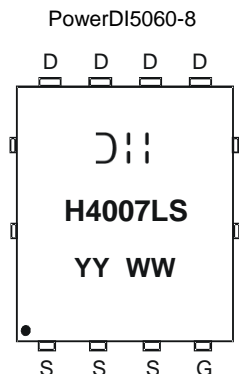
Top View  
Pin Configuration


