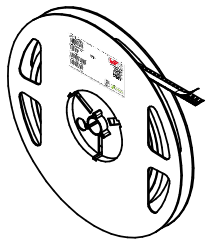
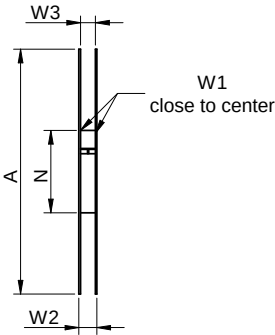
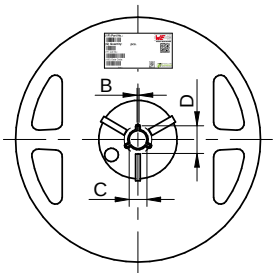
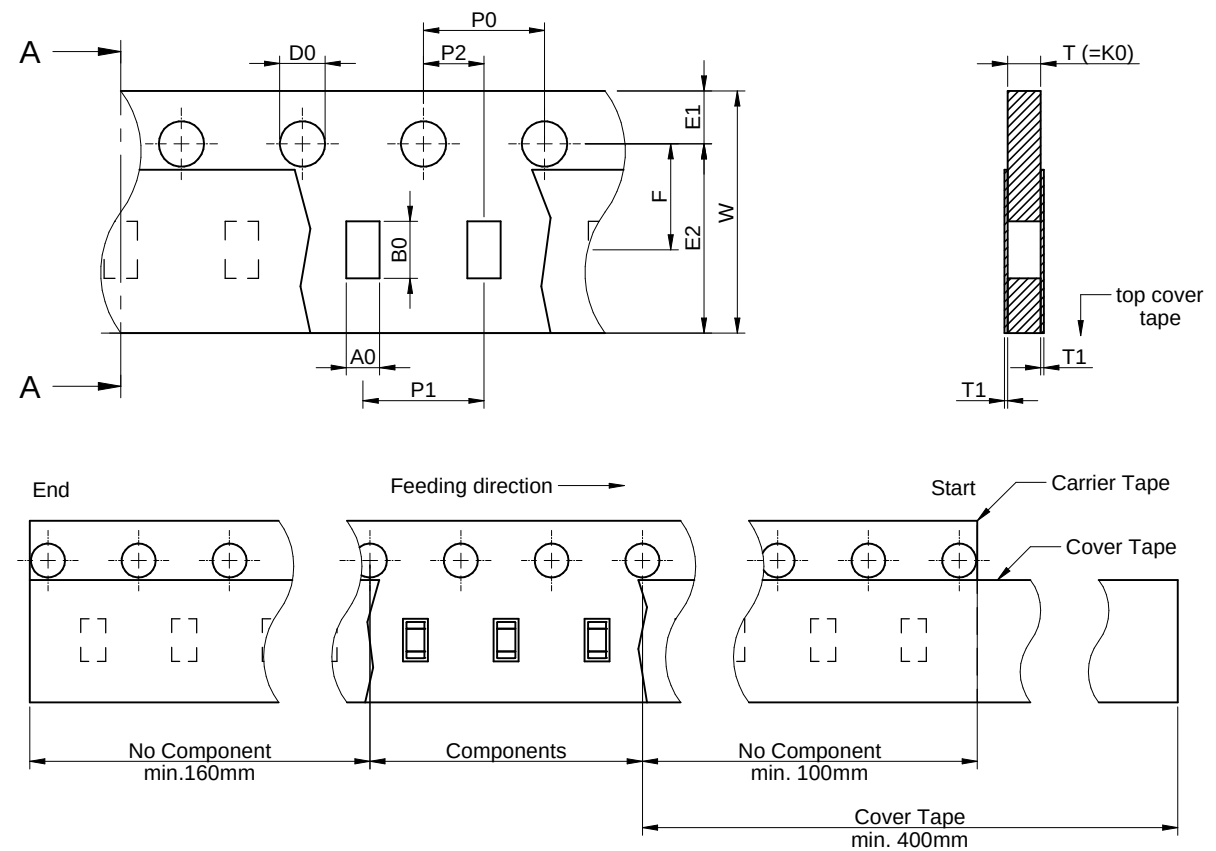
Derating Curve:
