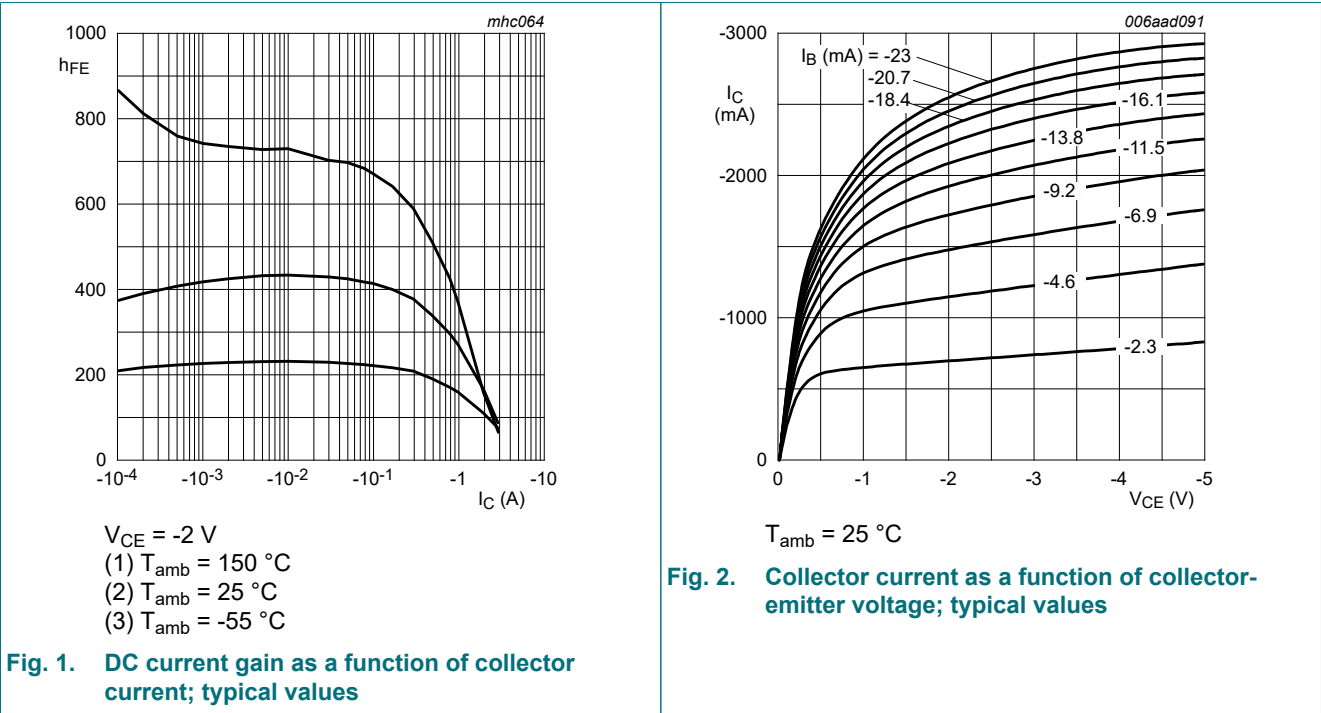

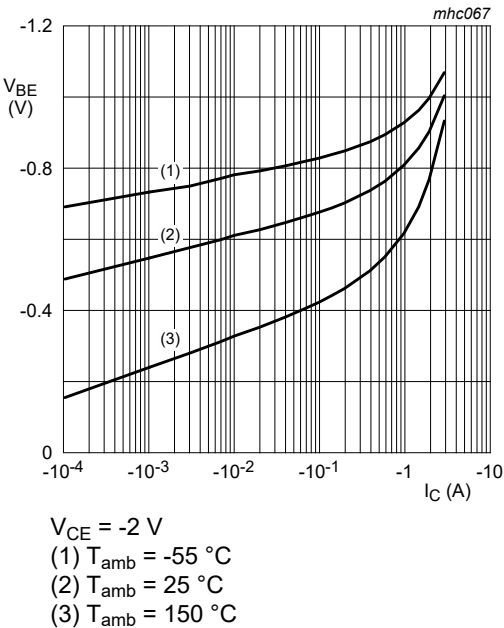


Fig. 3. Base-emitter voltage as a function of collector current; typical values

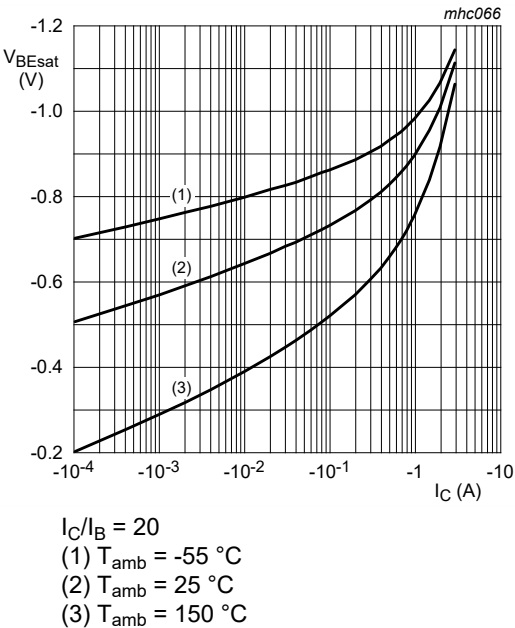


Fig. 4. Base-emitter saturation voltage as a function of collector current; typical values

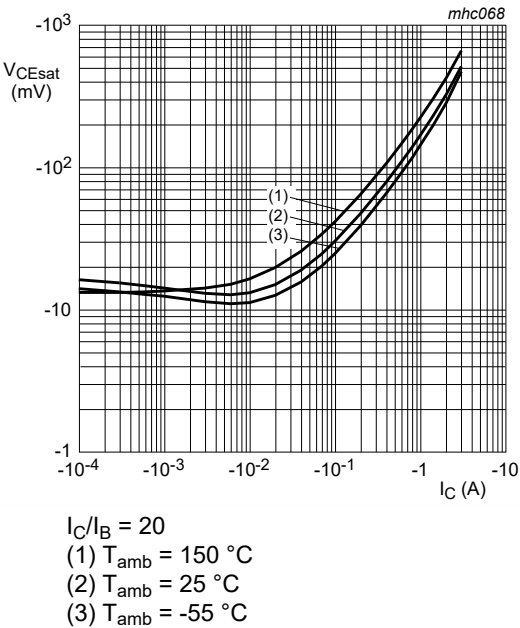


Fig. 5. Collector-emitter saturation voltage as a function of collector current; typical values

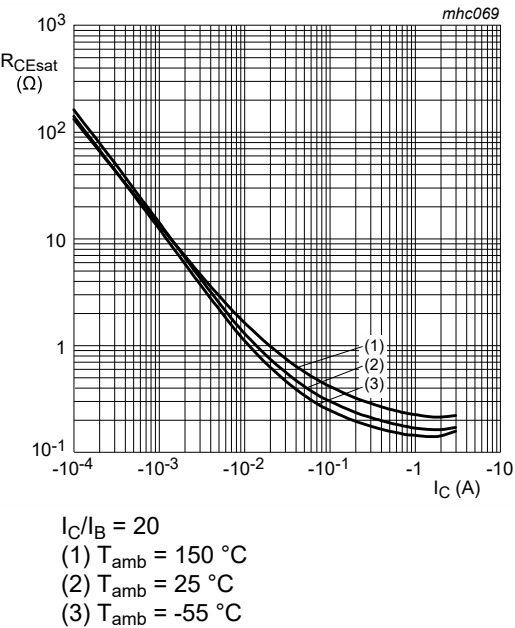
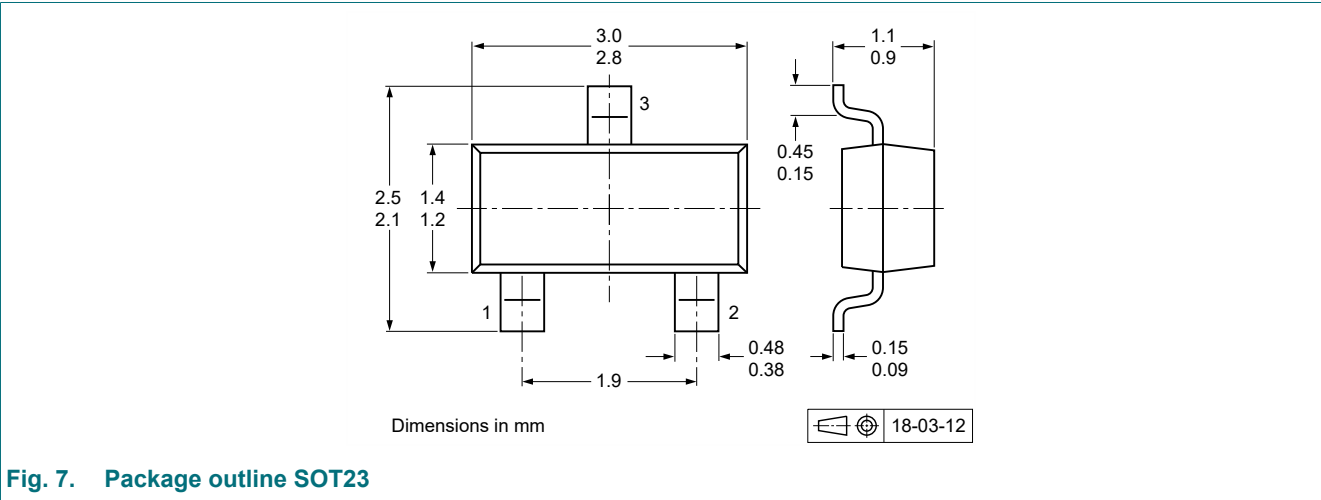
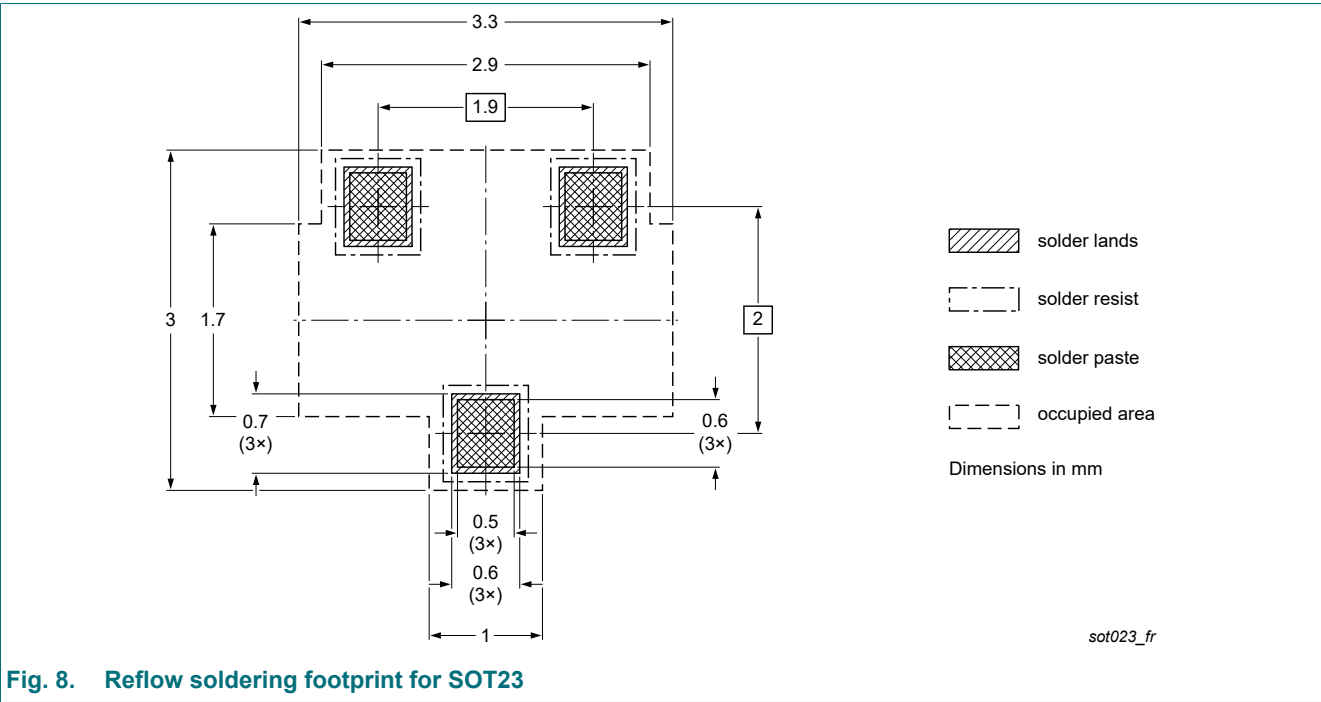


Fig. 6. Collector-emitter saturation resistance as a function of collector current; typical values

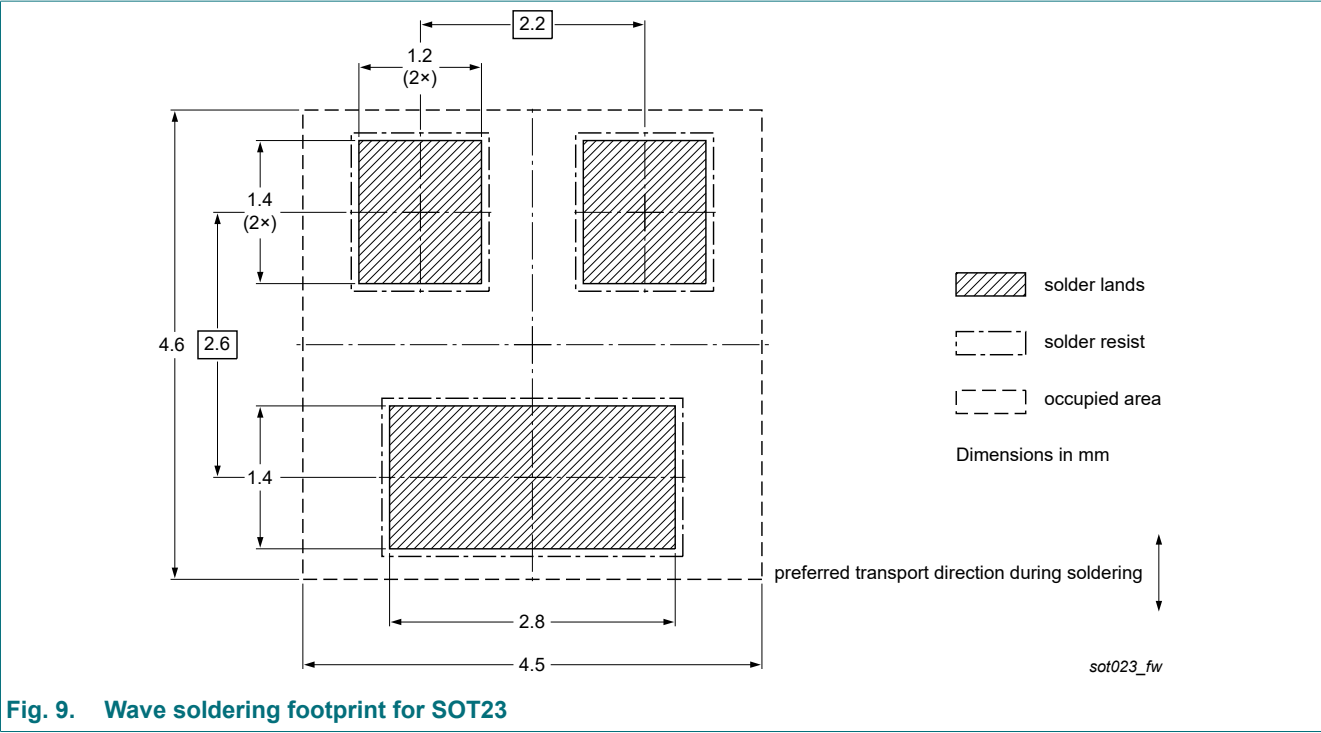


Fig. 9. Wave soldering footprint for SOT23
