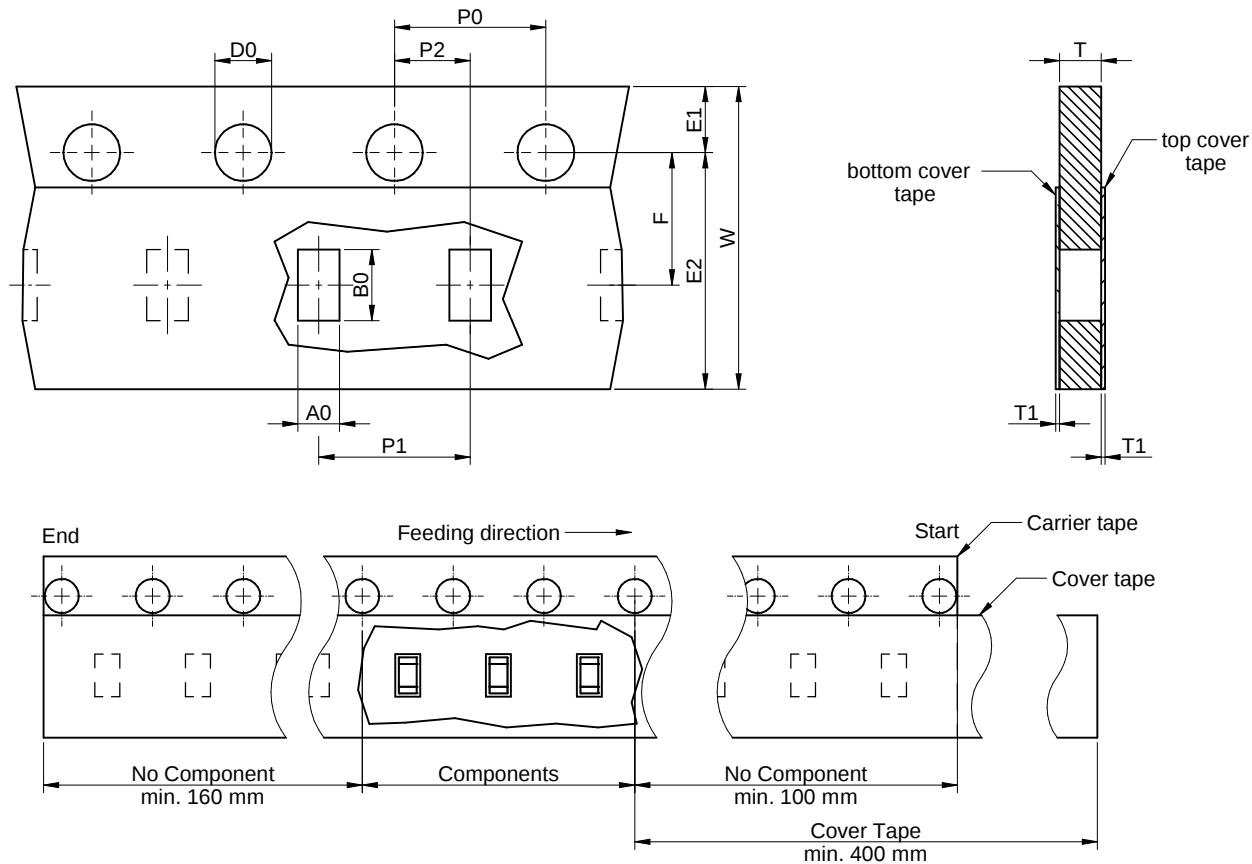
Derating Curve:

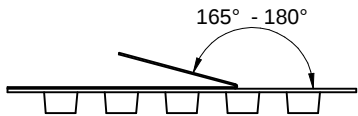

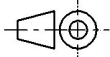

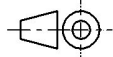
