C Schematic:



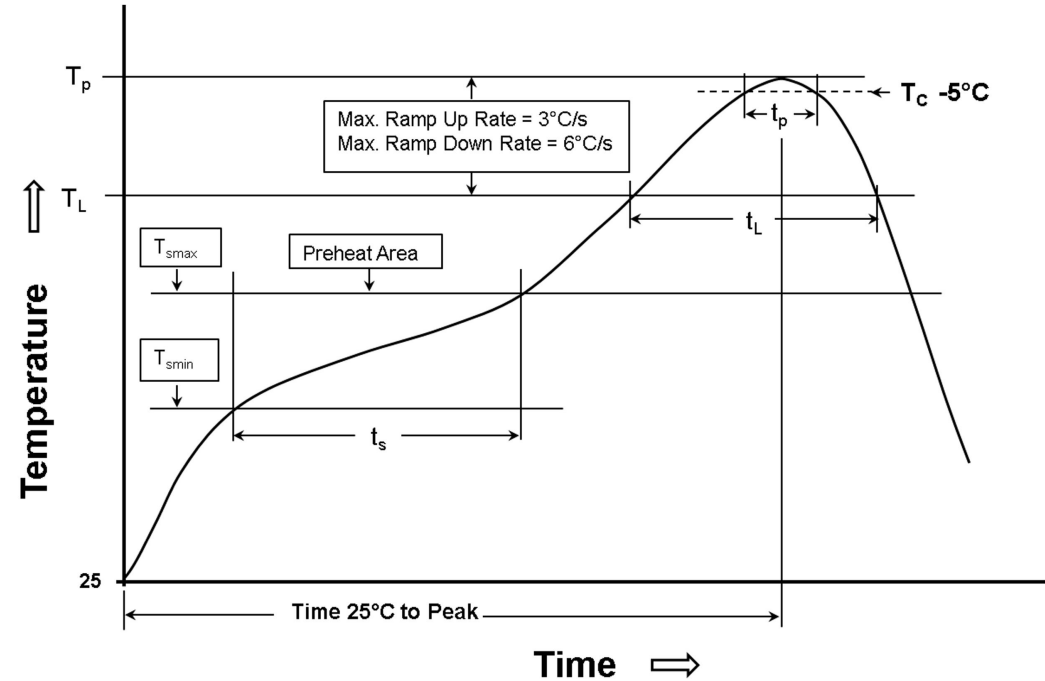
