

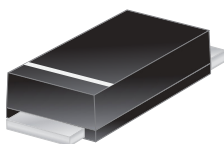

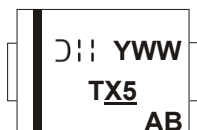

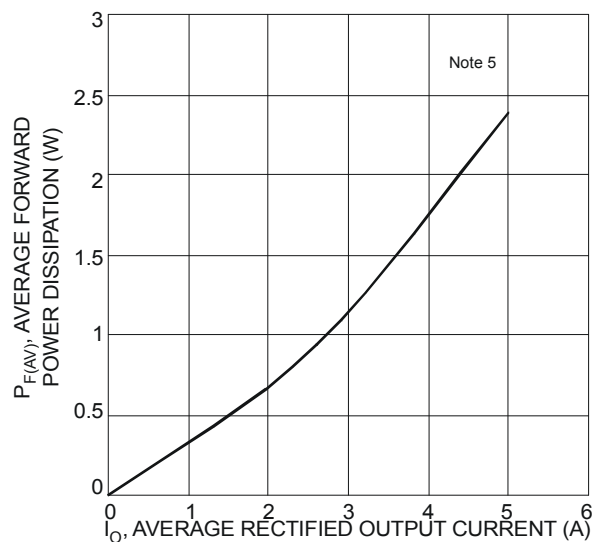


Figure 1 Forward Power Dissipation

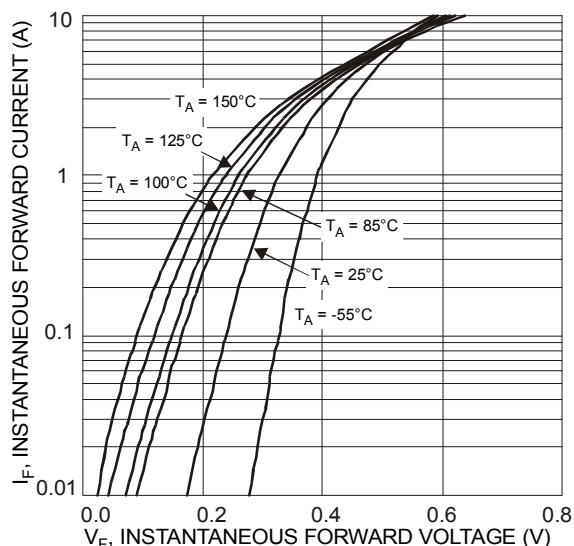
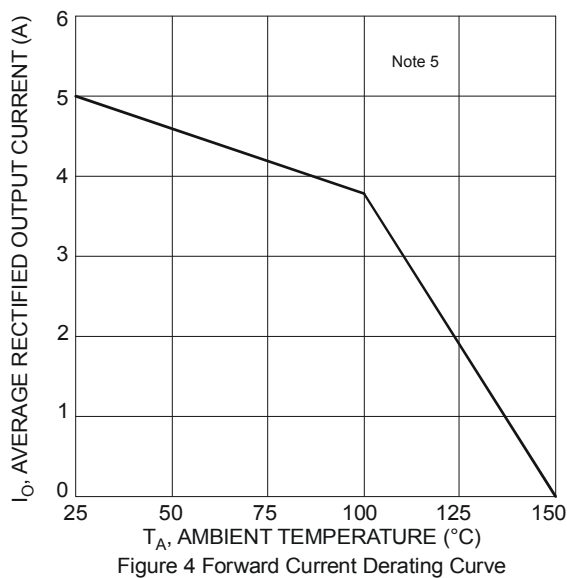
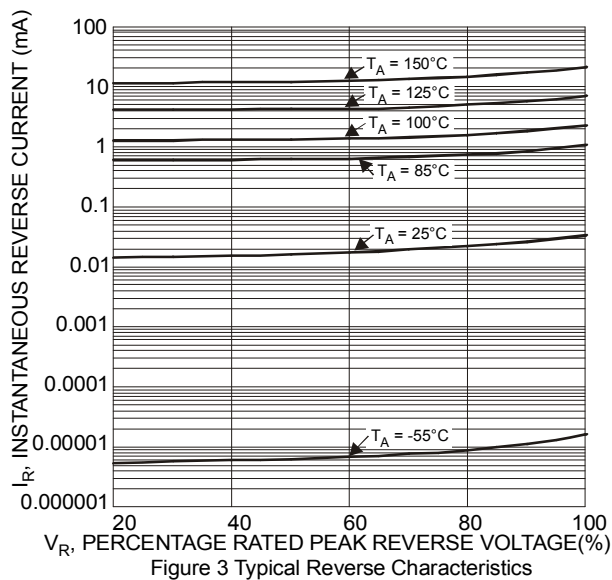
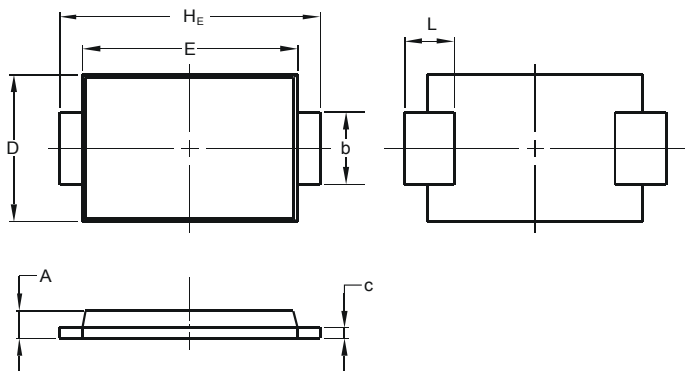


Figure 2 Typical Forward Characteristics

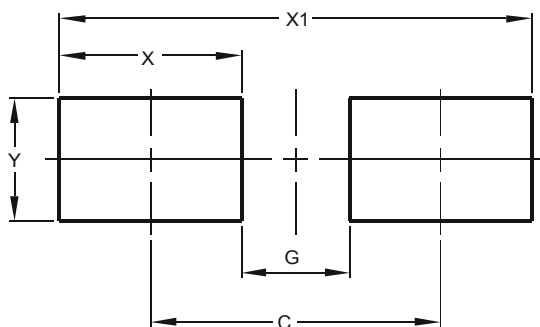
