


PACKAGE DIMENSIONS







RELATIVE INTENSITY vs. WAVELENGTH




SPATIAL DISTRIBUTION




SUPER BRIGHT ORANGE




REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS



TAPE SPECIFICATIONS (units : mm)





REEL DIMENSION (units : mm)
