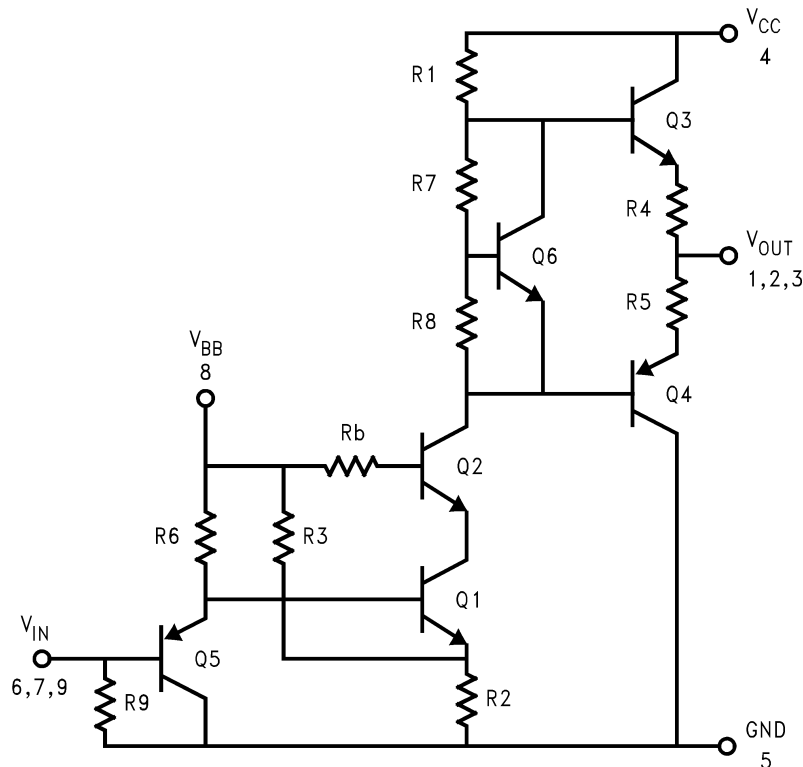

### DESCRIPTION

The LM2445 is an integrated high voltage CRT driver circuit designed for use in color monitor applications. The IC contains three high input impedance, wide band amplifiers which directly drive the RGB cathodes of a CRT. Each channel has its gain internally set to  $-20$  and can drive CRT capacitive loads as well as resistive loads present in other applications, limited only by the package's power dissipation.

The IC is packaged in an industry standard 9-lead TO-220 molded plastic power package. See the [THERMAL CONSIDERATIONS](#) section for more information.

(One Channel)**

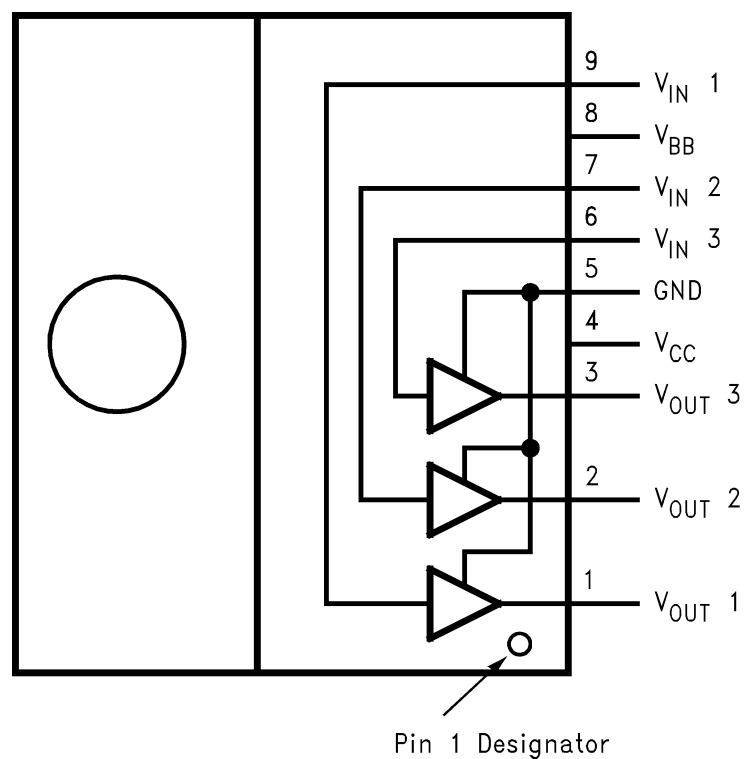

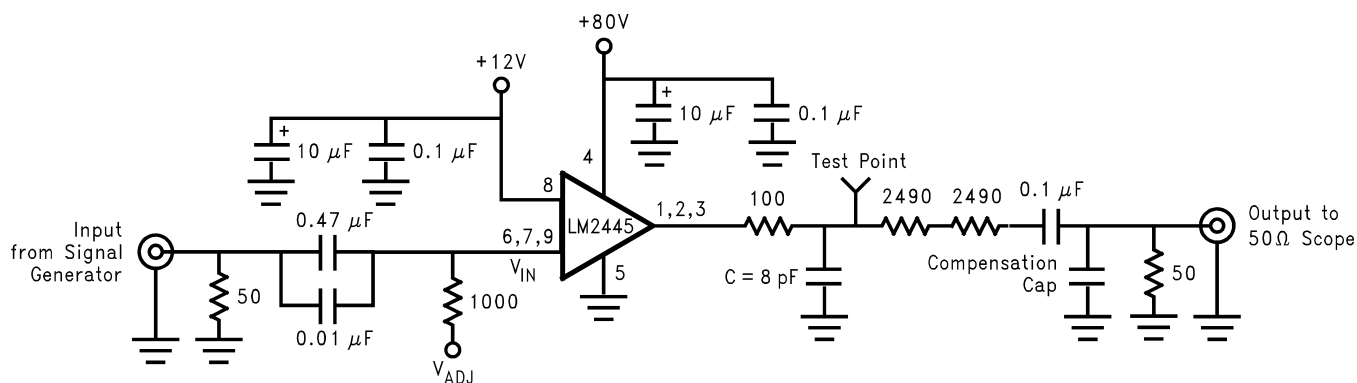

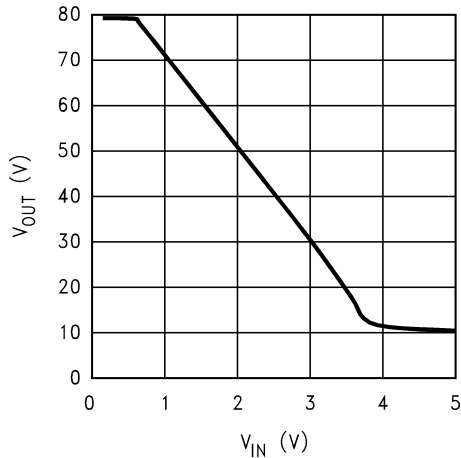

**Figure 3. Test Circuit (One Channel)**

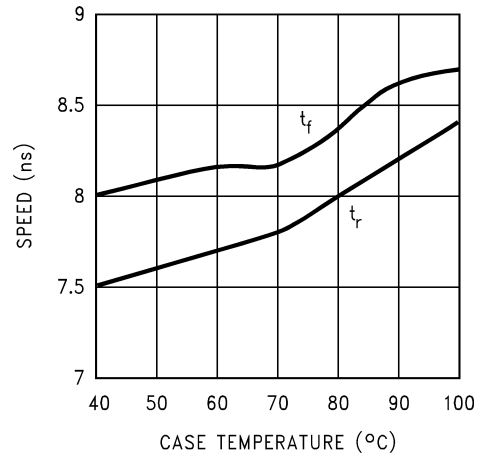
Figure 3 shows a typical test circuit for evaluation of the LM2445. This circuit is designed to allow testing of the LM2445 in a 50Ω environment without the use of an expensive FET probe. The two 2490Ω resistors form a 200:1 divider with the 50Ω resistor and the oscilloscope. A test point is included for easy use of an oscilloscope probe. The compensation capacitor is used to compensate the stray capacitance of the two 2490Ω resistors to achieve flat frequency response.

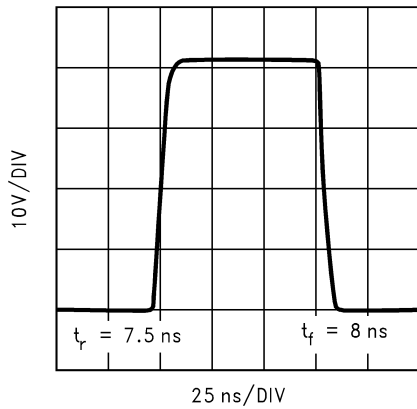

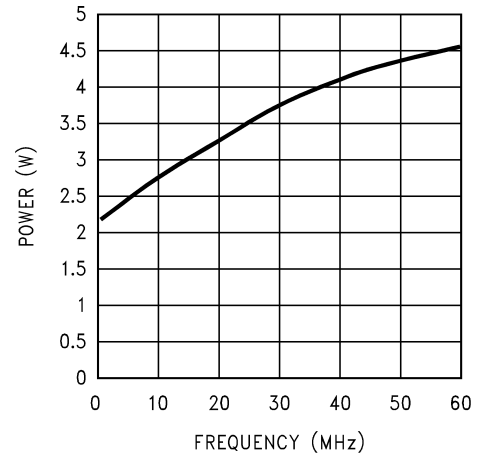
**Figure 4.  $V_{OUT}$  vs  $V_{IN}$**



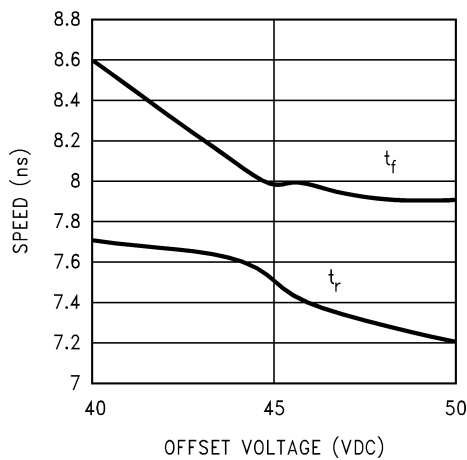
**Figure 5. Speed vs Temp.**



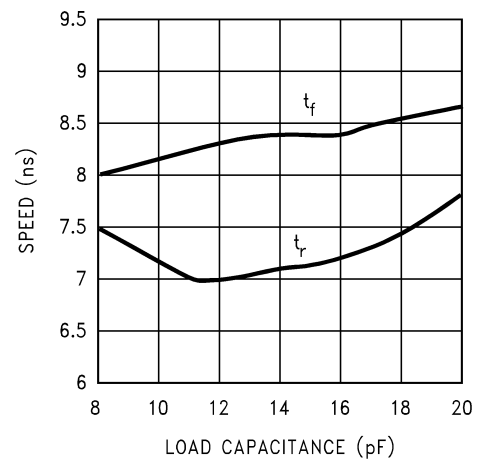
**Figure 6. LM2445 Pulse Response**

## THEORY OF OPERATION

The LM2445 is a high voltage monolithic three channel CRT driver suitable for high resolution display applications. The LM2445 operates with 80V and 12V power supplies. The part is housed in the industry standard 9-lead TO-220 molded plastic power package.

The circuit diagram of the LM2445 is shown in [Figure 1](#). The PNP emitter follower, Q5, provides input buffering. Q1 and Q2 form a fixed gain cascode amplifier with resistors R1 and R2 setting the gain at  $-20$ . Emitter followers Q3 and Q4 isolate the high output impedance of the cascode stage from the capacitance of the CRT cathode which decreases the sensitivity of the device to load capacitance. Q6 provides biasing to the output emitter follower stage to reduce crossover distortion at low signal levels.

[Figure 3](#) shows a typical test circuit for evaluation of the LM2445. This circuit is designed to allow testing of the LM2445 in a  $50\Omega$  environment without the use of an expensive FET probe. In this test circuit, the two  $2.49\text{k}\Omega$  resistors form a 200:1 wideband, low capacitance probe when connected to a  $50\Omega$  coaxial cable and a  $50\Omega$  load (such as a  $50\Omega$  oscilloscope input). The input signal from the generator is ac coupled to the base of Q5.

## APPLICATION HINTS

### INTRODUCTION

Texas Instruments is committed to provide application information that assists our customers in obtaining the best performance possible from our products. The reader should be aware that the optimization of performance was done using a specific printed circuit board designed at TI. Variations in performance can be realized due to physical changes in the printed circuit board and the application. Therefore, the designer should know that component value changes may be required in order to optimize performance in a given application. The values shown in this document can be used as a starting point for evaluation purposes. When working with high bandwidth circuits, good layout practices are also critical to achieving maximum performance.

### IMPORTANT INFORMATION

The LM2445 performance is targeted for the VGA (640 x 480) to XGA (1024 x 768, 85 Hz refresh) resolution market. The application circuits shown in this document to optimize performance and to protect against damage from CRT arc-over are designed specifically for the LM2445. If another member of the LM246X family is used, please refer to its datasheet.

### POWER SUPPLY BYPASS

Since the LM2445 is a wide bandwidth amplifier, proper power supply bypassing is critical for optimum performance. Improper power supply bypassing can result in large overshoot, ringing or oscillation.  $0.1\ \mu\text{F}$  capacitors should be connected from the supply pins,  $V_{\text{CC}}$  and  $V_{\text{BB}}$ , to ground, as close to the LM2445 as is practical. Additionally, a  $47\ \mu\text{F}$  or larger electrolytic capacitor should be connected from both supply pins to ground reasonably close to the LM2445.

## ARC PROTECTION

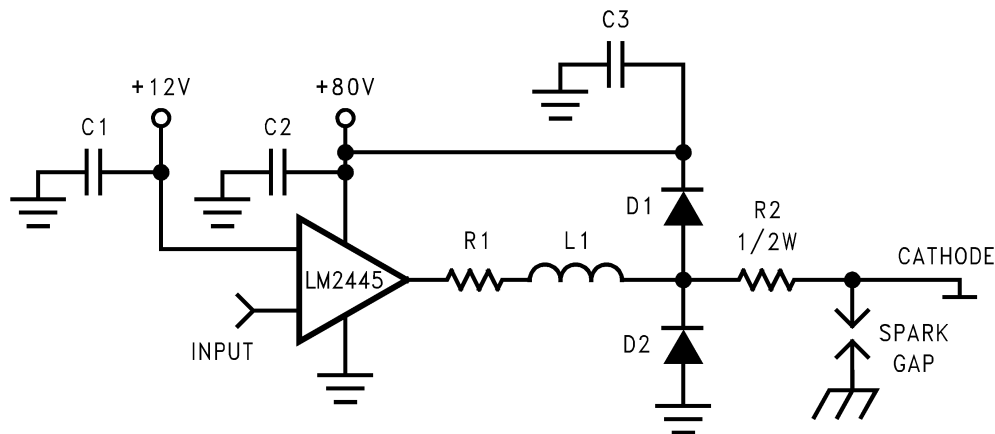


Figure 10. One Channel of the LM2445 with the Recommended Application Circuit

During normal CRT operation, internal arcing may occasionally occur. Spark gaps, in the range of 200V, connected from the CRT cathodes to CRT ground will limit the maximum voltage, but to a value that is much higher than allowable on the LM2445. This fast, high voltage, high energy pulse can damage the LM2445 output stage. The application circuit shown in Figure 10 is designed to help clamp the voltage at the output of the LM2445 to a safe level. The clamp diodes, D1 and D2, should have a fast transient response, high peak current rating, low series impedance and low shunt capacitance. FDH400 or equivalent diodes are recommended. Do not use 1N4148 diodes for the clamp diodes. D1 and D2 should have short, low impedance connections to  $V_{CC}$  and ground respectively. The cathode of D1 should be located very close to a separately decoupled bypass capacitor (C3 in Figure 10). The ground connection of D2 and the decoupling capacitor should be very close to the LM2445 ground. This will significantly reduce the high frequency voltage transients that the LM2445 would be subjected to during an arcover condition. Resistor R2 limits the arcover current that is seen by the diodes while R1 limits the current into the LM2445 as well as the voltage stress at the outputs of the device. R2 should be a  $\frac{1}{2}W$  solid carbon type resistor. R1 can be a  $\frac{1}{4}W$  metal or carbon film type resistor. Having large value resistors for R1 and R2 would be desirable, but this has the effect of increasing rise and fall times. Inductor L1 is critical to reduce the initial high frequency voltage levels that the LM2445 would be subjected to. The inductor will not only help protect the device but it will also help minimize rise and fall times as well as minimize EMI. For proper arc protection, it is important to not omit any of the arc protection components shown in Figure 10.

## OPTIMIZING TRANSIENT RESPONSE

Referring to Figure 10, there are three components (R1, R2 and L1) that can be adjusted to optimize the transient response of the application circuit. Increasing the values of R1 and R2 will slow the circuit down while decreasing overshoot. Increasing the value of L1 will speed up the circuit as well as increase overshoot. It is very important to use inductors with very high self-resonant frequencies, preferably above 300 MHz. Ferrite core inductors from J.W. Miller Magnetics (part # 78FR--k) were used for optimizing the performance of the device in the TI application board. The values shown in Figure 12 and Figure 13 can be used as a good starting point for the evaluation of the LM2445. Using variable resistors for R1 and the parallel resistor will simplify finding the values needed for optimum performance in a given application. Once the optimum values are determined the variable resistors can be replaced with fixed values.

## EFFECT OF LOAD CAPACITANCE

Figure 9 shows the effect of increased load capacitance on the speed of the device. This demonstrates the importance of knowing the load capacitance in the application.

## EFFECT OF OFFSET

Figure 8 shows the variation in rise and fall times when the output offset of the device is varied from 40 to 50  $V_{DC}$ . The rise time shows a maximum variation relative to the center data point (45  $V_{DC}$ ) less than 5%. The fall time shows a variation of less than 8% relative to the center data point.

## THERMAL CONSIDERATIONS

Figure 5 shows the performance of the LM2445 in the test circuit shown in Figure 3 as a function of case temperature. The figure shows that the rise time of the LM2445 increases by approximately 10% as the case temperature increases from 50°C to 100°C. This corresponds to a speed degradation of 2% for every 10°C rise in case temperature. The fall time increases by approximately 7% as the case temperature increases from 50°C to 100°C.

Figure 7 shows the maximum power dissipation of the LM2445 vs. Frequency when all three channels of the device are driving an 8 pF load with a 40 V<sub>p-p</sub> alternating one pixel on, one pixel off signal. The graph assumes a 72% active time (device operating at the specified frequency) which is typical in a monitor application. The other 28% of the time the device is assumed to be sitting at the black level (65V in this case). This graph gives the designer the information needed to determine the heat sink requirement for his application. The designer should note that if the load capacitance is increased the AC component of the total power dissipation will also increase.

The LM2445 case temperature must be maintained below 100°C. If the maximum expected ambient temperature inside the monitor is 70°C and the power dissipation is 4.4W (from Figure 7, 50 MHz max. video frequency), then a maximum heat sink thermal resistance can be calculated:

$$R_{TH} = \frac{100^{\circ}\text{C} - 70^{\circ}\text{C}}{4.4\text{W}} = 6.8^{\circ}\text{C/W} \quad (1)$$

This example assumes a capacitive load of 8 pF and no resistive load.

## TYPICAL APPLICATION

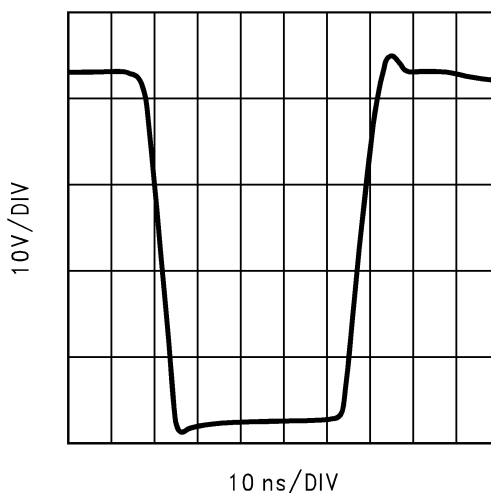


Figure 11. Red Cathode Response

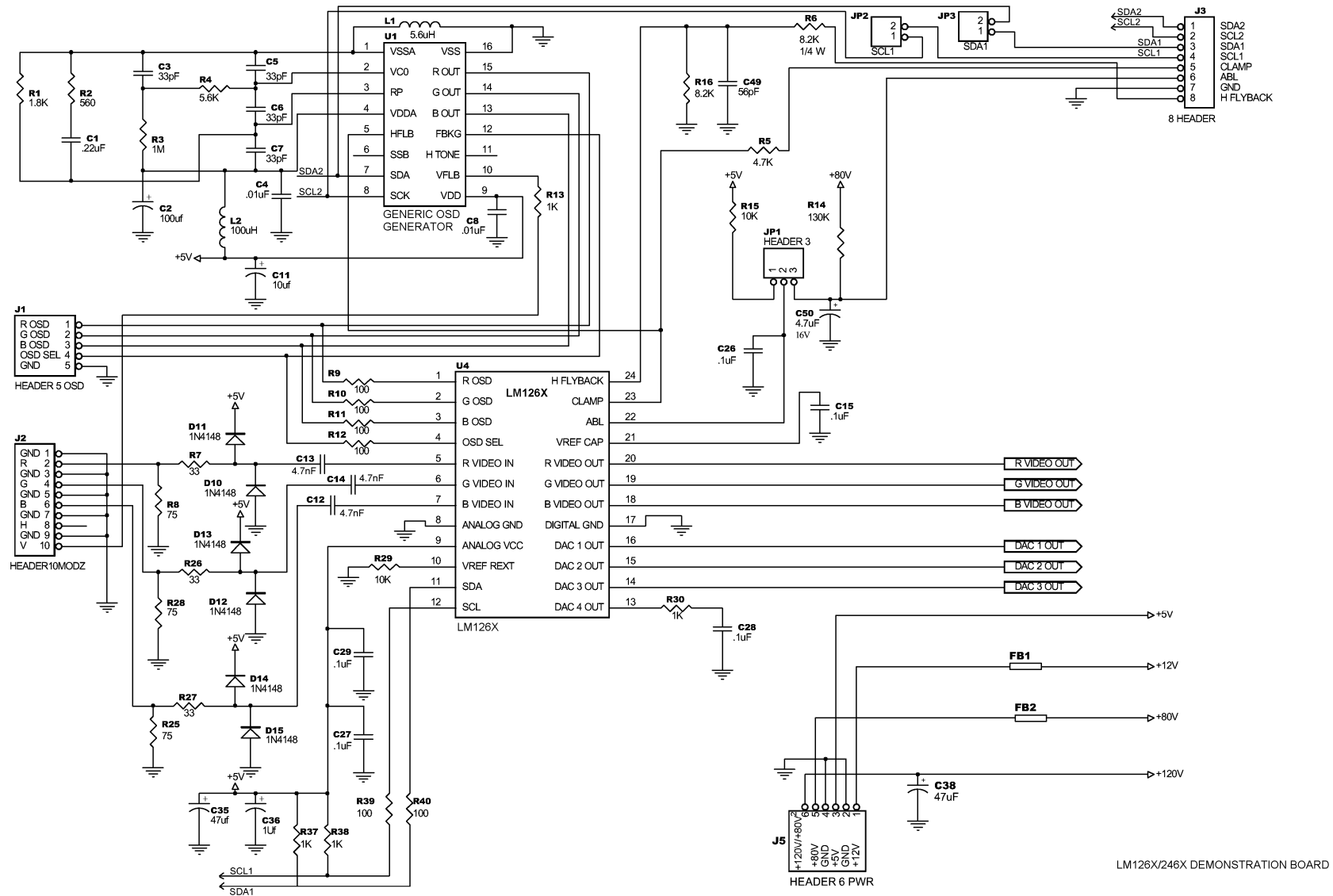


Figure 12. LM126X/LM246X Demonstration Board Schematic

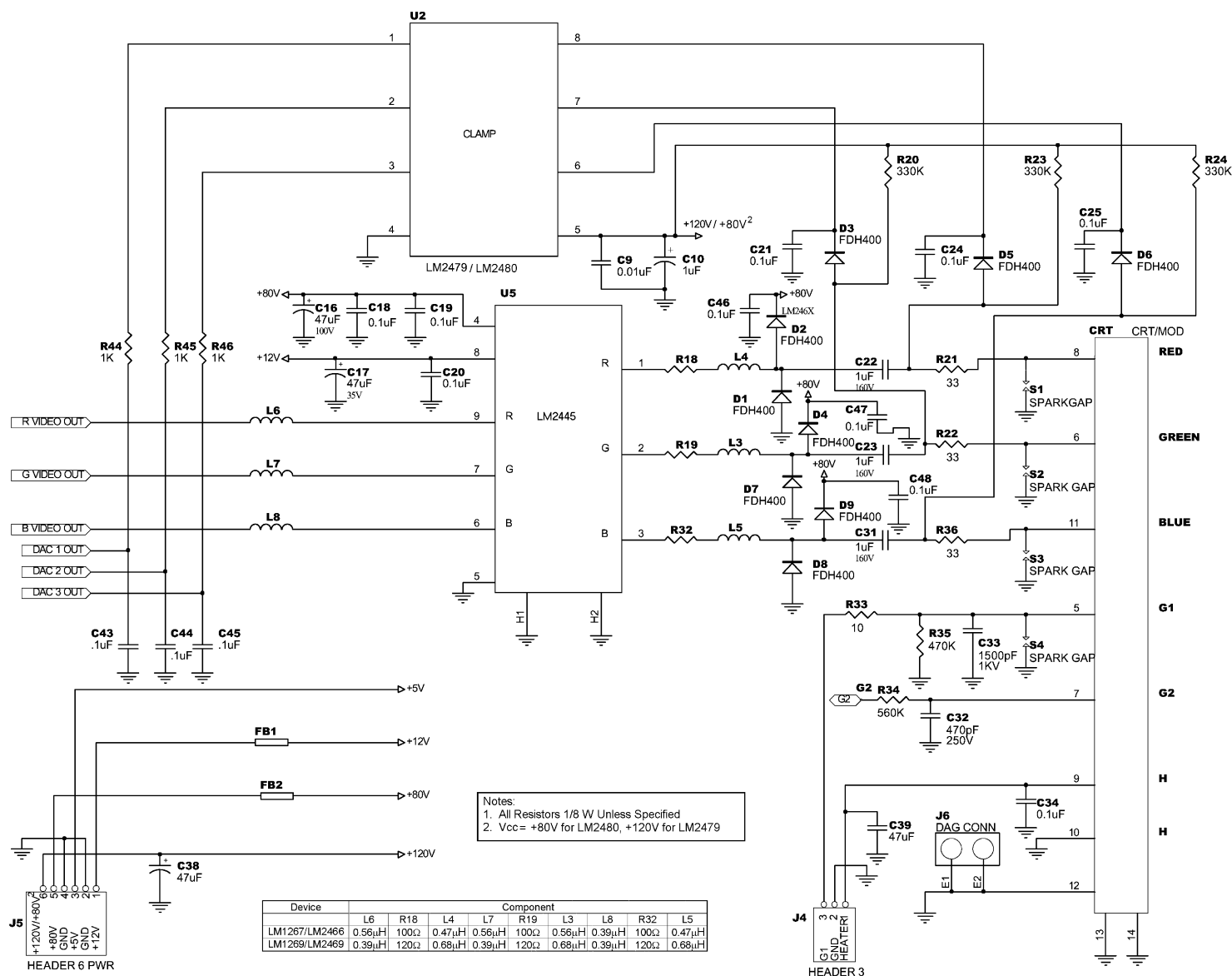


Figure 13. LM126X/LM246X Demonstration Board Schematic (continued)

A typical application of the LM2445 is shown in Figure 12 and Figure 13. Used in conjunction with an LM1267, a complete video channel from monitor input to CRT cathode can be achieved. Performance is ideal for 1024 x 768 resolution displays with pixel clock frequencies up to 95 MHz. Figure 12 and Figure 13 are the schematic for the TI demonstration board that can be used to evaluate the LM1267/2466 combination in a monitor, and Figure 11 shows the typical response at the red cathode for this application. The input video rise time is 3.2ns, and the peaking component values are those recommended in Figure 13. Table 1 shows the typical cathode response of all three channels.

## PC BOARD LAYOUT CONSIDERATIONS

For optimum performance, an adequate ground plane, isolation between channels, good supply bypassing and minimizing unwanted feedback are necessary. Also, the length of the signal traces from the preamplifier to the LM2445 and from the LM2445 to the CRT cathode should be as short as possible. The following references are recommended:

Because of its high small signal bandwidth, the part may oscillate in a monitor if feedback occurs around the video channel through the chassis wiring. To prevent this, leads to the video amplifier input circuit should be shielded, and input circuit wiring should be spaced as far as possible from output circuit wiring.

## TI DEMONSTRATION BOARD

[Figure 14](#) shows the routing and component placement on the TI LM1267/2466 demonstration board. The schematic of the board is shown in [Figure 12](#) and [Figure 13](#). This board provides a good example of a layout that can be used as a guide for future layouts. Note the location of the following components:

- C19— $V_{CC}$  bypass capacitor, located very close to pin 4 and ground pins
- C20— $V_{BB}$  bypass capacitors, located close to pin 8 and ground
- C46, C47, C48— $V_{CC}$  bypass capacitors, near LM2445 and  $V_{CC}$  clamp diodes. Very important for arc protection.

The routing of the LM2445 outputs to the CRT is very critical to achieving optimum performance. [Figure 15](#) shows the routing and component placement from pin 1 of the LM2445 to the blue cathode. Note that the components are placed so that they almost line up from the output pin of the LM2445 to the blue cathode pin of the CRT connector. This is done to minimize the length of the video path between these two components. Note also that D8, D9, R24 and D6 are placed to minimize the size of the video nodes that they are attached to. This minimizes parasitic capacitance in the video path and also enhances the effectiveness of the protection diodes. The anode of protection diode D8 is connected directly to a section of the the ground plane that has a short and direct path to the LM2445 ground pins. The cathode of D9 is connected to  $V_{CC}$  very close to decoupling capacitor C19 (see [Figure 15](#)) which is connected to the same section of the ground plane as D8. The diode placement and routing is very important for minimizing the voltage stress on the LM2445 during an arc-over event. Lastly, notice that S3 is placed very close to the blue cathode and is tied directly to CRT ground.

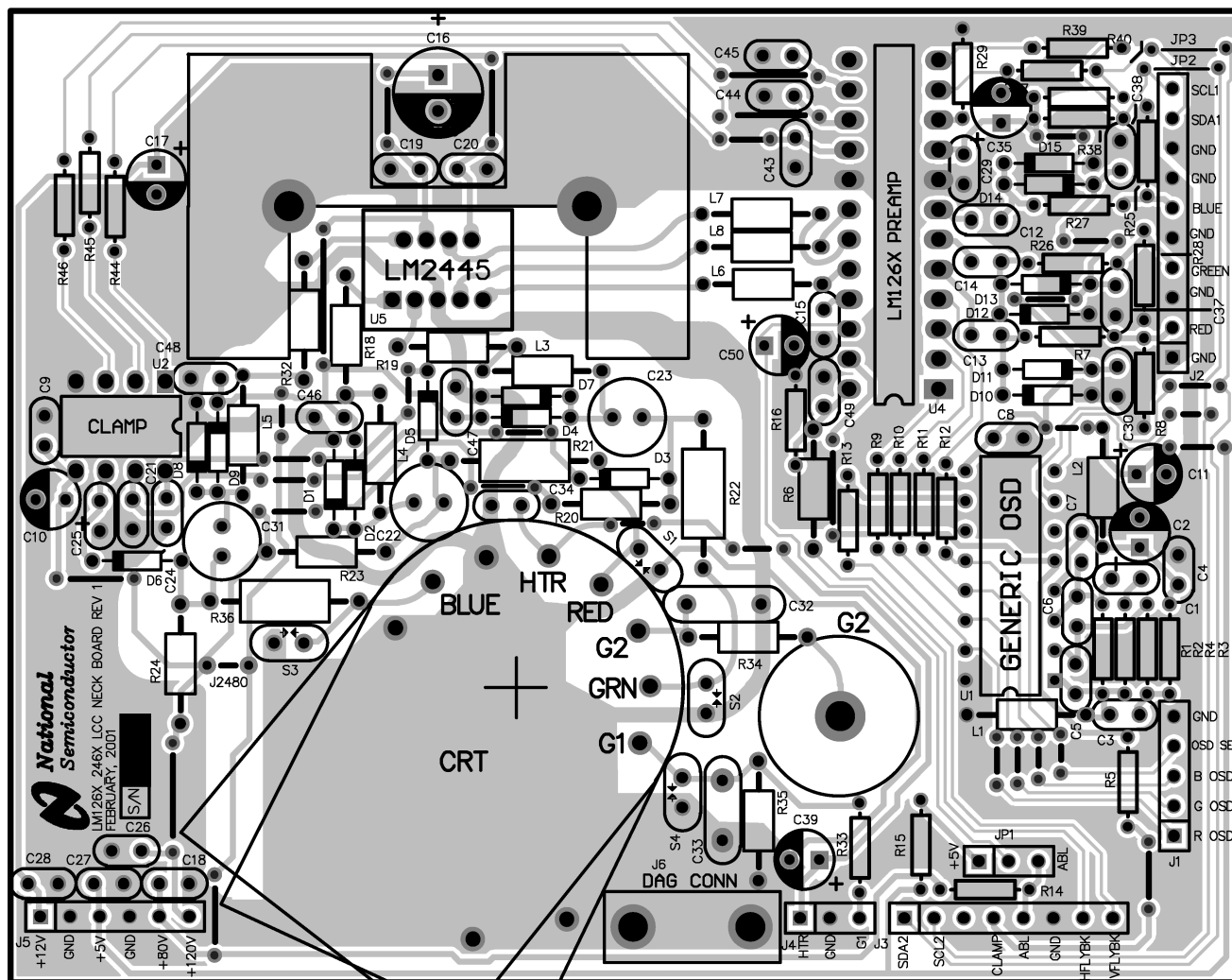


Figure 14. LM126X/LM246X Demo Board Layout

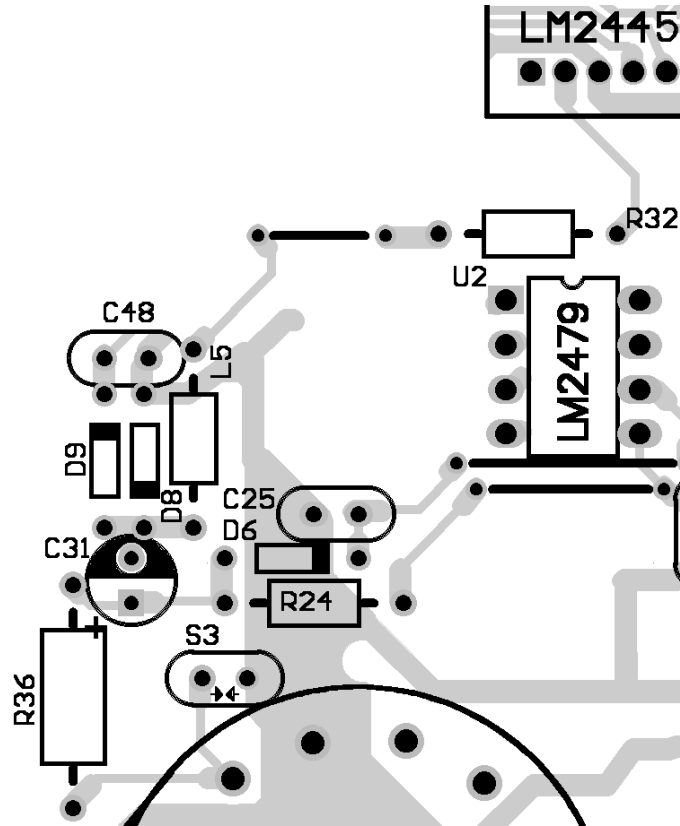


Figure 15. Trace Routing and Component Placement for Blue Channel Output
