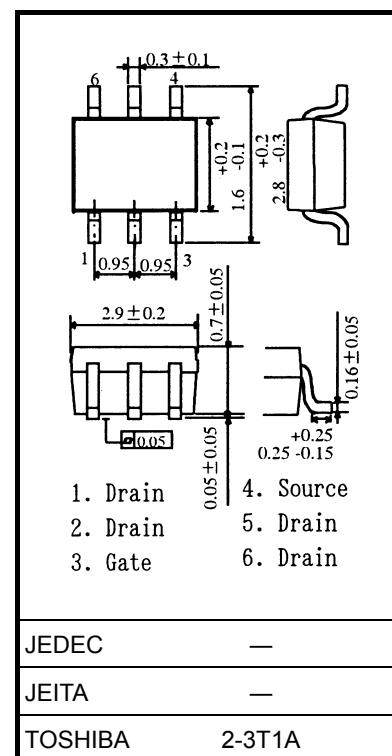

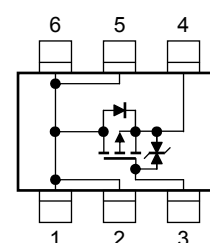

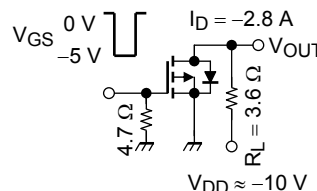

Circuit Configuration



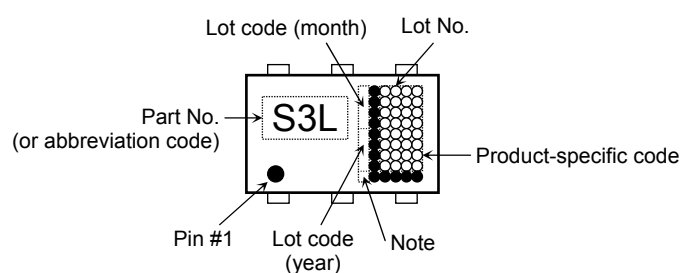
