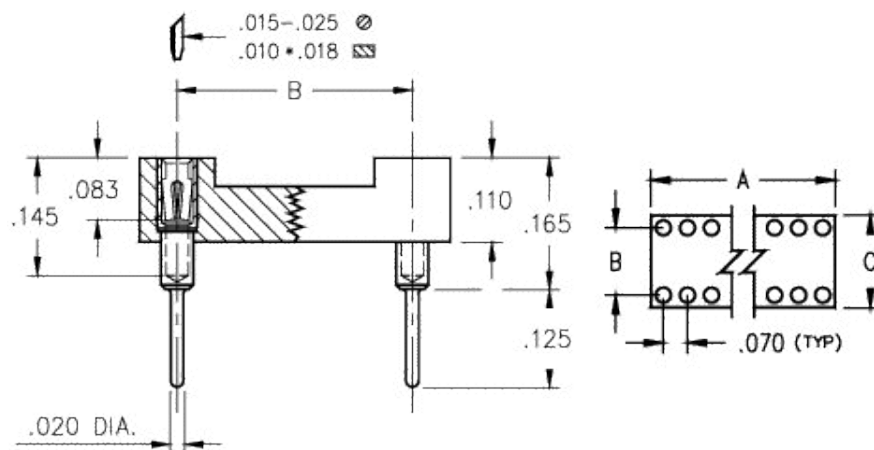

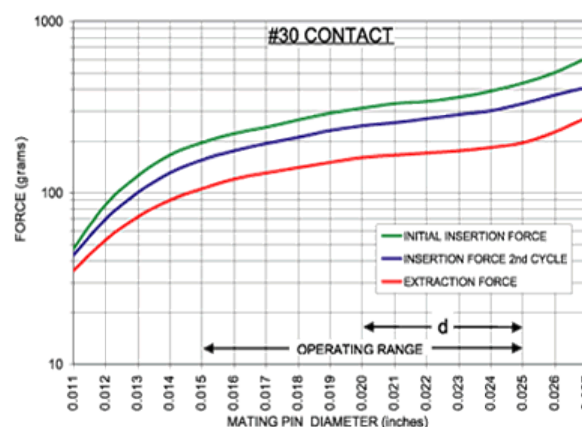

Properties of BERYLLIUM COPPER:
