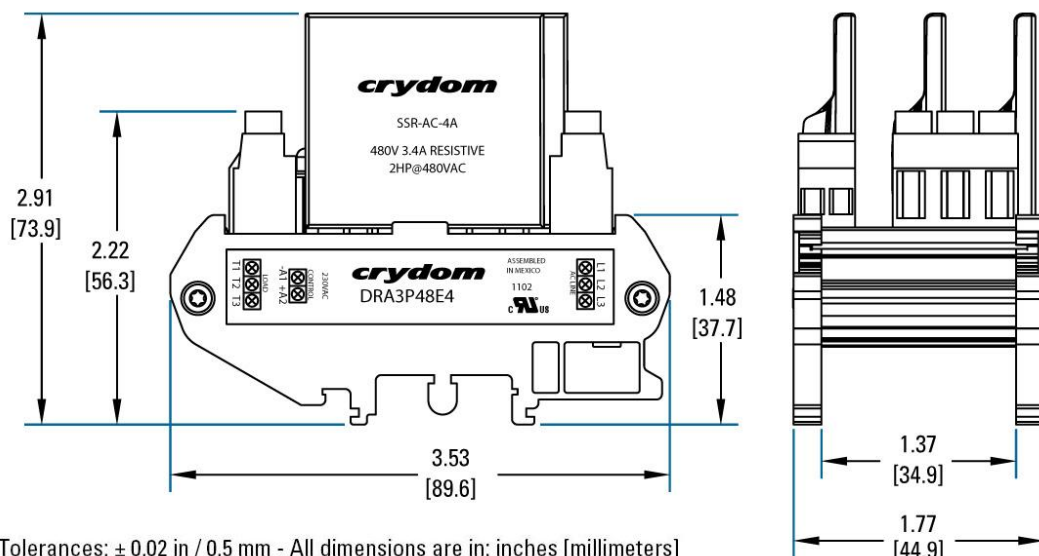

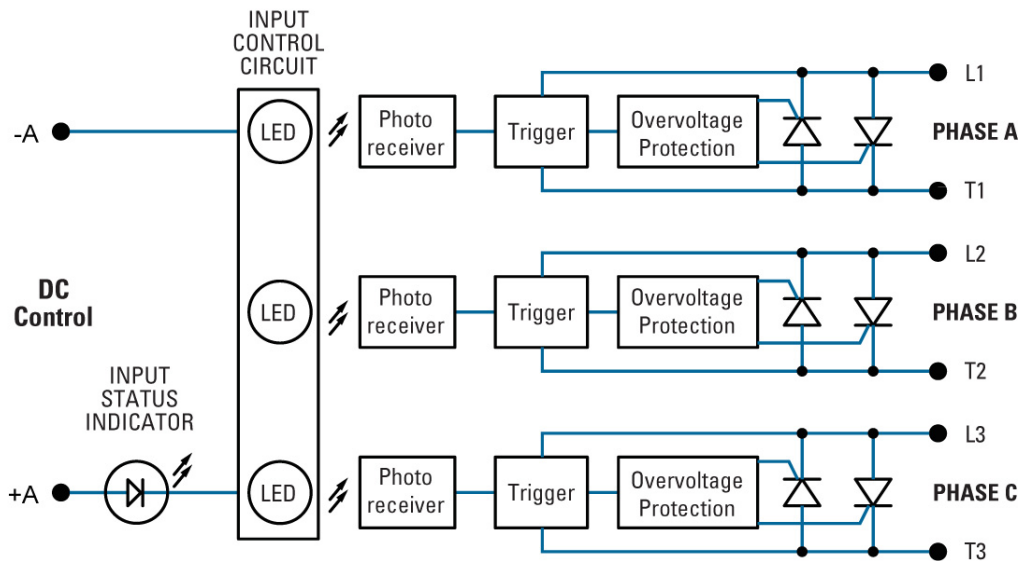

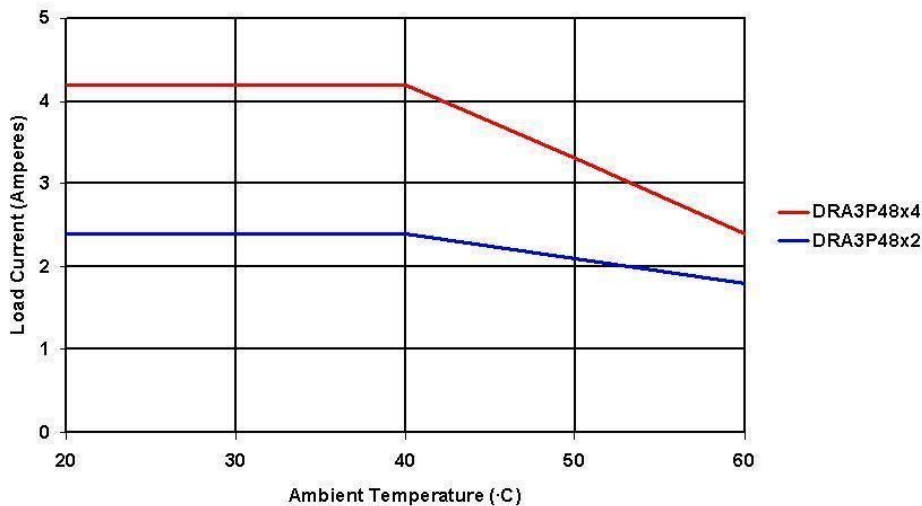


WIRING DIAGRAM
