Derating Curve:

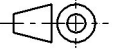

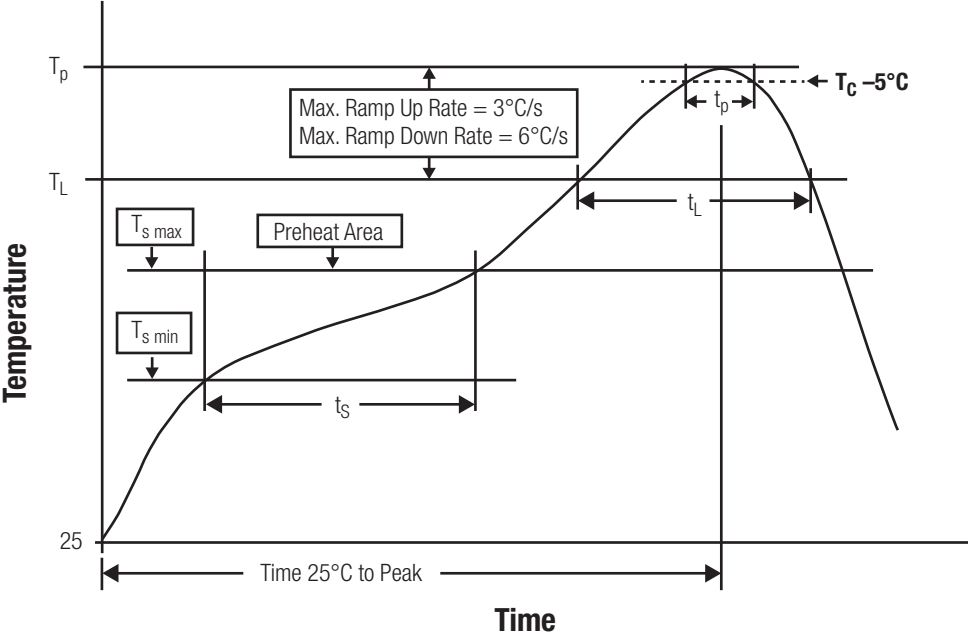
