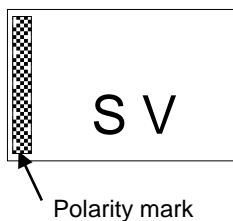

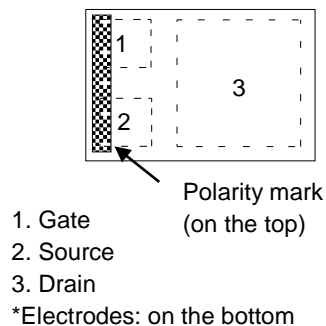

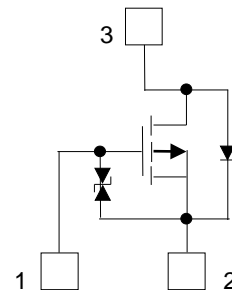
### Marking (top view)

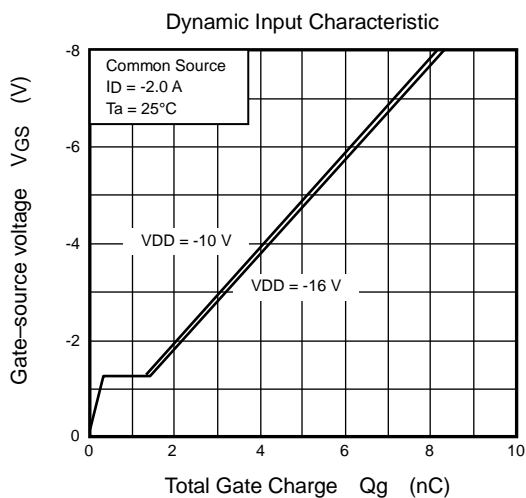
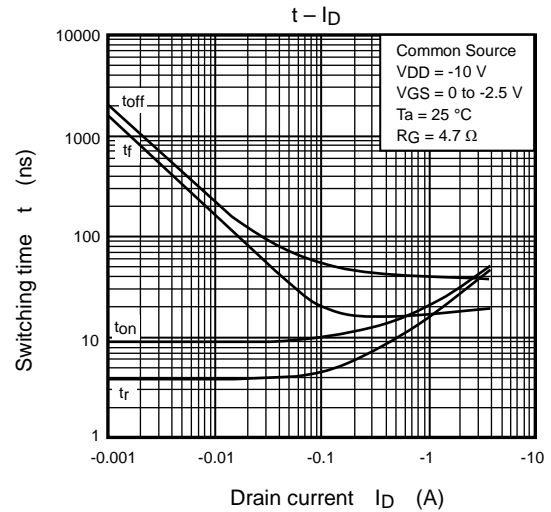
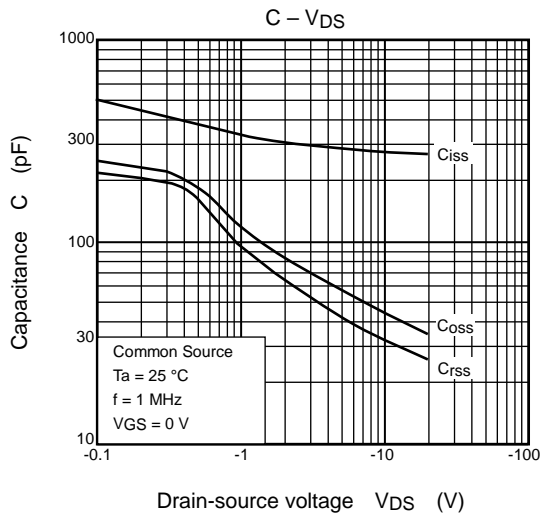
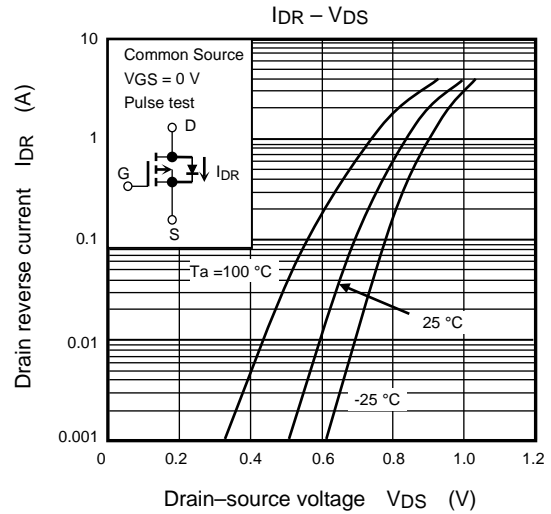
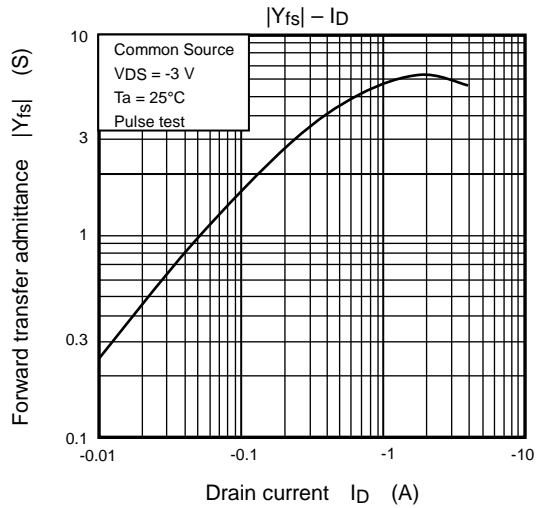
V<sub>th</sub> can be expressed as the voltage between gate and source when the low operating current value is I<sub>D</sub> = -1 mA for this product. For normal switching operation, V<sub>GS</sub> (on) requires a higher voltage than V<sub>th</sub> and V<sub>GS</sub> (off) requires a lower voltage than V<sub>th</sub>. (The relationship can be established as follows: V<sub>GS</sub> (off) < V<sub>th</sub> < V<sub>GS</sub> (on).)

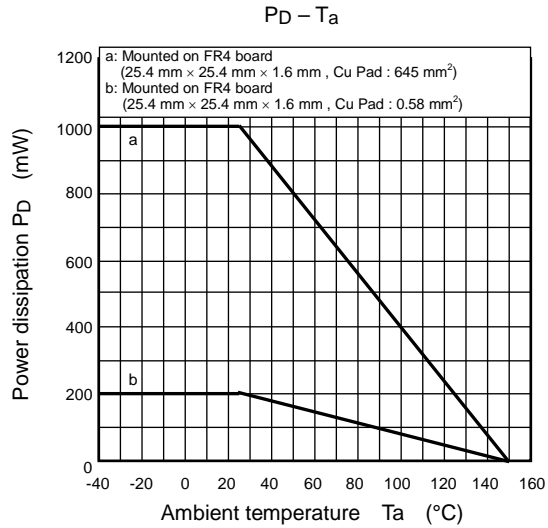
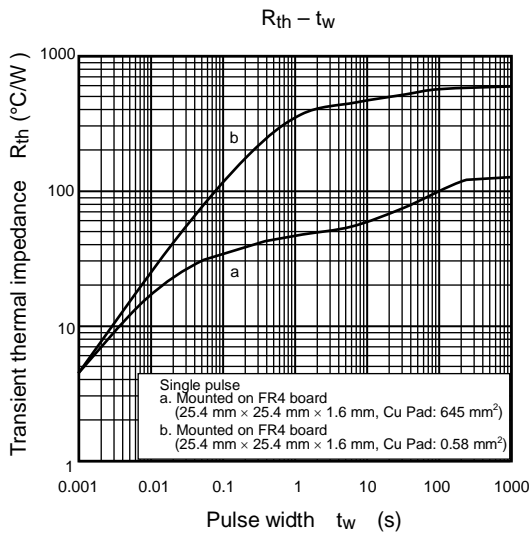
