

# Cree® XLamp® CXA1830 LED



## PRODUCT DESCRIPTION

The XLamp® CXA1830 LED array expands Cree's family of high-flux, multi-die arrays in a smaller, easy-to-use platform. With XLamp LED lighting-class reliability, the CXA1830's small, uniform emitting surface enables both directional and non-directional lighting applications including lamp retrofit and luminaire designs. Available in 2-step and 4-step color consistency, and featuring a 14-mm optical source, the CXA1830 brings new levels of flux and efficacy to this form factor.









## RELATIVE LUMINOUS FLUX

The relative luminous flux values provided below are the ratio of:

- Measurements of CXA1830 at steady-state operation at the given conditions, divided by
- Flux measured during binning, which is a pulsed measurement at 800 mA at  $T_j = 85^\circ\text{C}$ .

For example, at steady-state operation of  $T_c = 55^\circ\text{C}$ ,  $I_F = 1000$  mA, the relative luminous flux ratio is 120% in the chart below. A CXA1830 LED that measures 2100 lm during binning will deliver 2340 lm ( $2100 * 1.2$ ) at steady-state operation of  $T_c = 55^\circ\text{C}$ ,  $I_F = 1000$  mA.





## Thermal Design

The CXA family of LED arrays can include over a hundred different LED die inside one package, and thus over a hundred different junction temperatures ( $T_j$ ). Cree has intentionally removed junction-temperature-based operating limits and replaced the commonplace maximum  $T_j$  calculations with maximum ratings based on forward current ( $I_F$ ) and case temperature ( $T_c$ ). No additional calculations are required to ensure the CXA LED is being operated within its designed limits. Please refer to page 2 for the Operating Limit specification.

Cree has measured the temperature at the bottom of the package, commonly referred to as the solder point ( $T_{sp}$ ), and found this value to be equivalent to the temperature at the  $T_c$  location at the top of the package once the LED has reached thermal equilibrium. There is no need to calculate for  $T_j$  inside the package, as the thermal management design process, specifically from  $T_{sp}$  to ambient ( $T_a$ ), remains identical to any other LED component. For more information on thermal management of Cree XLamp LEDs, please refer to the [Thermal Management application note](#). For CXA soldering recommendations and more information on thermal interface materials (TIM) and connection methods, please refer to the [Cree XLamp CXA Family LEDs soldering and handling document](#). The [CXA LED Design Guide](#) provides basic information on the requirements to use Cree XLamp CXA LEDs successfully in luminaire designs.

To keep the CXA1830 LED at or below the maximum rated  $T_c$ , the case to ambient temperature thermal resistance ( $R_{c-a}$ ) must be at or below the maximum  $R_{c-a}$  value shown on the following graph, depending on the operating environment. The y-axis in the graph is a base 10 logarithmic scale.

As the figure at right shows, the  $R_{c-a}$  value is the sum of the thermal resistance of the TIM ( $R_{tim}$ ) plus the thermal resistance of the heat sink ( $R_{hs}$ ).

## PACKAGING

Cree CXA1830 LEDs are packaged in trays of 20. Five trays are sealed in an anti-static bag and placed inside a carton, for a total of 100 LEDs per carton. Each carton contains 100 LEDs from the same performance bin.
