C Schematic:



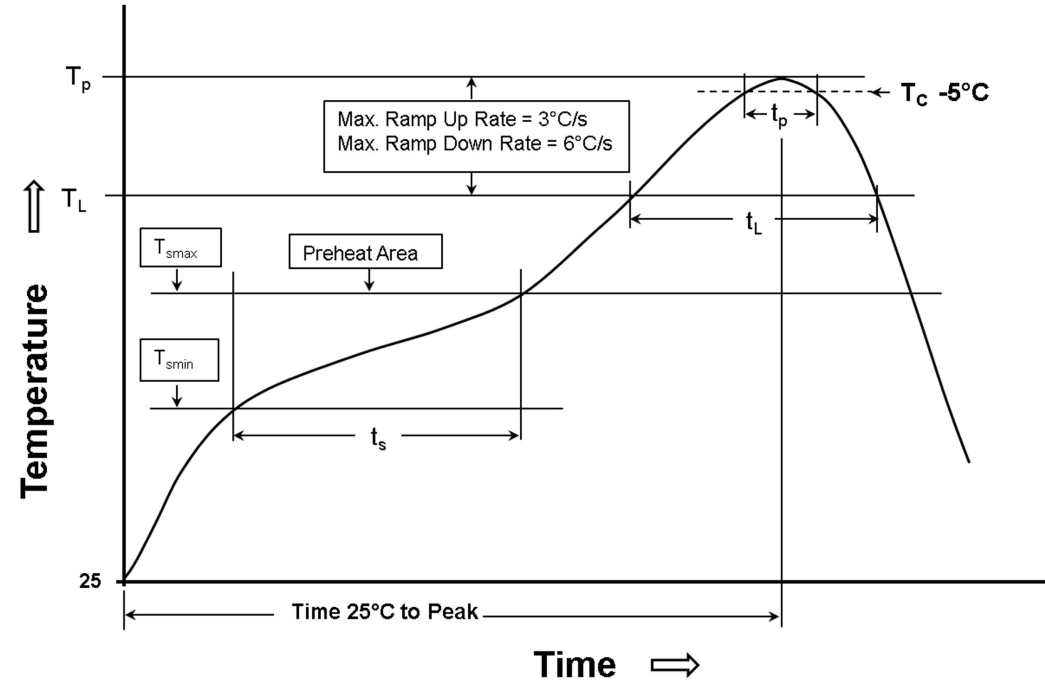
