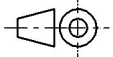
Typical Impedance Characteristics:



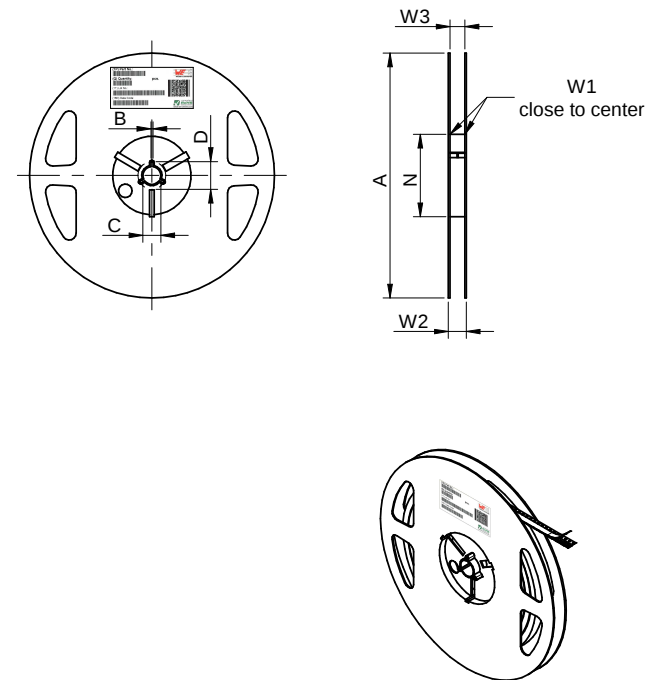
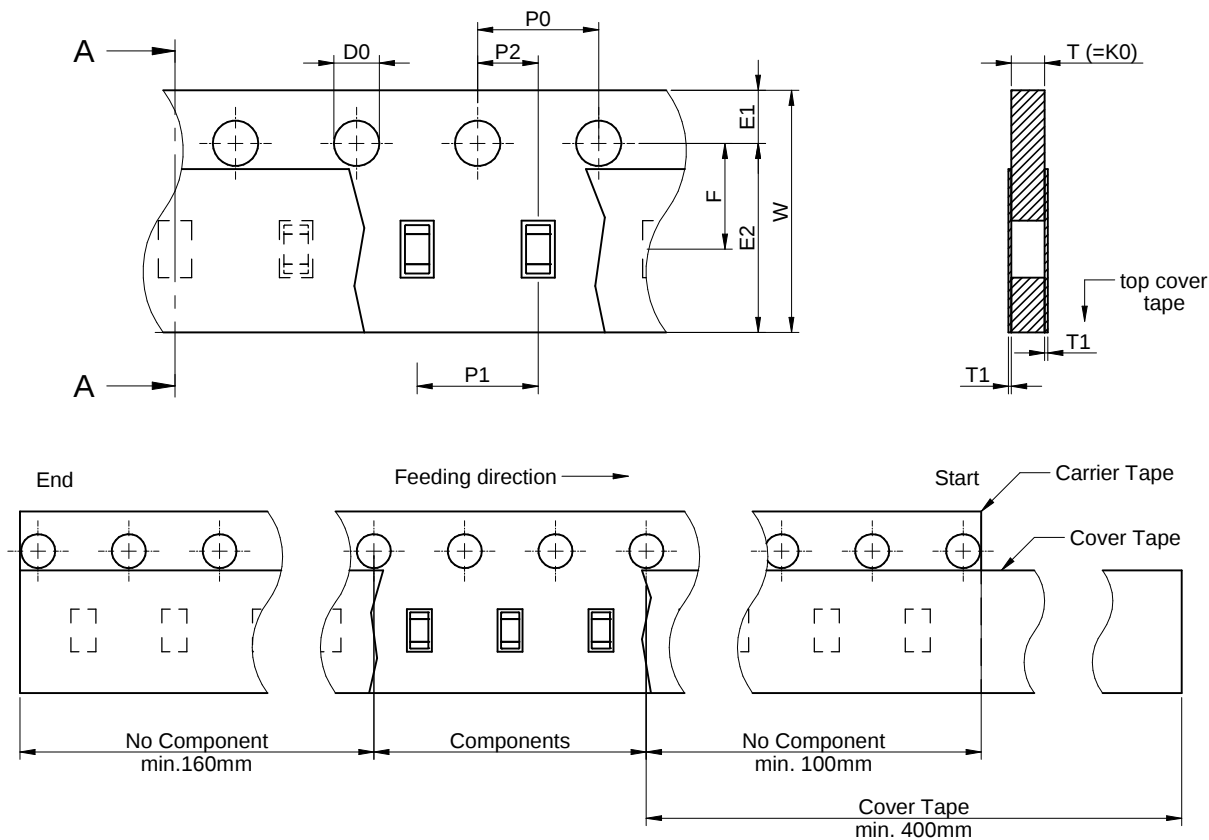
