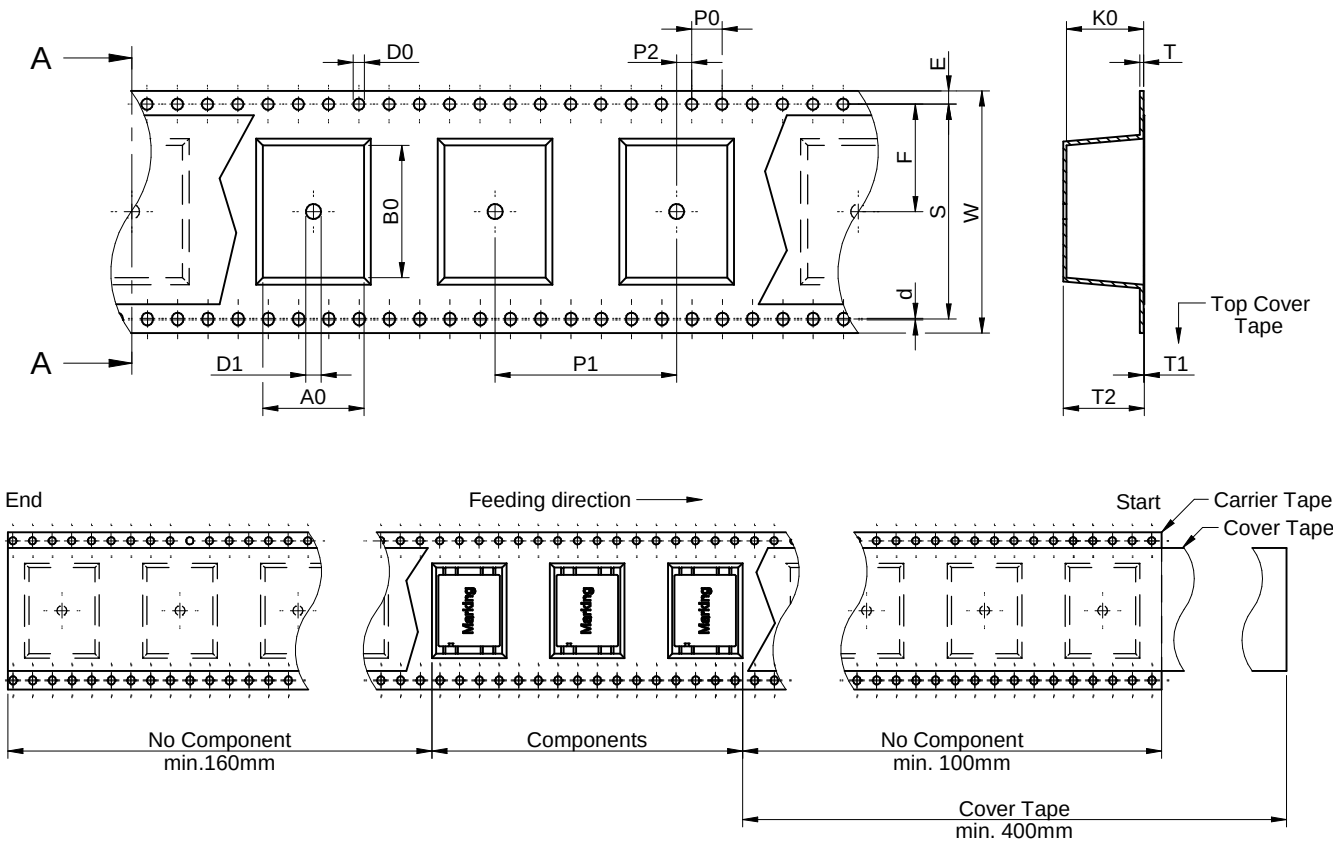
Typical Impedance Characteristics:
