## 1 General description

---

The 74LVC2G04 provides the dual inverting buffer.

Inputs can be driven from either 3.3 V or 5 V devices. These features allow the use of these devices in a mixed 3.3 V and 5 V environment.

This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.




Figure 1. Logic symbol




Figure 2. IEC logic symbol




Figure 3. Logic diagram (one gate)

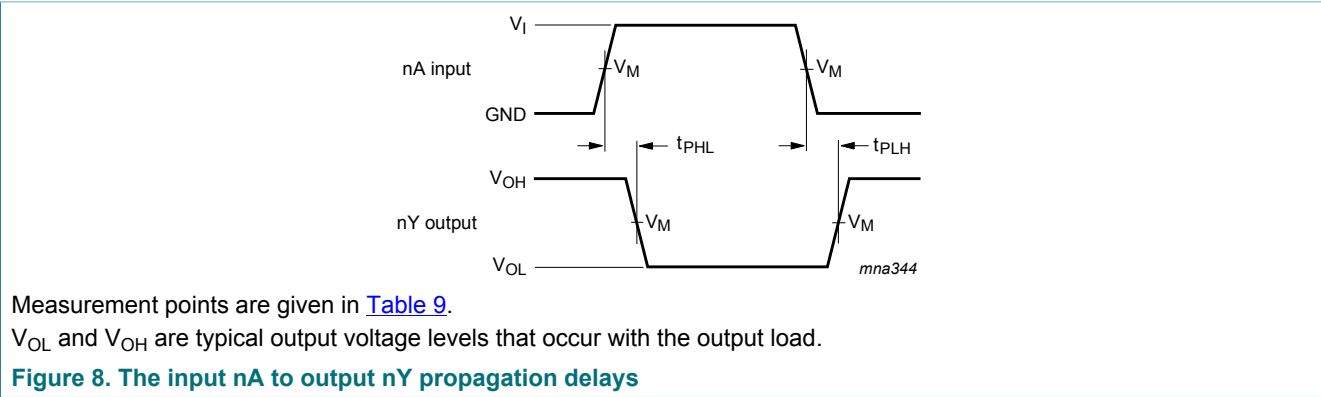
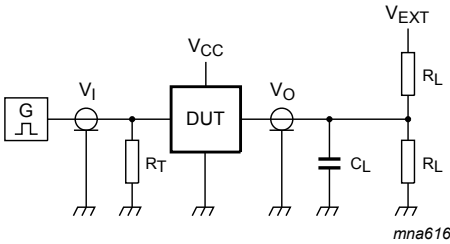

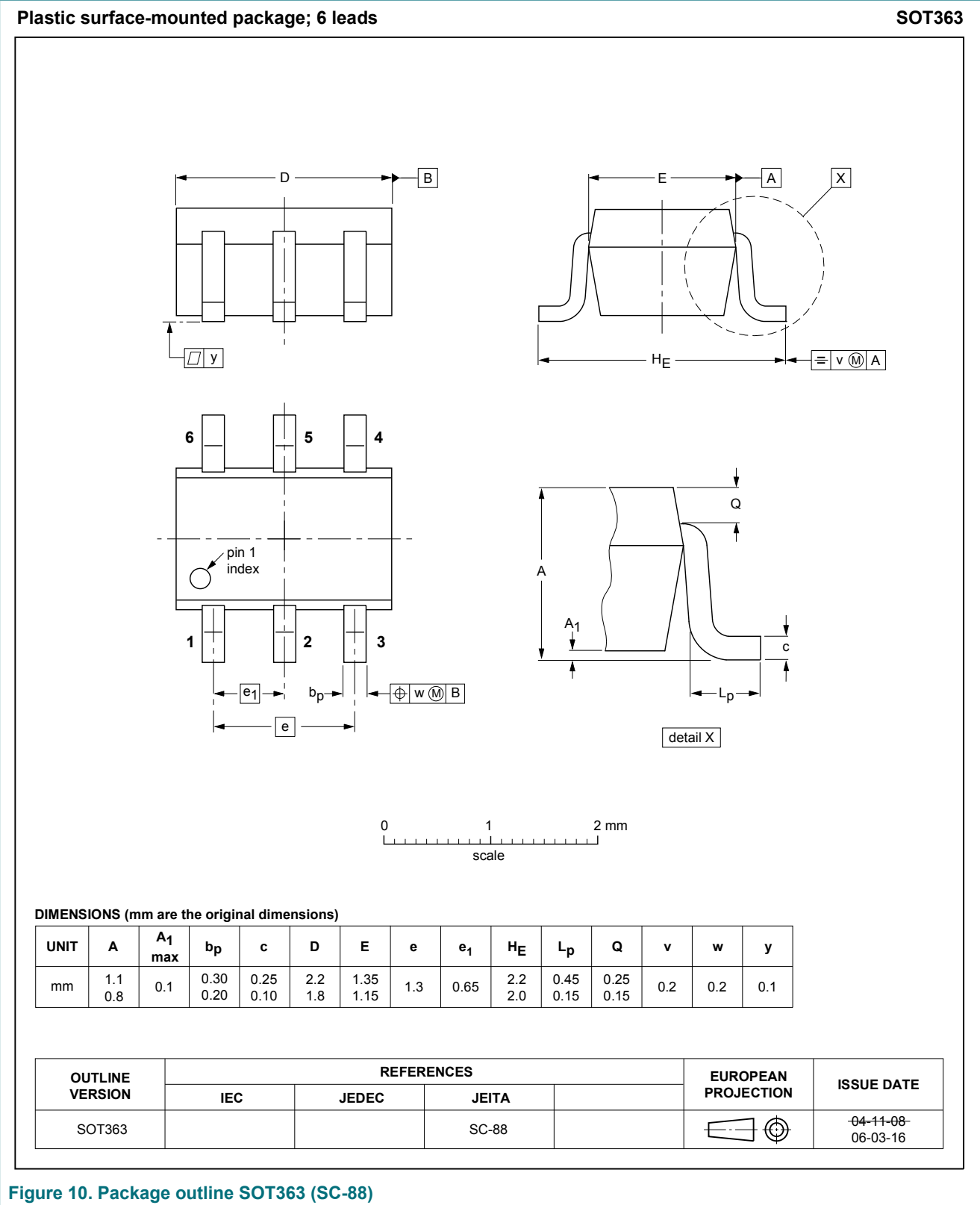
Figure 9. Test circuit for measuring switching times

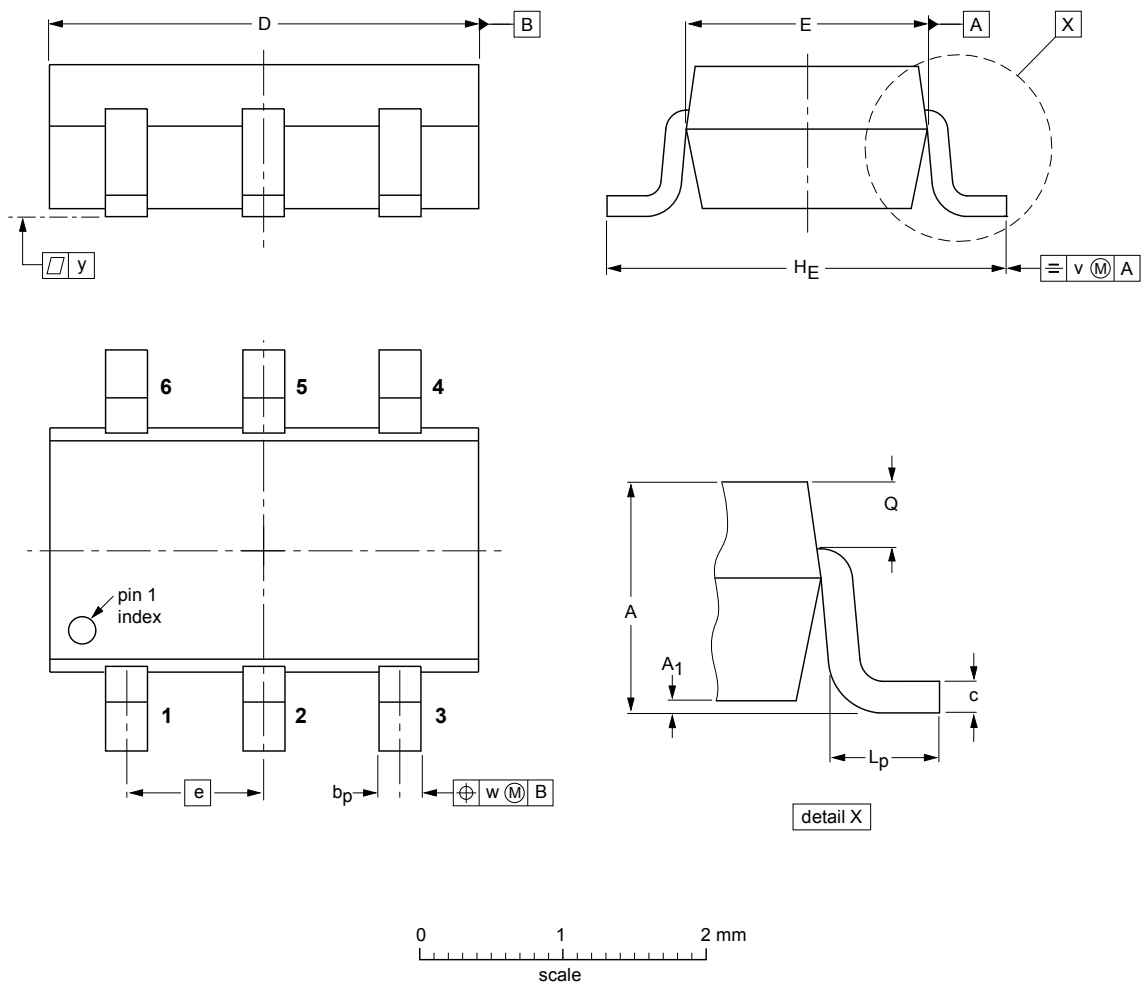



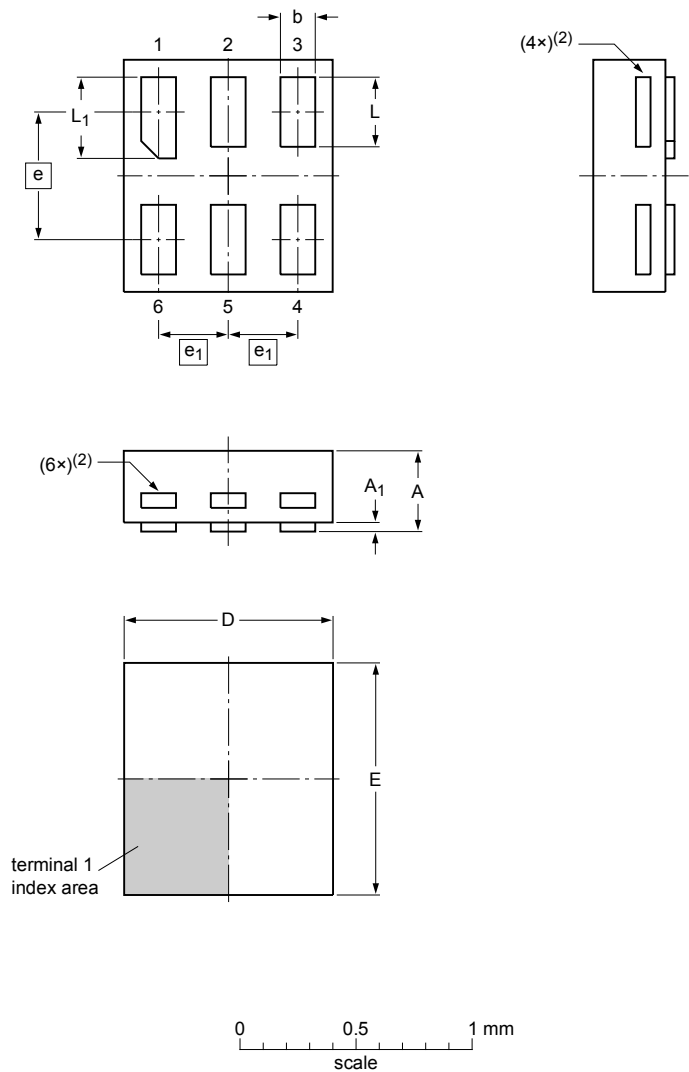





Figure 15. Package outline SOT1202 (XSON6)

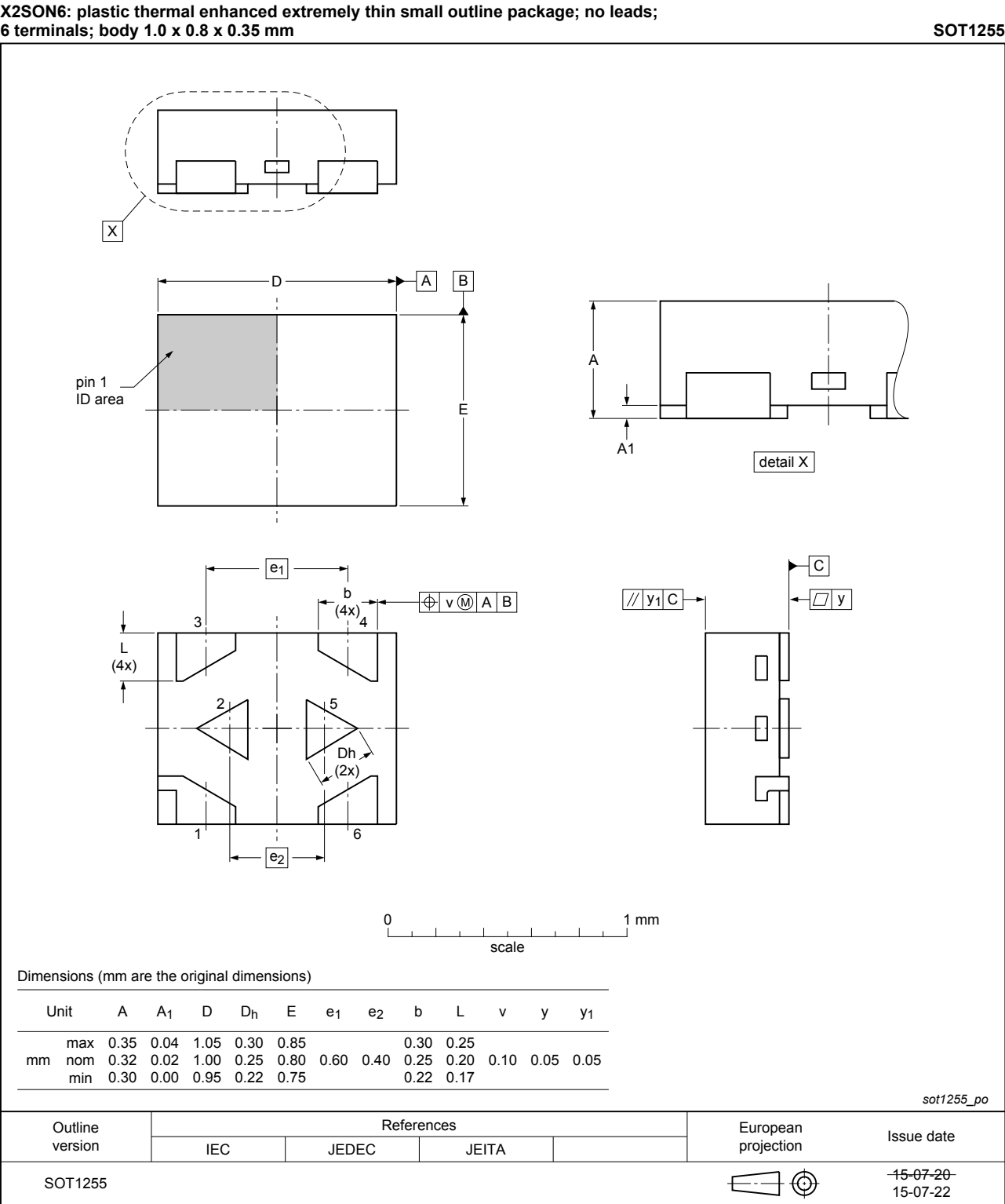


Figure 16. Package outline SOT1255 (X2SON6)
