1. General description

ESD protection device in a small SOD323 (SC-76) Surface-Mounted Device (SMD) plastic package designed to protect automotive In-vehicle network bus lines from the damage caused by ElectroStatic discharge (ESD) and other transients.

- Low clamping voltage: $V_{CL} = 33\text{ V}$ at $I_{PP} = 3.5\text{ A}$
- ESD protection up to 30 kV (IEC 61000-4-2)

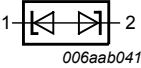

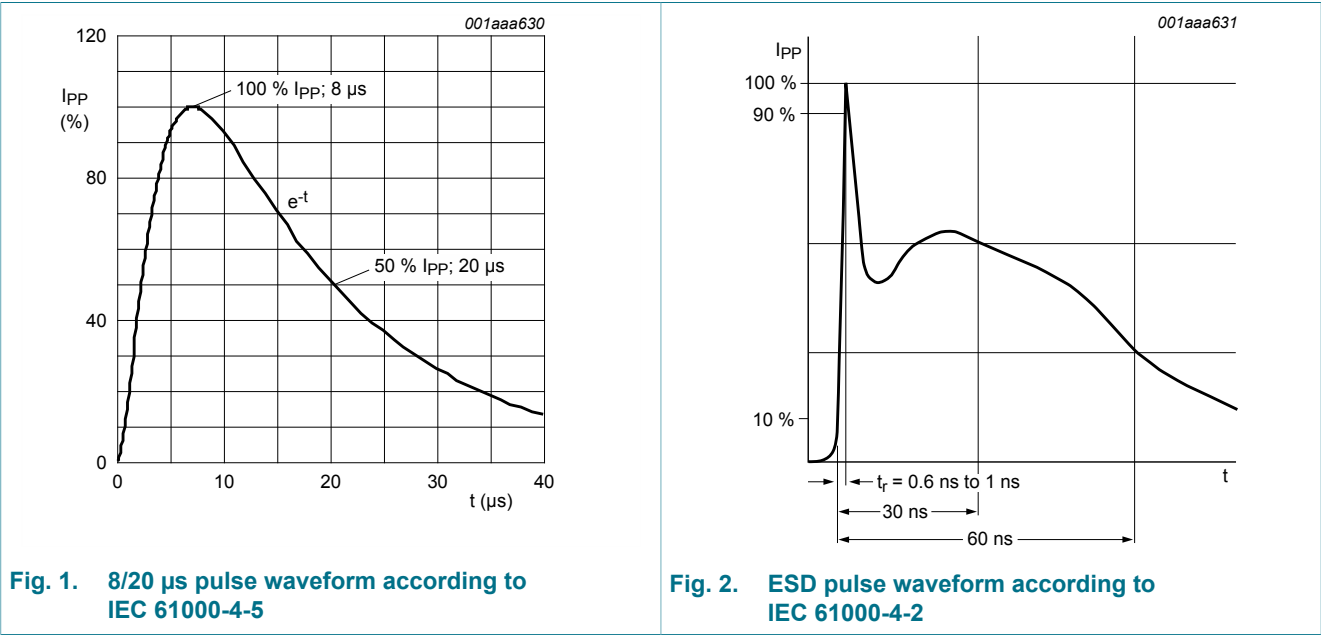

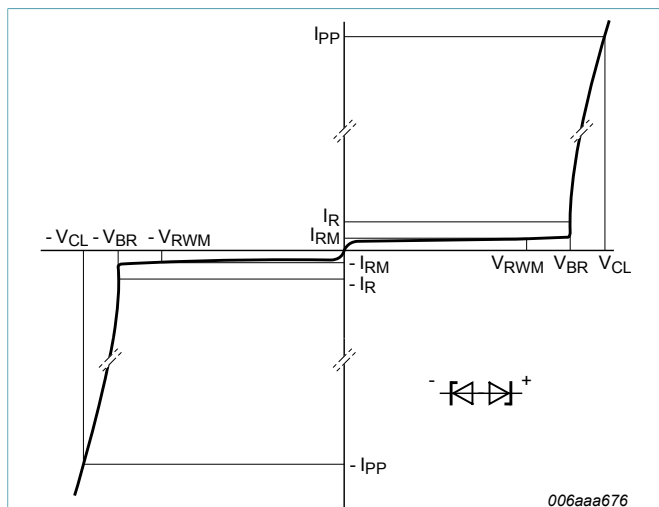


Fig. 3. V-I characteristics for a bidirectional ESD protection diode

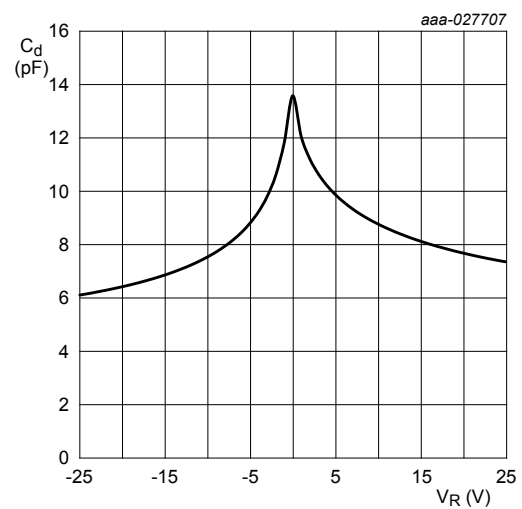


Fig. 4. Diode capacitance as a function of reverse voltage, typical values

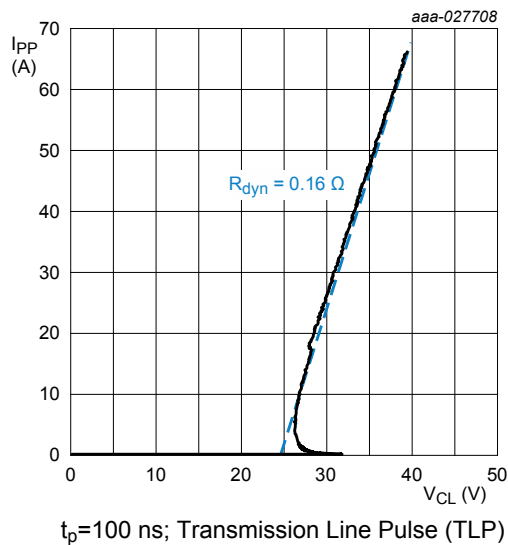


Fig. 5. Positive clamping voltage (TLP); typical values

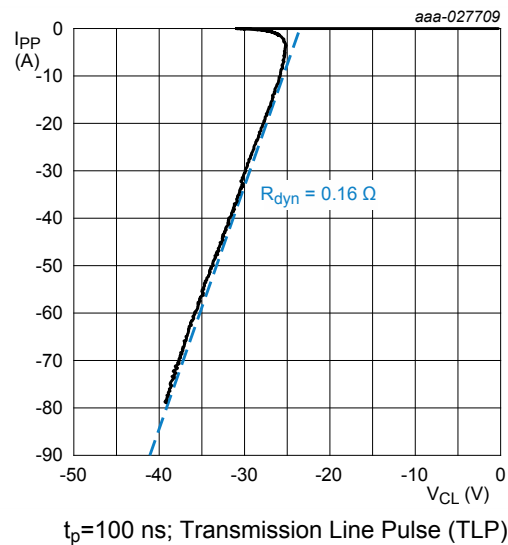


Fig. 6. Negative clamping voltage (TLP); typical values

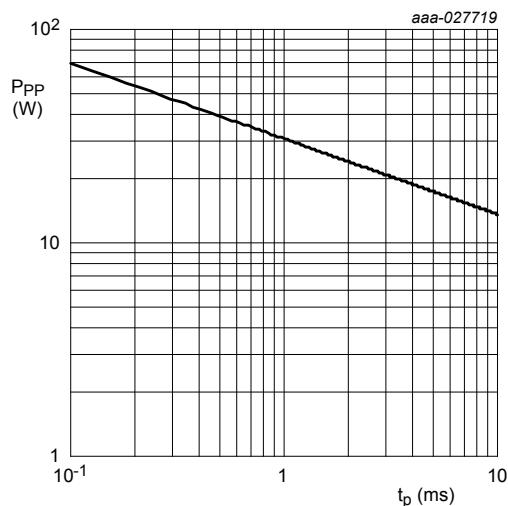


Fig. 7. Peak pulse power as a function of exponential pulse duration; typical values

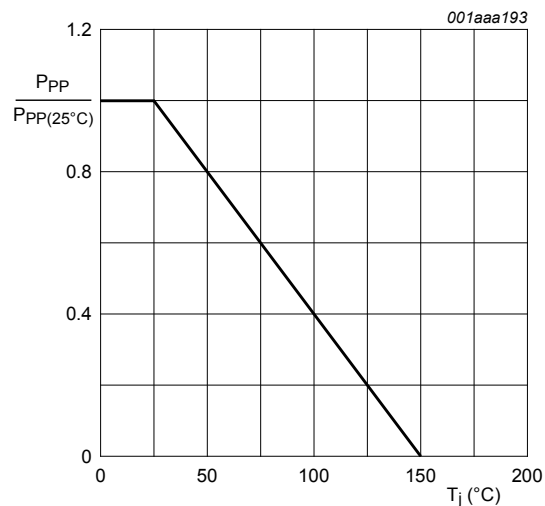


Fig. 8. Relative variation of peak pulse power as a function of junction temperature; typical values

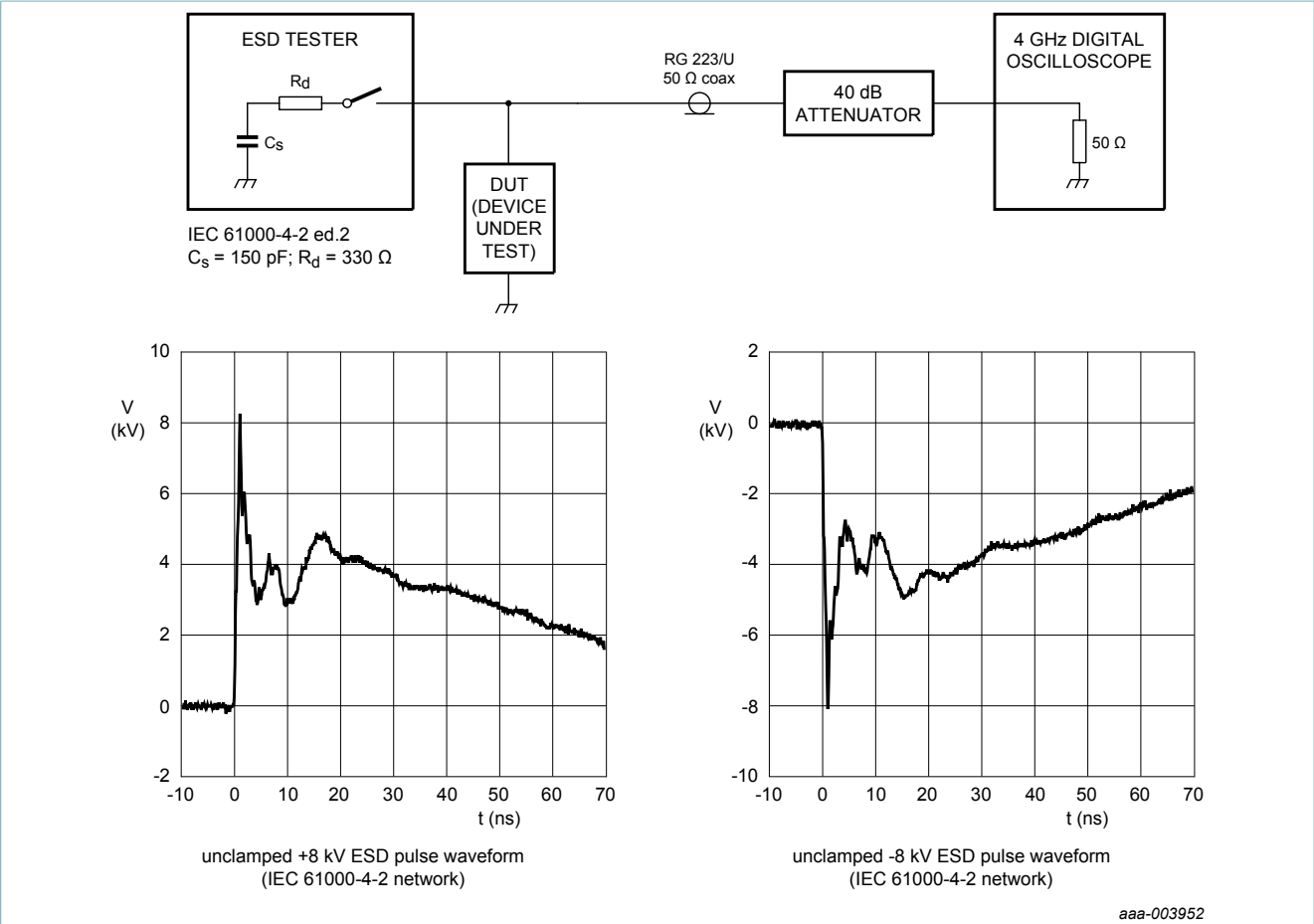


Fig. 9. ESD clamping test setup and waveforms

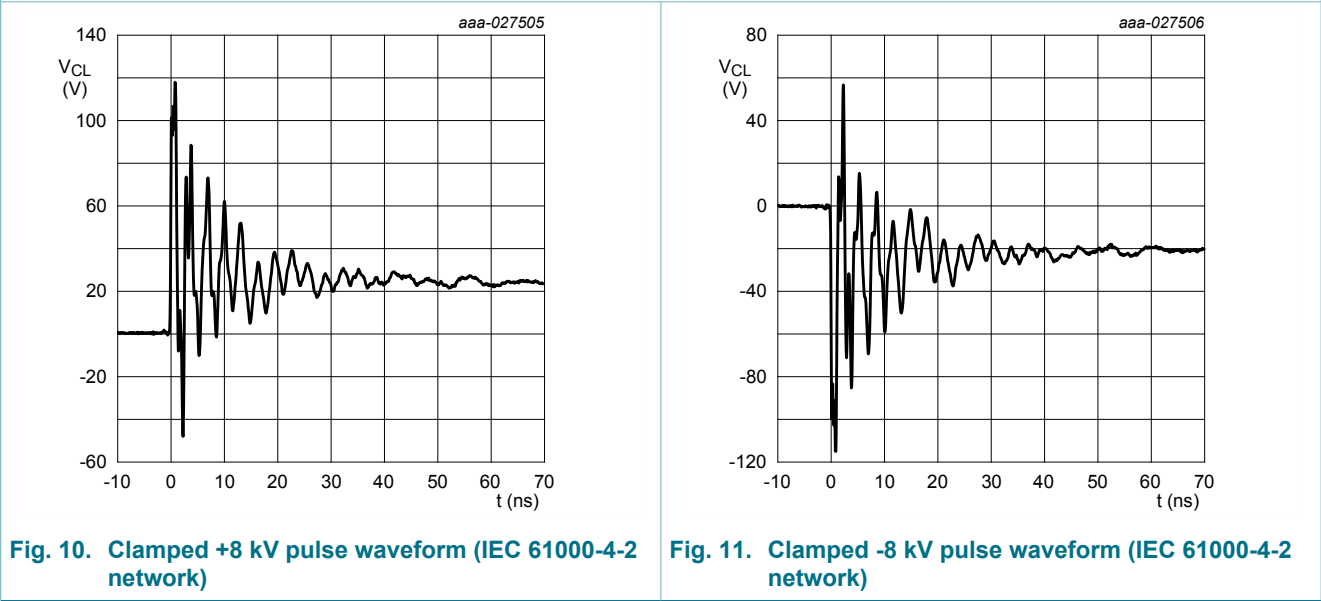


Fig. 10. Clamped +8 kV pulse waveform (IEC 61000-4-2 network)

The PESD1IVN24-A is designed for the protection of one automotive IVN bus line from the damage caused by ESD and surge pulses.

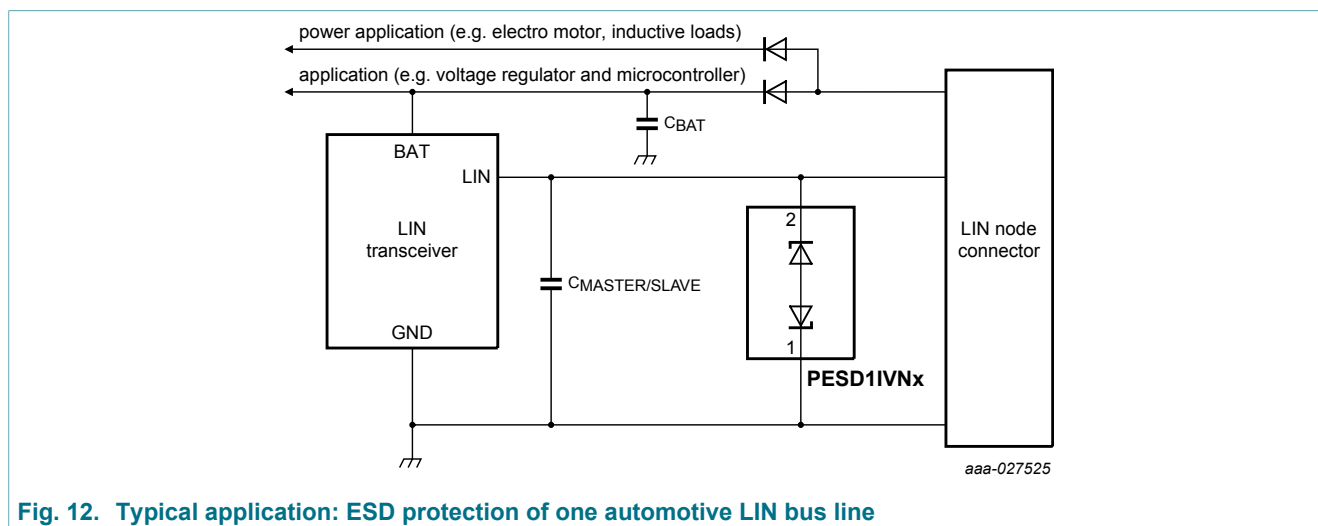


Fig. 12. Typical application: ESD protection of one automotive LIN bus line

Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

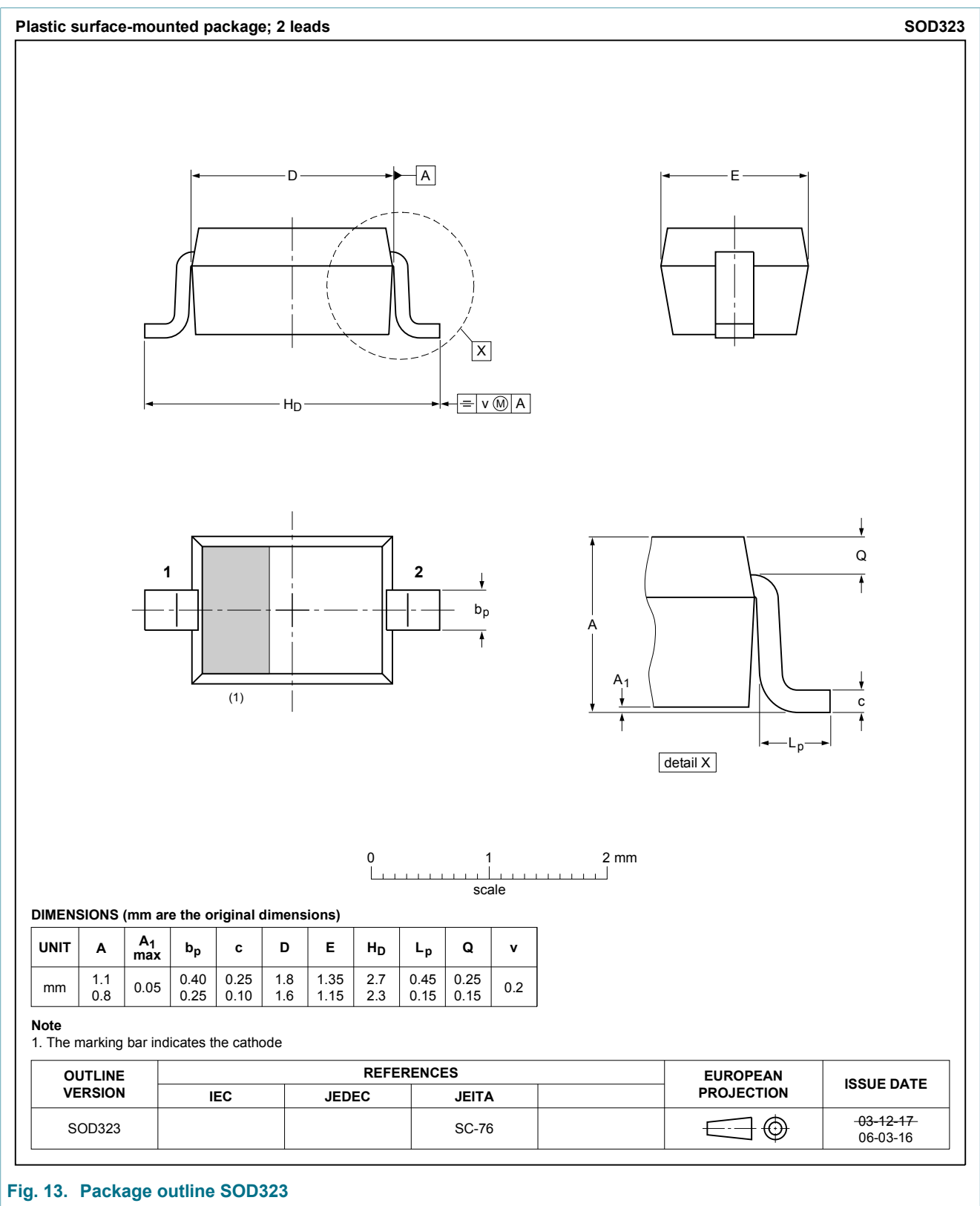
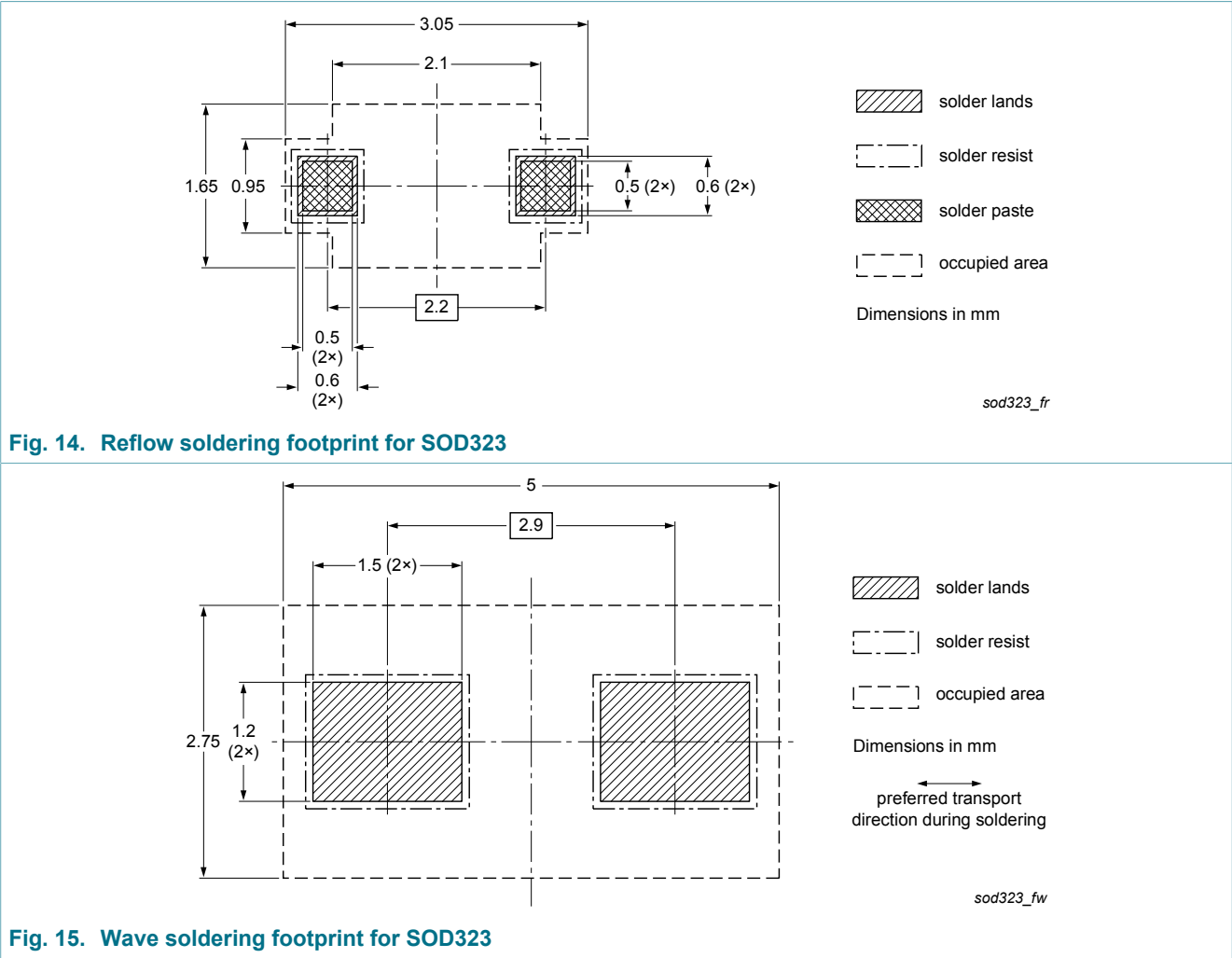


Fig. 13. Package outline SOD323
