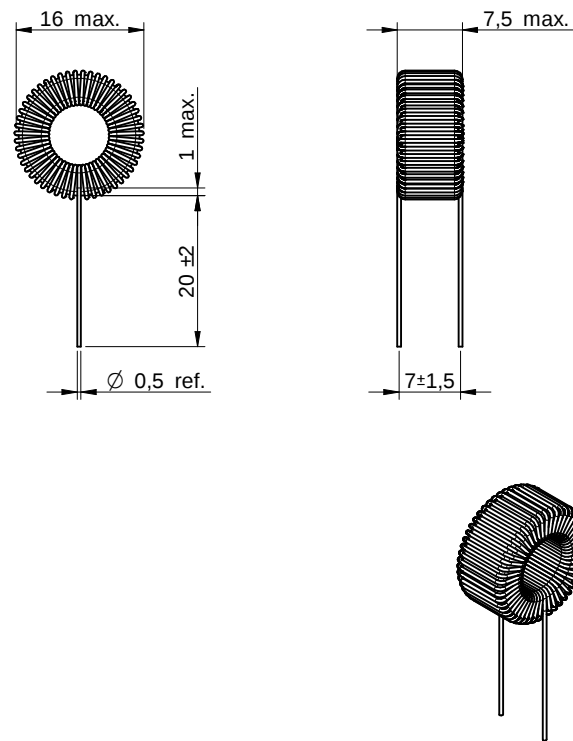

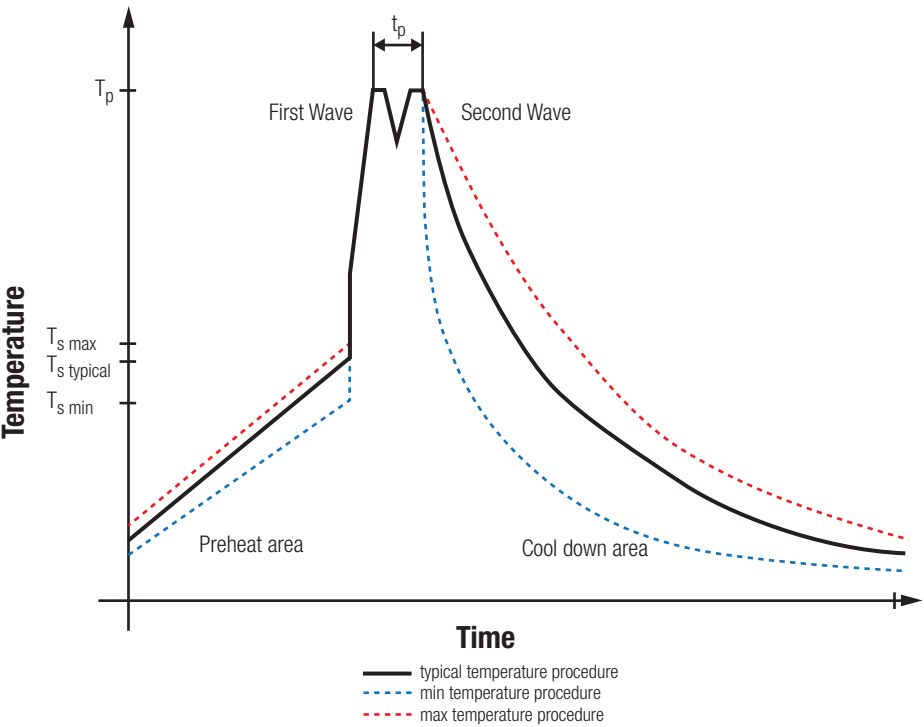
Typical Impedance Characteristics:

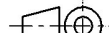

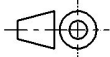
Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

Product specific:

- The solder profile has to be complied with according to the technical wave soldering specification, otherwise this will void the warranty.
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.

6. Product Life Cycle

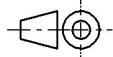
