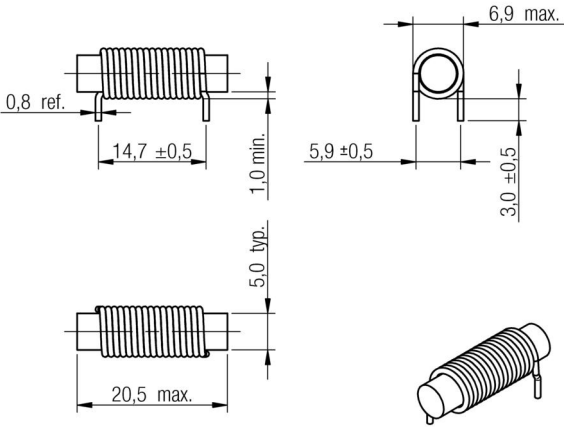

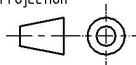
Product specific:

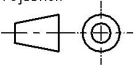
