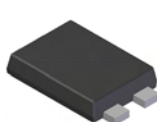

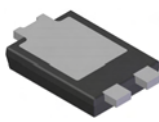

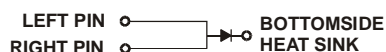

Bottom View



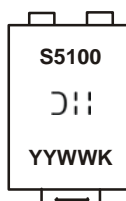
