1. General description

The 74AHC2G125; 74AHCT2G125 is a dual buffer/line driver with 3-state outputs controlled by the output enable inputs ($\overline{\text{OE}}$). Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.

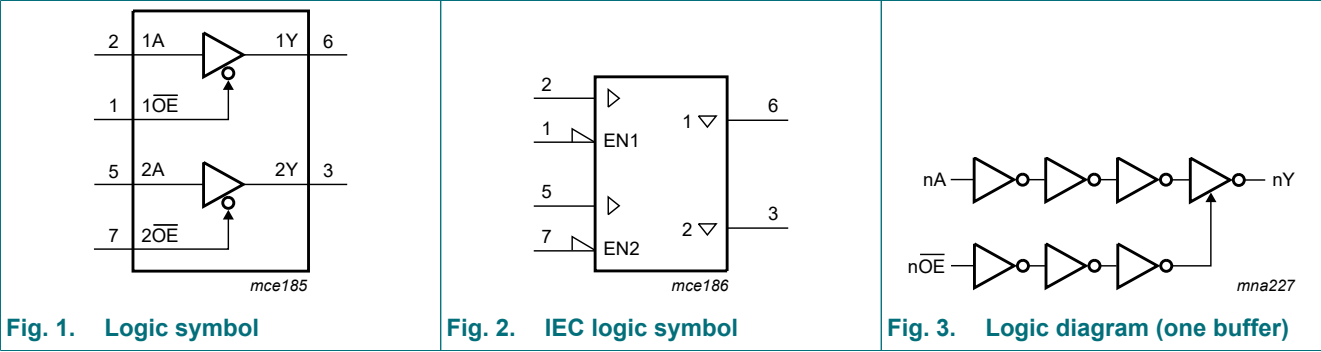

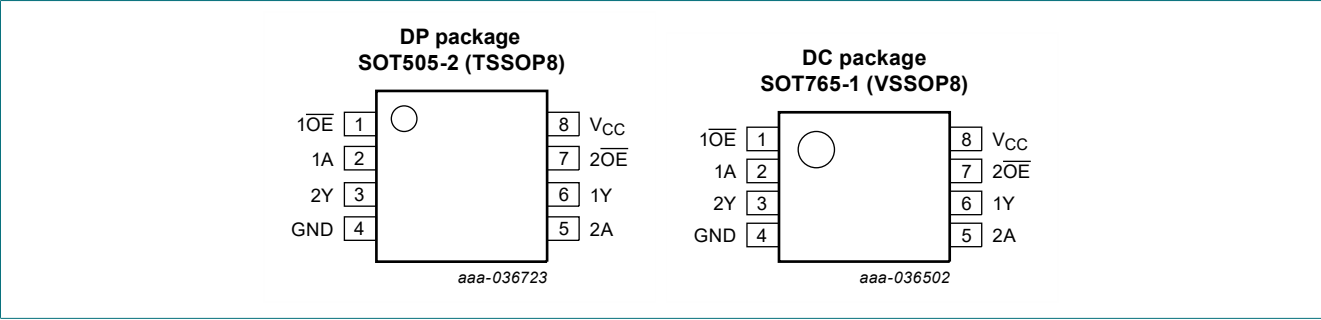

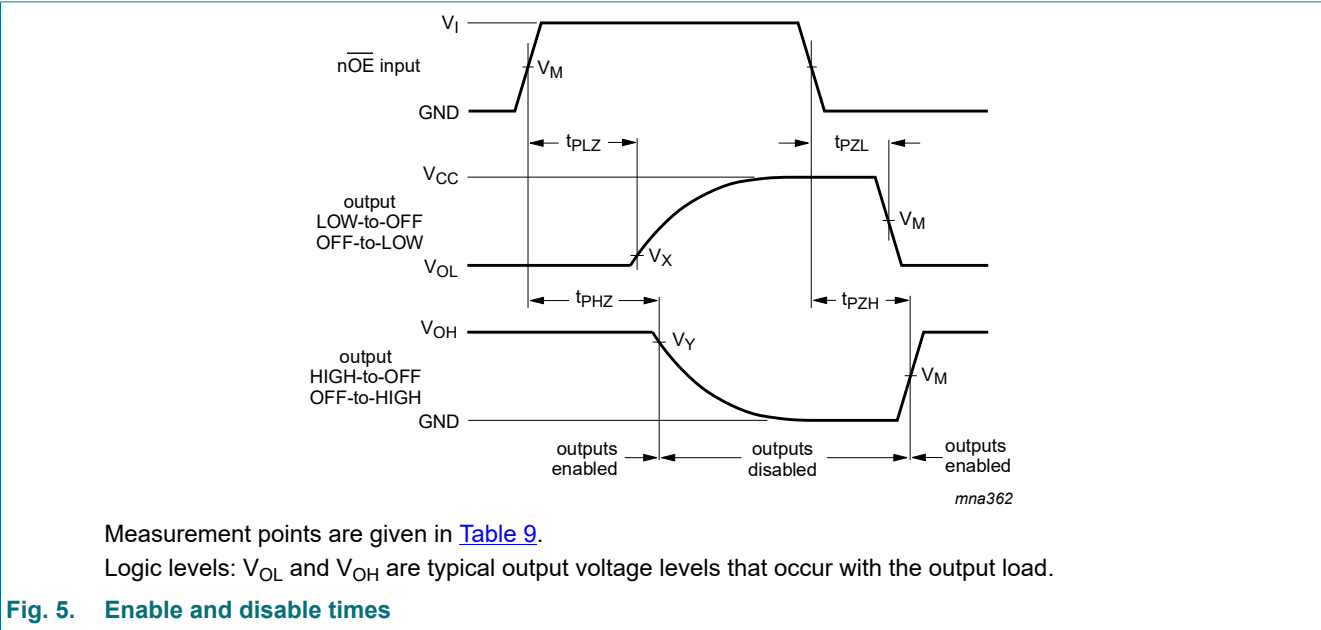
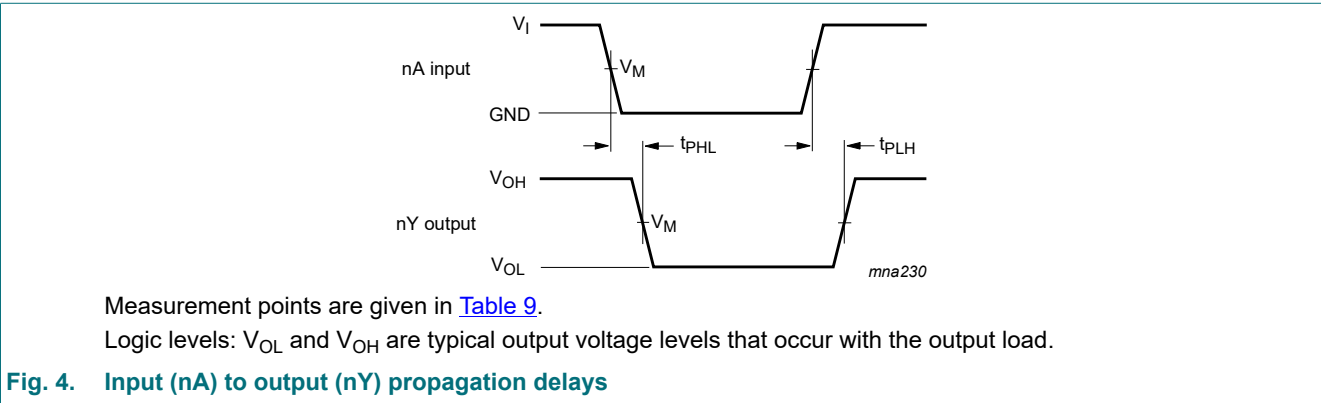

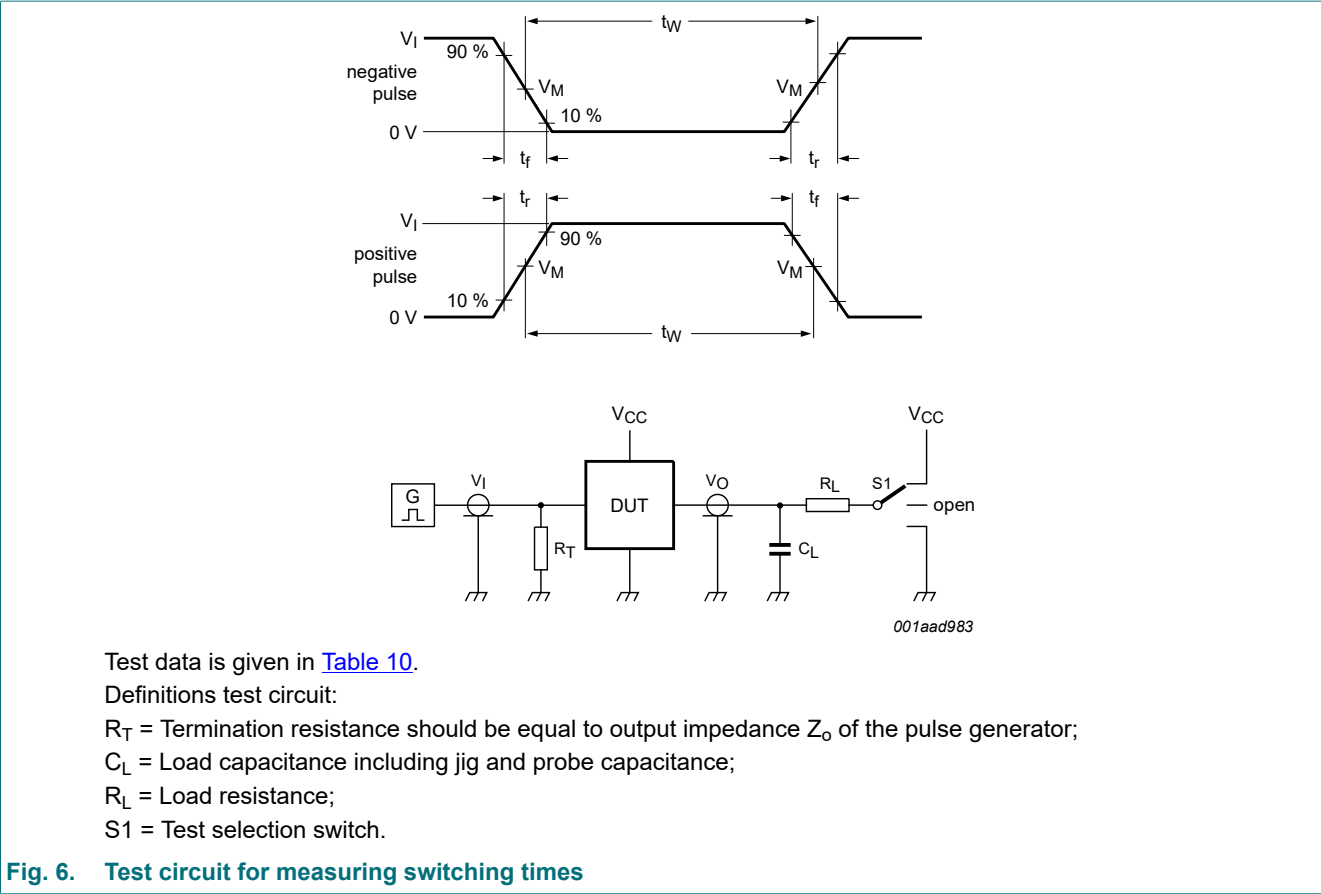

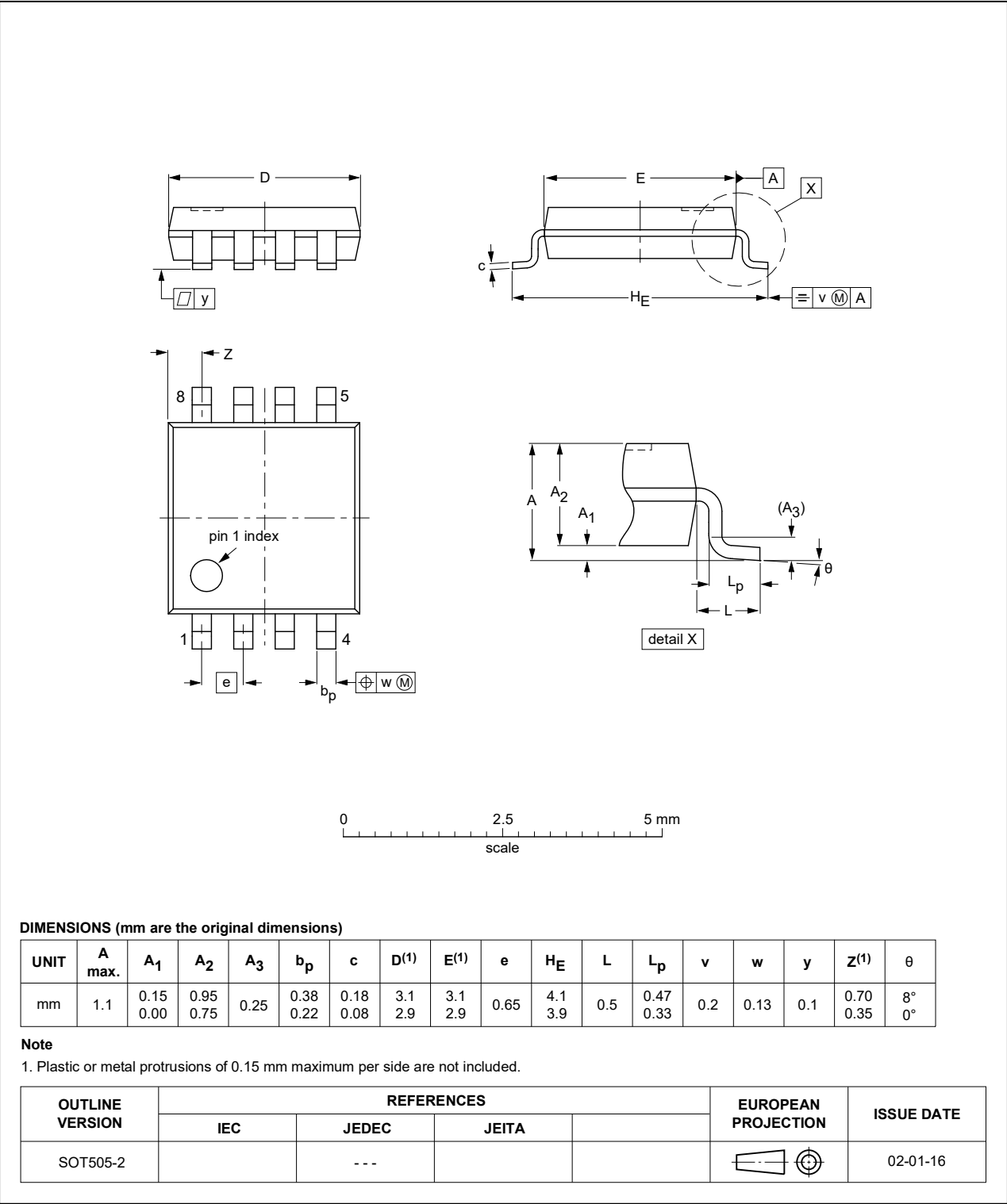


Fig. 7. Package outline SOT505-2 (TSSOP8)

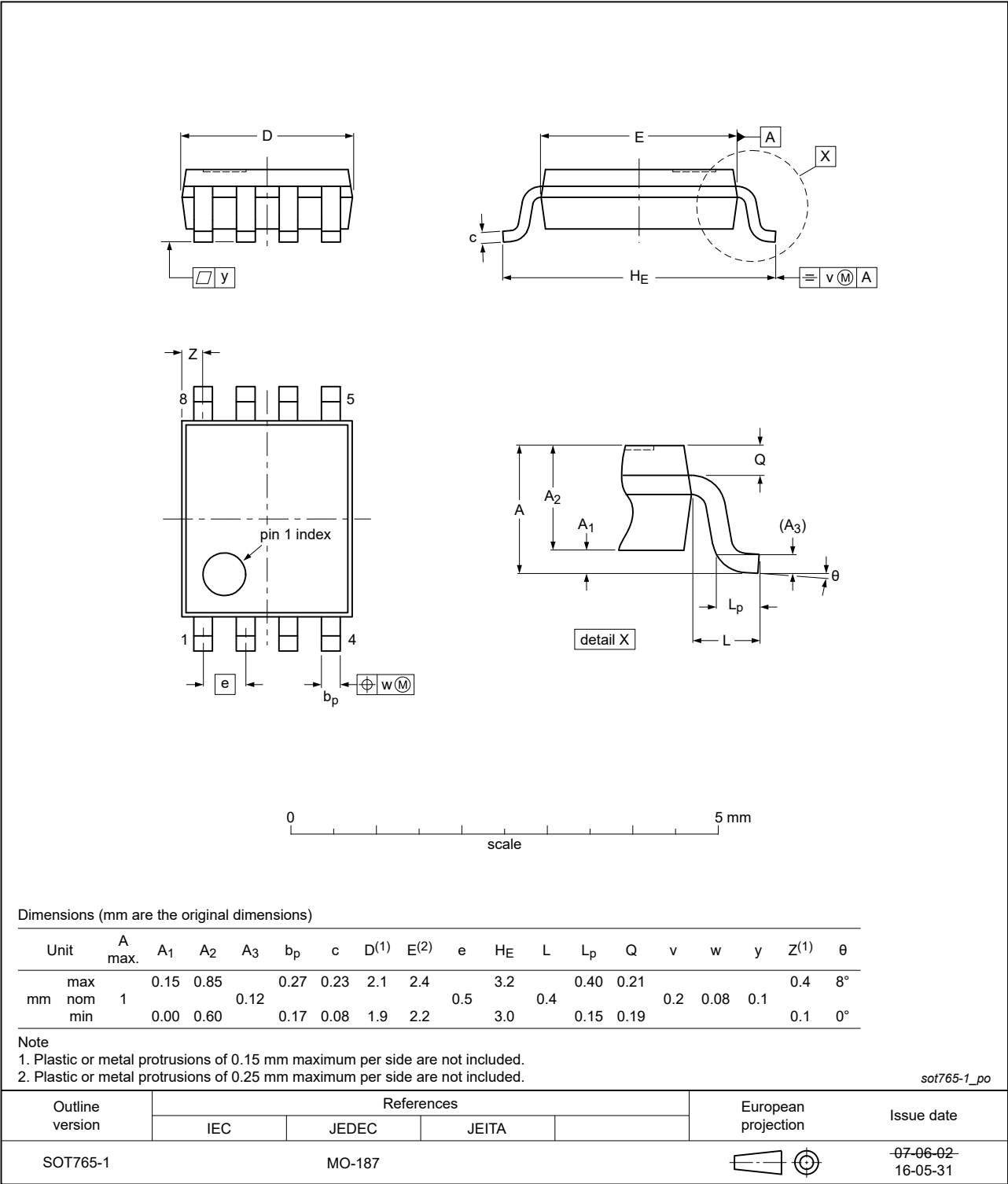


Fig. 8. Package outline SOT765-1 (VSSOP8)
