1. General description

The 74LVC08A is a quad 2-input AND gate. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V applications.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

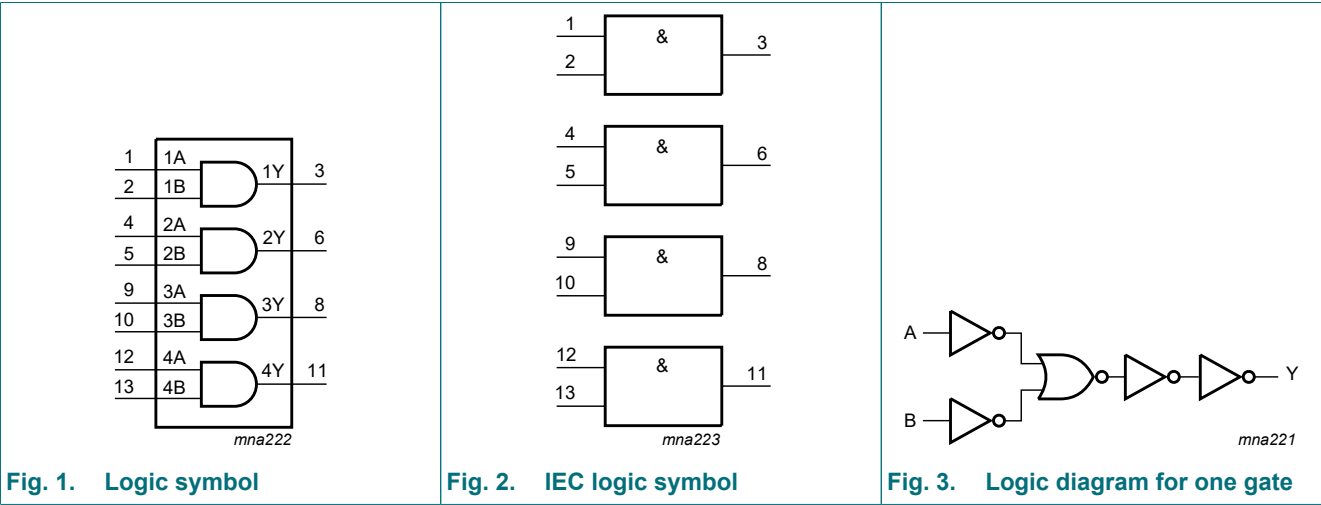

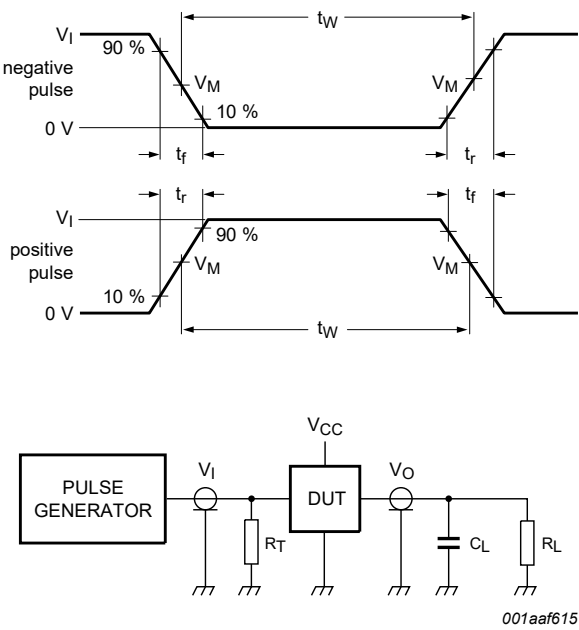

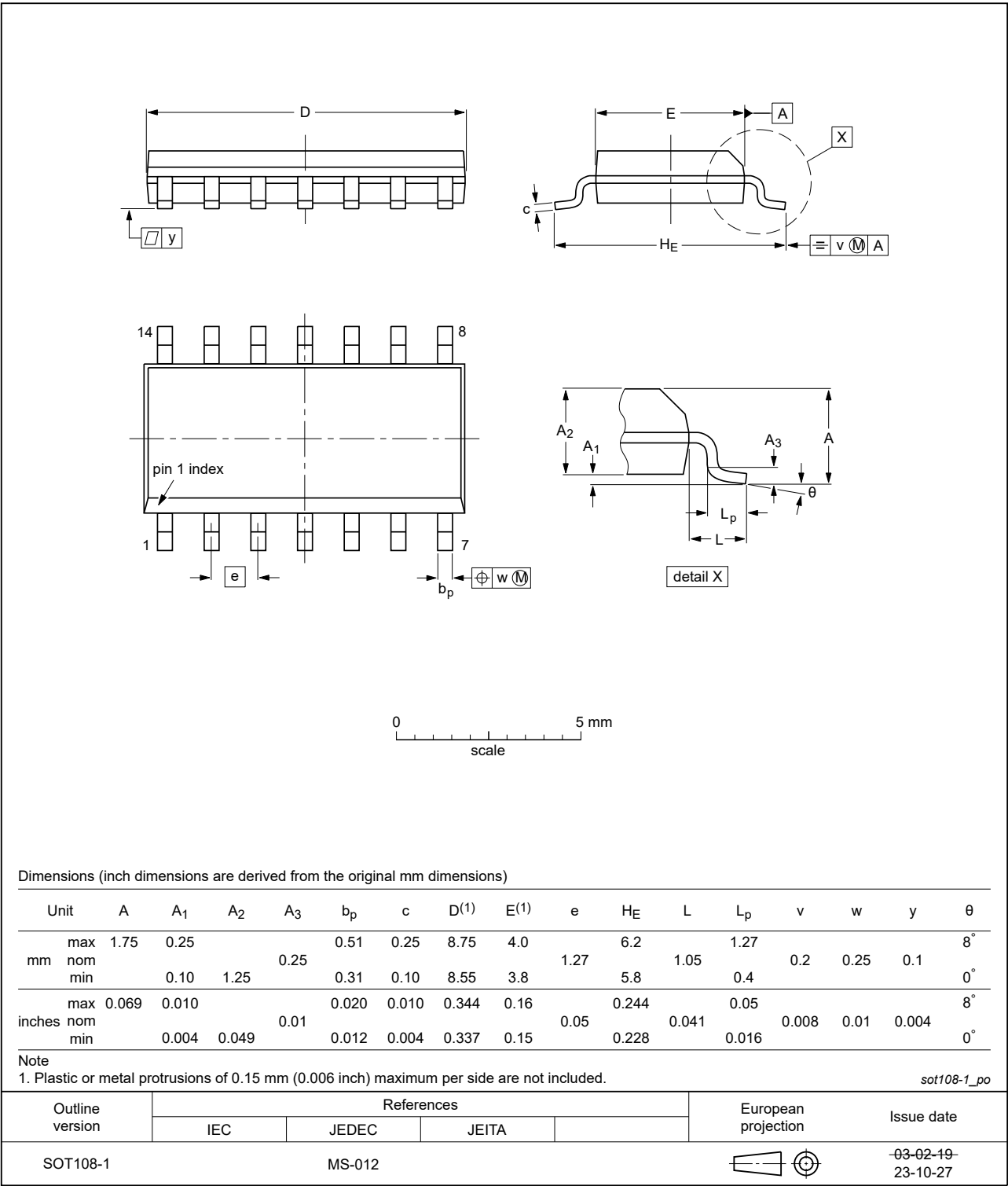


Fig. 6. Package outline SOT108-1 (SO14)

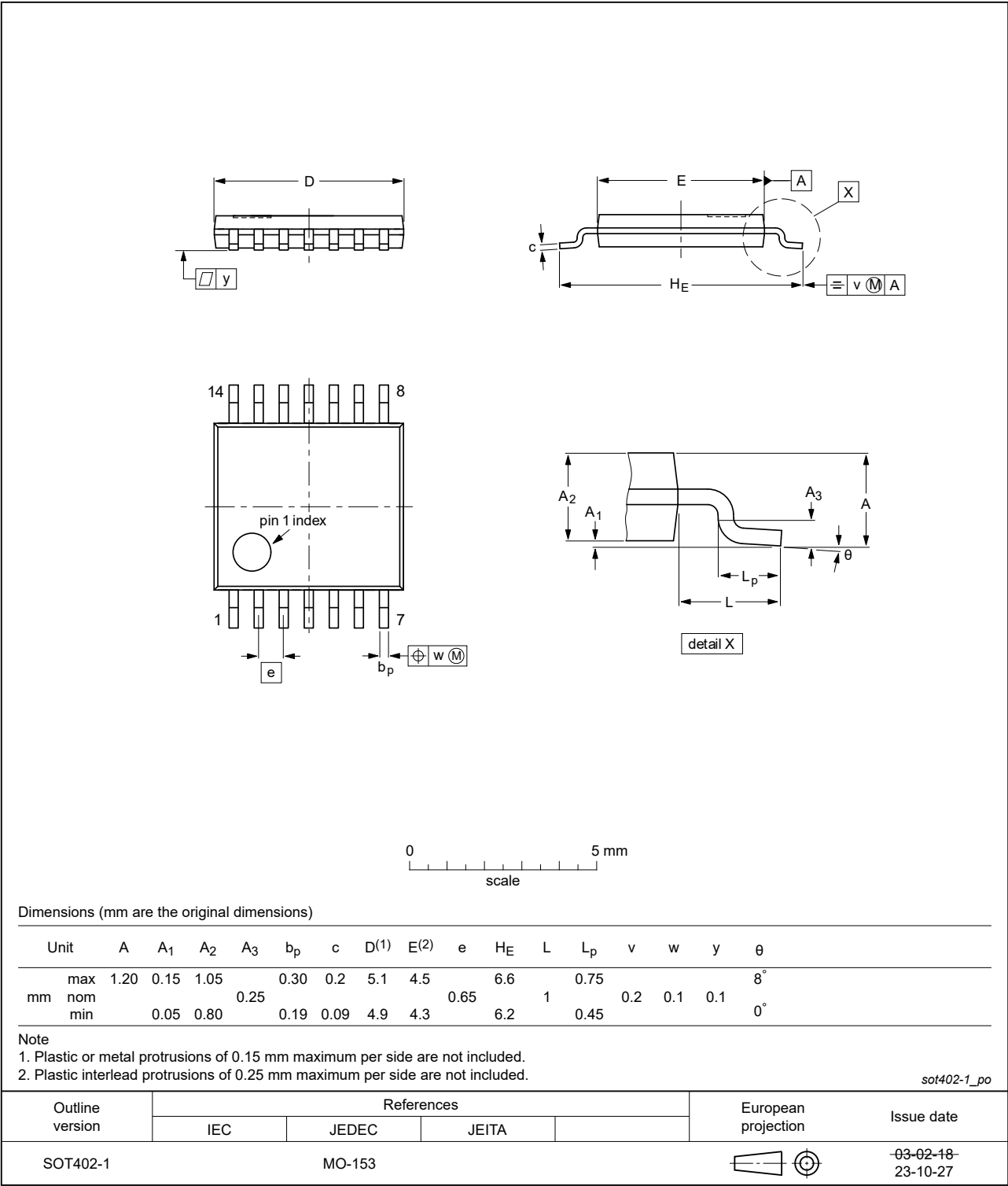


Fig. 7. Package outline SOT402-1 (TSSOP14)

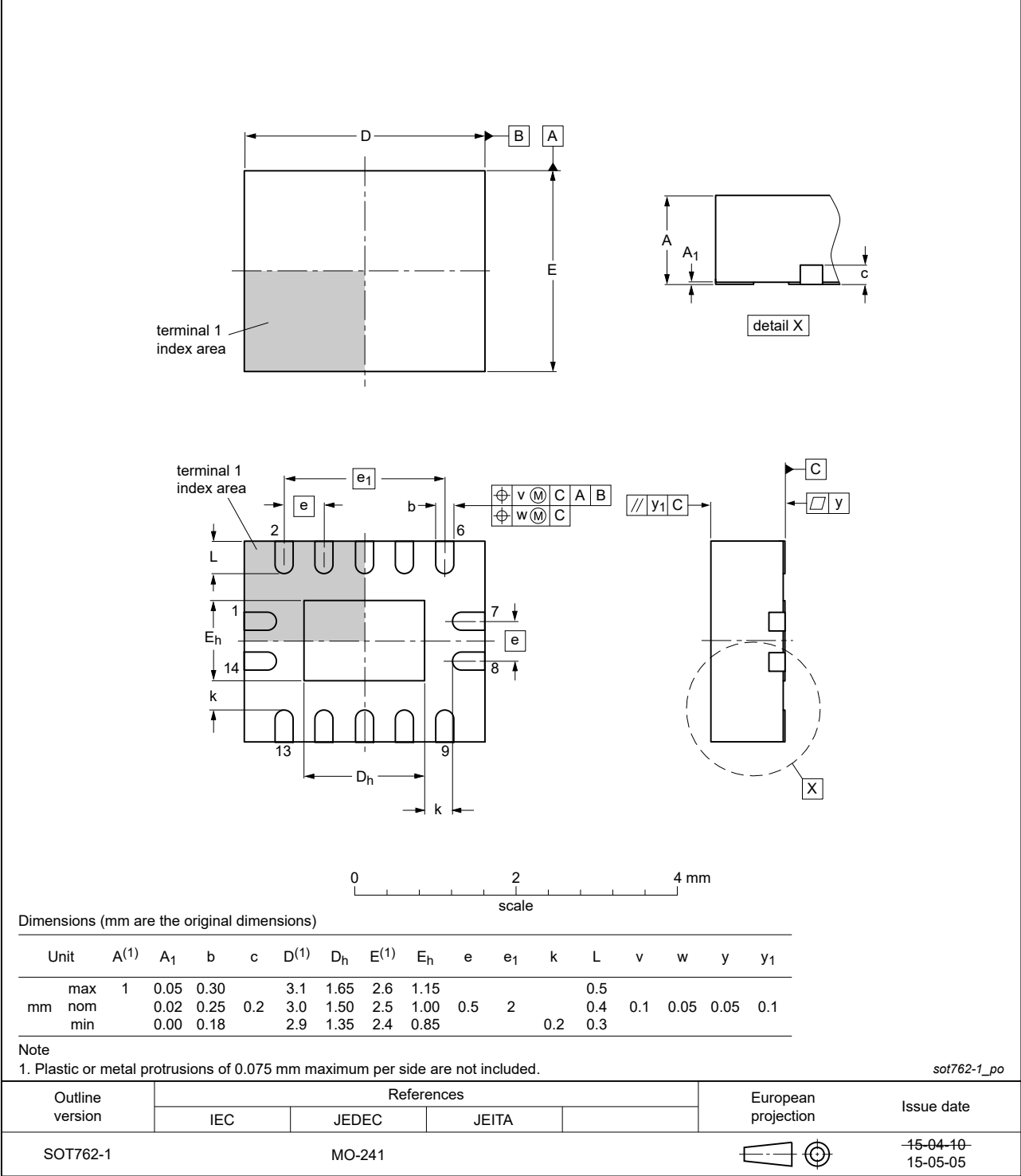


Fig. 8. Package outline SOT762-1 (DHVQFN14)

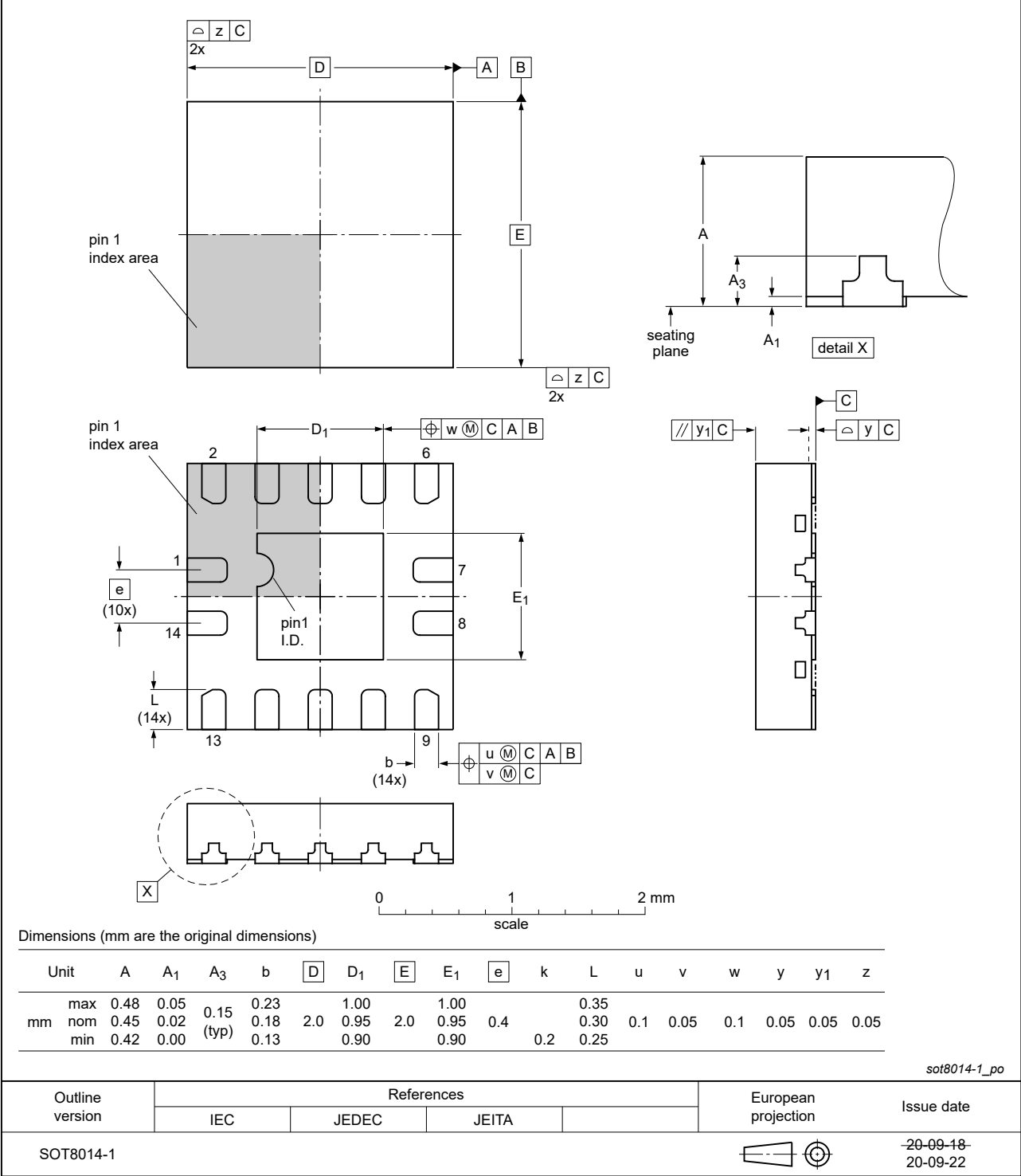


Fig. 9. Package outline SOT8014-1 (DHXQFN14)
