






FIG.5 MAXIMUM FORWARD DC CURRENT VS TEMPERATURE. DERATING BASED ON Tjmax=110 $^{\mbox{\scriptsize $\%$}}$




FIG.2 REVERSE CURRENT VS. REVERSE VOLTAGE.




FIG.4 RELATIVE LUMINOUS INTENSITY VS. WAVELENGTH.




FIG.6 FAR FIELD PATTERN
