The 2SK3355 is N-channel MOS Field Effect Transistor designed for high current switching applications.







## TEST CIRCUIT 2 SWITCHING TIME




## TEST CIRCUIT 3 GATE CHARGE




FORWARD TRANSFER CHARACTERISTICS




DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE




FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT




DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE











DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT



GATE TO SOURCE THRESHOLD VOLTAGE vs. CHANNEL TEMPERATURE







