1. General description

The 74AUP1G3208 is a single 3-input OR-AND gate. Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times. This device ensures very low static and dynamic power consumption across the entire V_{CC} range from 0.8 V to 3.6 V. This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.

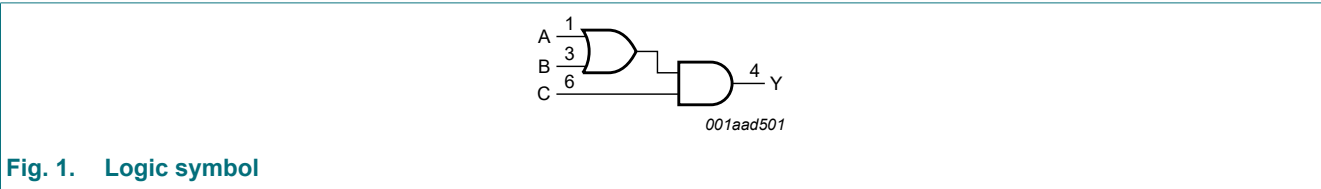

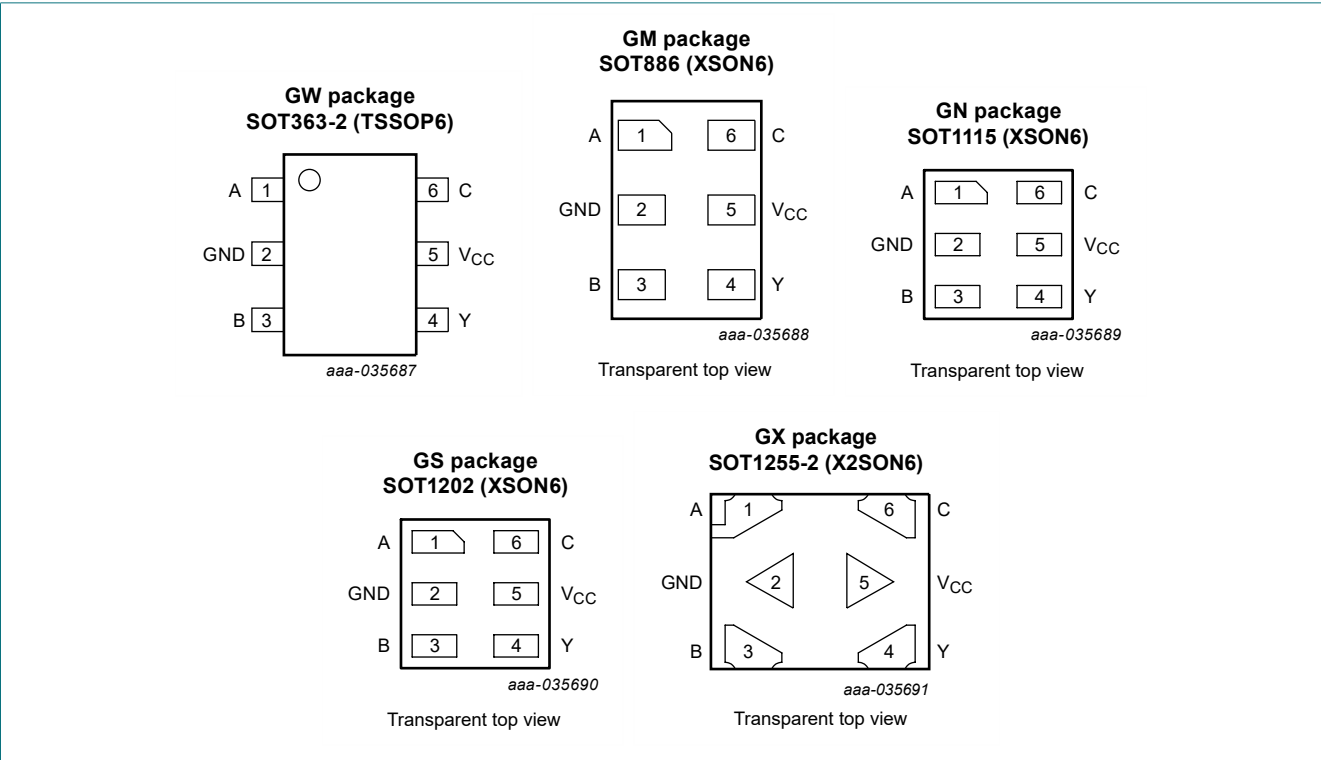

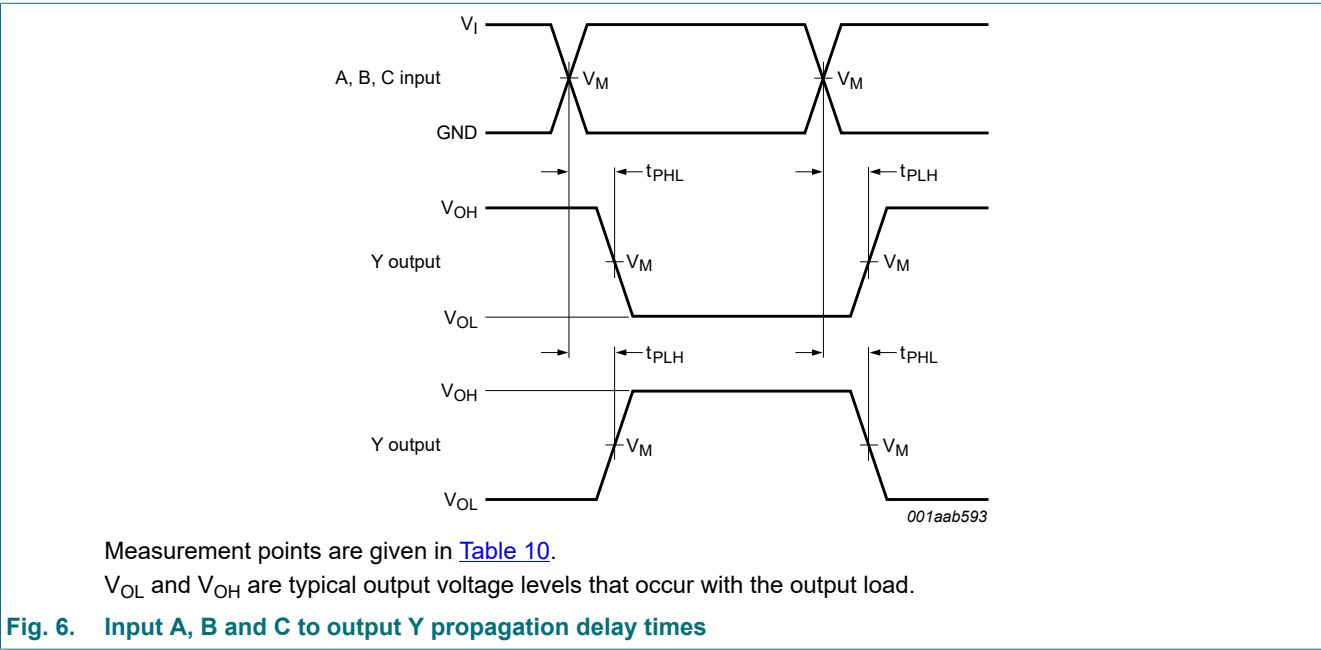

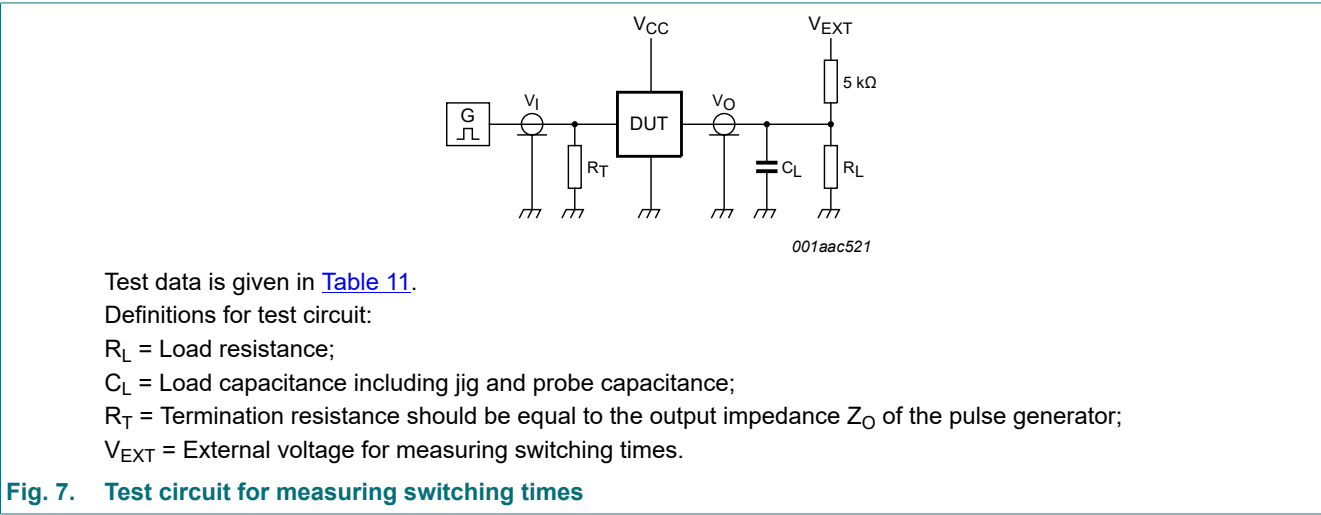

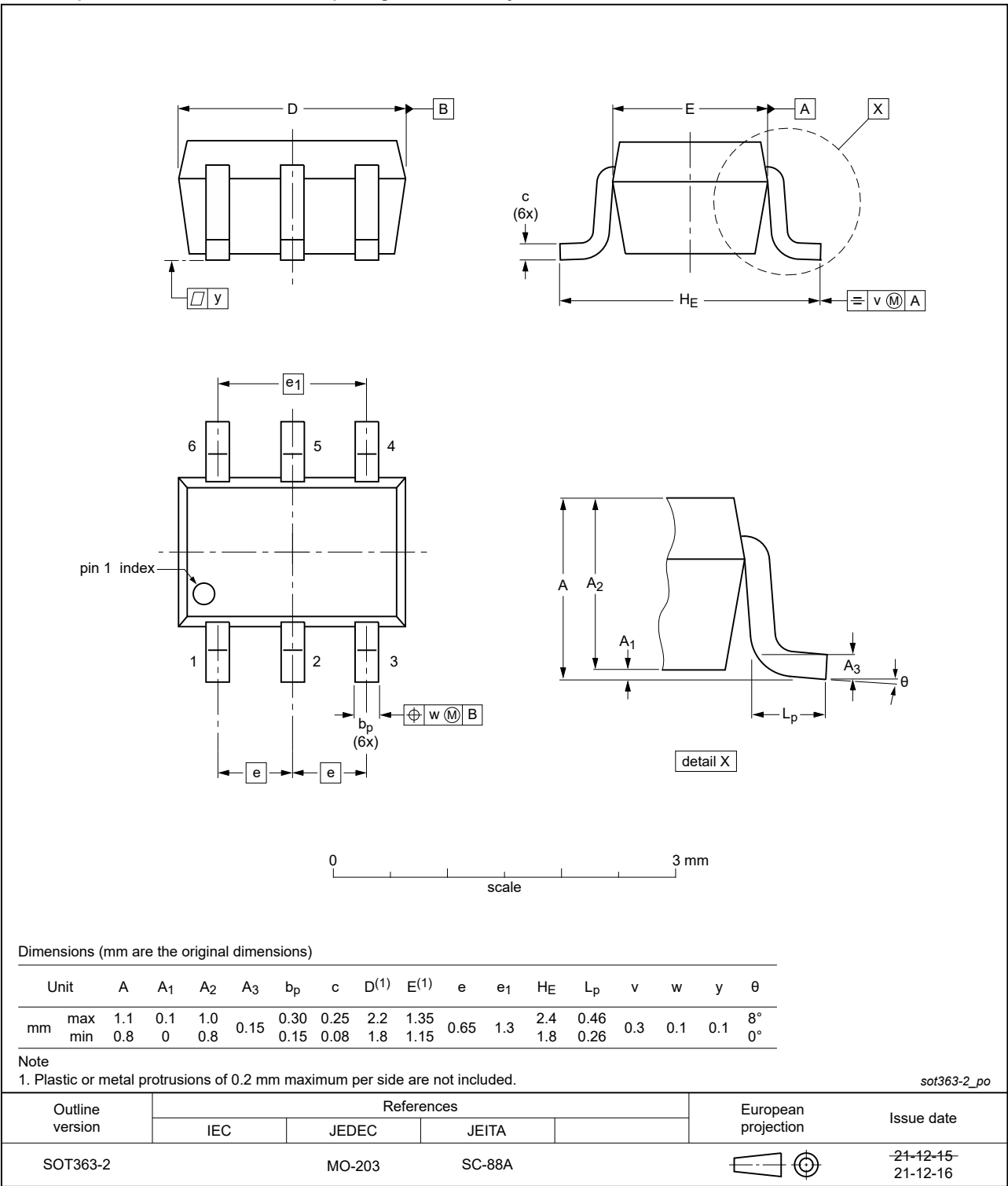


Fig. 8. Package outline SOT363-2 (TSSOP6)

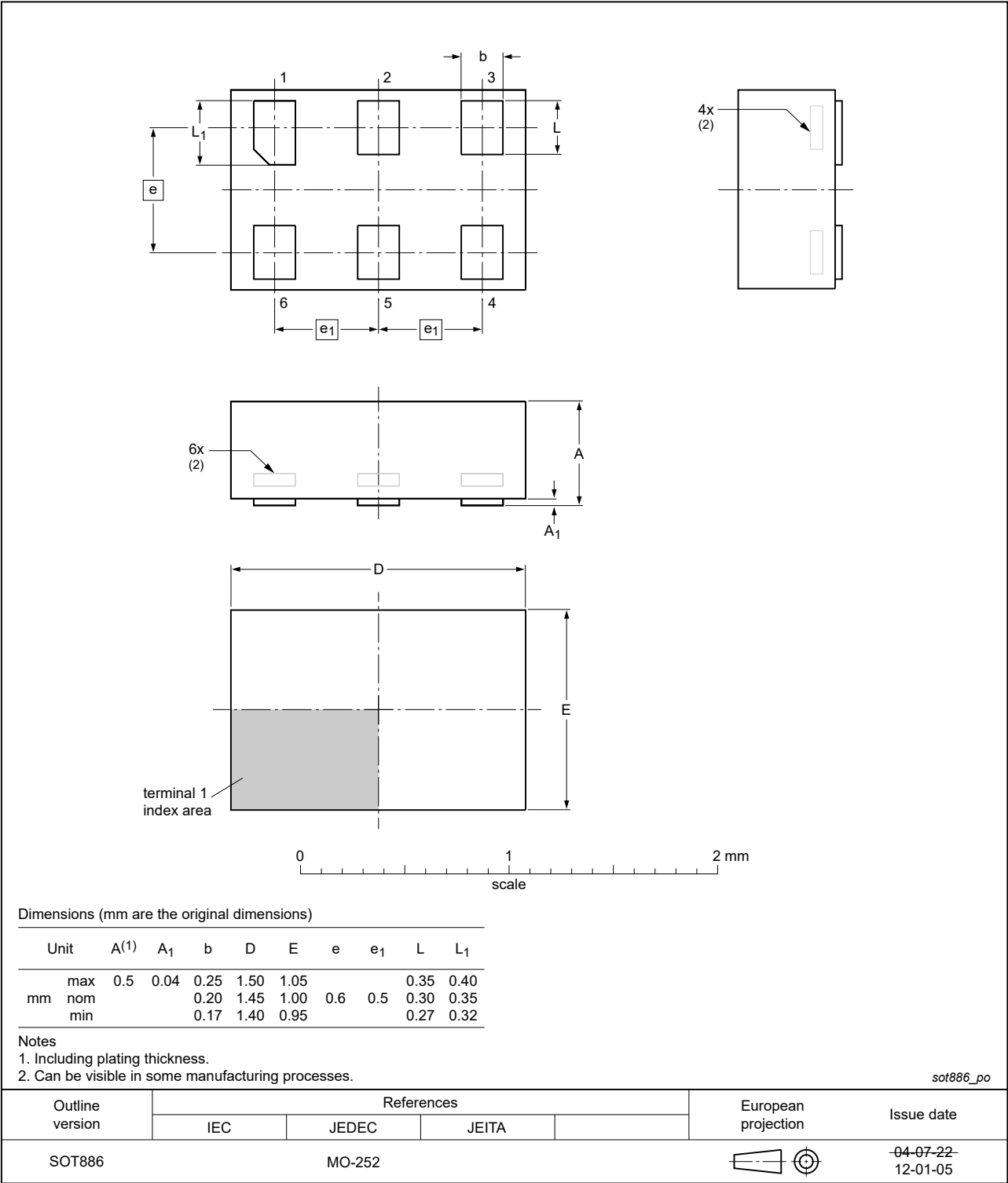


Fig. 9. Package outline SOT886 (XSON6)

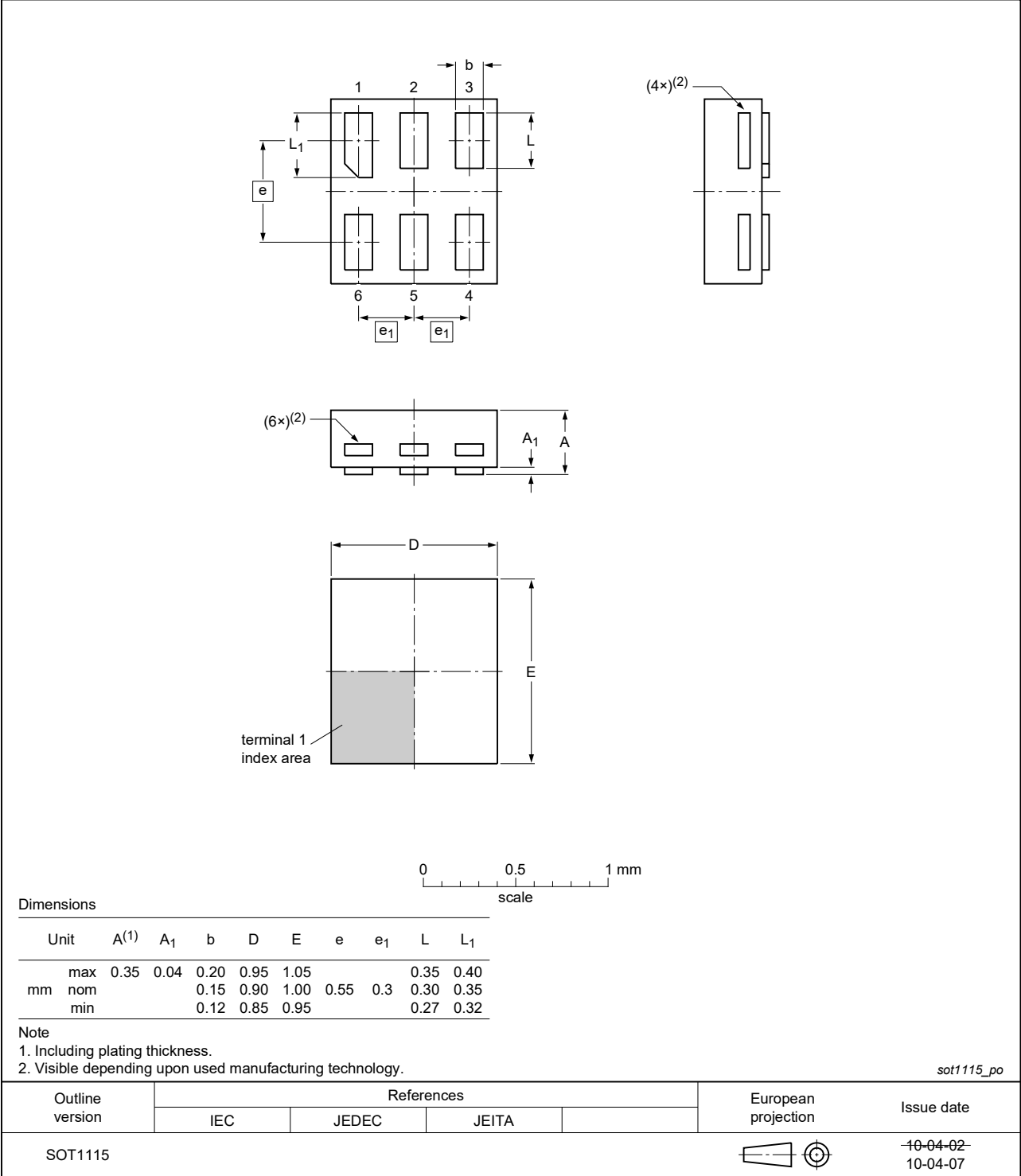
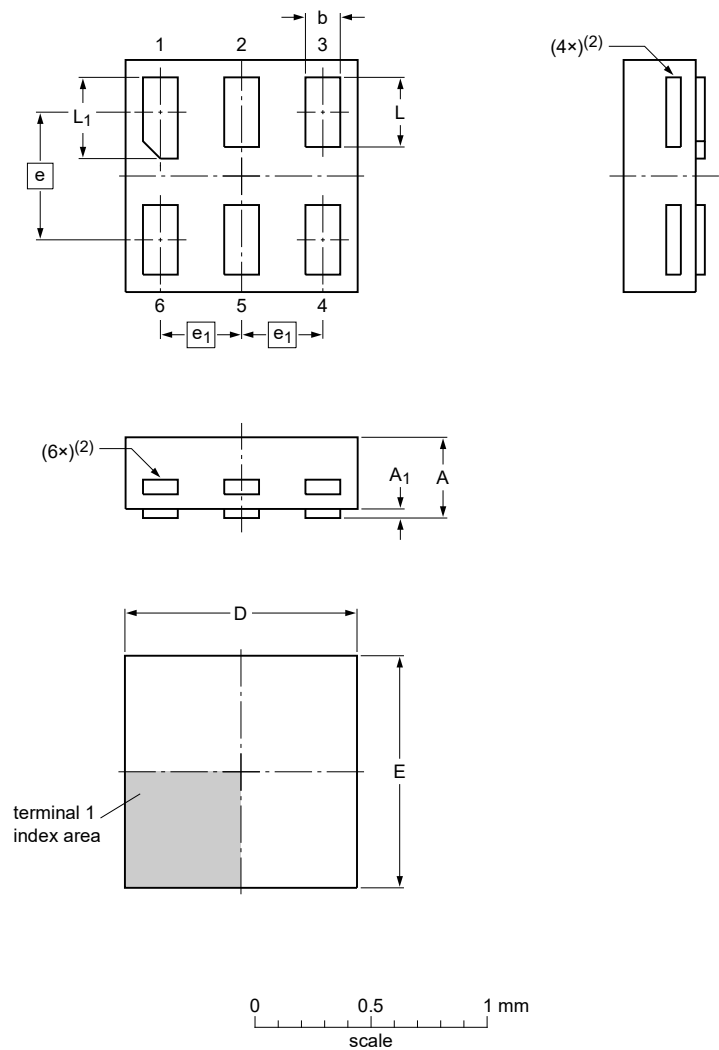


Fig. 10. Package outline SOT1115 (XSON6)

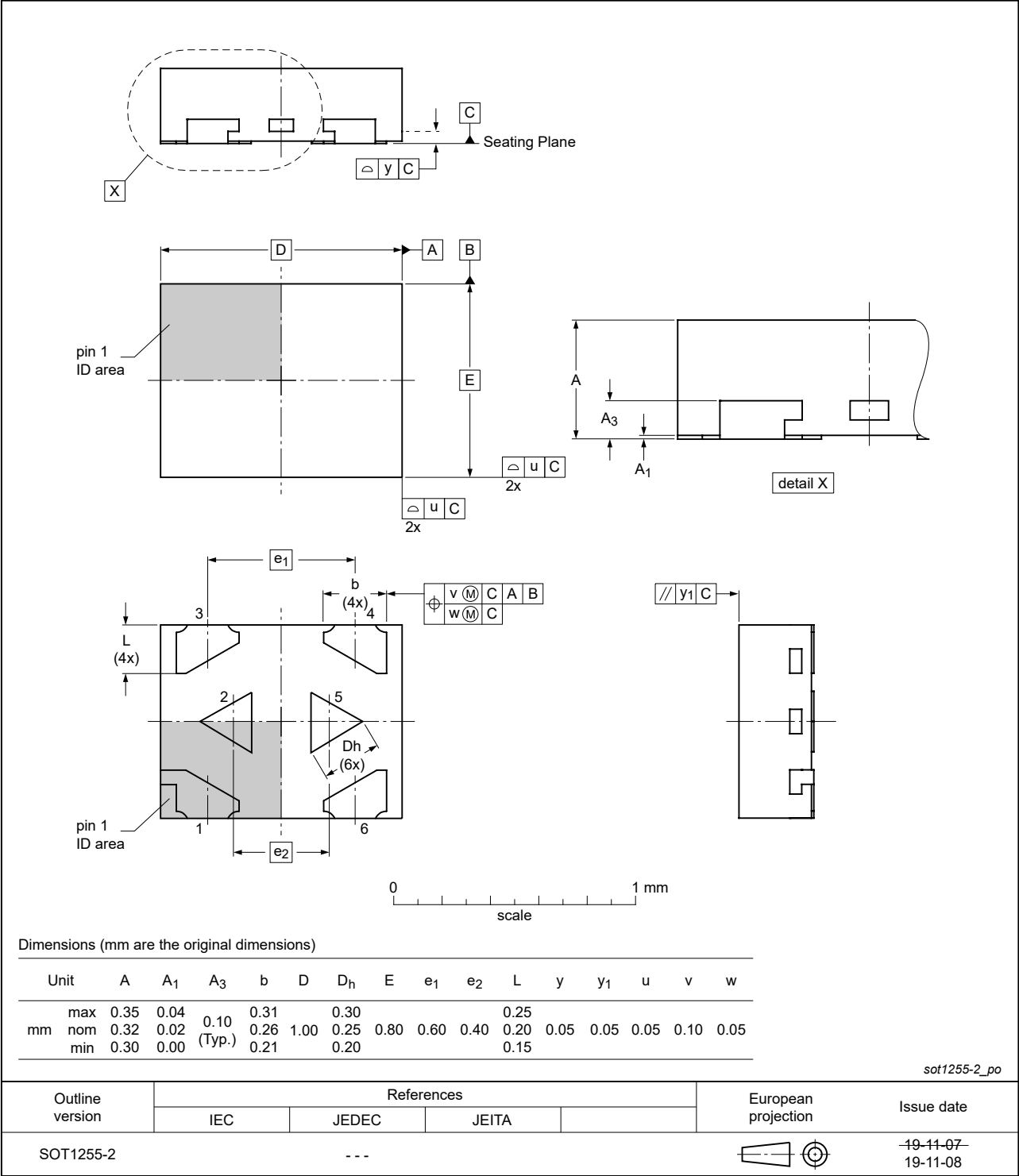


Fig. 12. Package outline SOT1255-2 (X2SON6)
