
#### PRODUCT DESCRIPTION

### TX91501 – 915 MHz Powercaster<sup>TM</sup> Transmitter

#### SET-UP AND OPERATION

- Wall-mount the TX91501 in the desired location with the Powercast logo and status LED facing the direction in which the energy is desired. For permanent installations, mount the TX91501 eight feet or more above floor level.
- 2. Plug the DC connector of the power supply into one of the two available connectors on the TX91501. Plug the power supply into a 120V outlet.
- 3. When the green LED illuminates, the TX91501 is active and transmitting radio frequency (RF) energy. Data is automatically included in the transmission and can be received by one of Powercast's Powerharvester Modules.

The status LED indicates the following operating conditions:


