
# High Intensity LED in ∅ 5 mm Clear Package




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 3. Forward Current vs. Pulse Length




Figure 2. Forward Current vs. Ambient Temperature for AllnGaP




Figure 4. Rel. Luminous Intensity vs. Angular Displacement








Figure 6. Rel. Luminous Intensity vs. Ambient Temperature




Figure 7. Rel. Lumin. Intensity vs. Forw. Current/Duty Cycle




Figure 8. Relative Luminous Intensity vs. Forward Current






Figure 9. Relative Intensity vs. Wavelength
